The Auburn Police Department would like to announce the arrest of Harry White. Harry has been the subject of an ongoing manhunt regarding an active arrest warrant out of the Tompkins County Sheriff's Department, and a suspect in several ongoing cases being handled by the APD Detective Bureau.

On August 03, 2016 Auburn Police Officers were dispatched to an address on Liberty St for a reported domestic. Upon arrival and after further investigation Harry White was located within the vicinity and arrested for charges related to the domestic incident, in which he assaulted the victim with an axe handle, threatened her with a black handgun, (determined to be a pellet pistol), attempted to strangle her with a belt, and then threw a cinder block through her vehicle window. The victim sustained injuries and was treated at ACH. White was held at APD pending arraignment

On August 04, 2016 while still awaiting arraignment, additional charges were filed against Harry White, which involved a separate victim. This case involved the use of the victim's stolen credit card at numerous locations in Cayuga County and Onondaga County on July 24, 25, and 27, 2016.

Harry White was arraigned at Auburn City Court at 1000hrs and remanded to CCJ on 20K cash bail/50K bond. Anyone with additional information regarding either of these cases is advised to contact the Auburn Police at (315) 253-3231. Callers are reminded that they may remain anonymous.
