COUNCIL RESOLUTION #47 OF 2024

AUTHORIZING THE AUBURN FIRE DEPARTMENT TO APPLY FOR A FEDERAL EMERGENCY MANAGEMENT AGENCY (FEMA) FIRE PREVENTION AND SAFETY GRANT (FP&S) FOR MATERIALS, MEDIA ACCESS AND PERSONNEL COSTS ASSOCIATED WITH DELIVERING FIRE PREVENTION AND SAFETY PROGRAMS TO THE COMMUNITY

April 11, 2024

WHEREAS, the City of Auburn Fire Department has the opportunity to apply for funding through the 2023 FEMA Fire Prevention and Safety Grant Program (the "FEMA FP&S"); and

WHEREAS, the FEMA FP&S Grant Program is focused on reducing community risk through fire prevention and safety education; and

WHEREAS, the Fire Department is interested in applying for a 2023 FEMA FP&S Grant in the amount of \$43,016.00, for the purpose of covering the materials, media access and personnel costs associated with delivering high quality fire prevention and safety programs to the community; and

WHEREAS, a FEMA FP&S Grant Award requires a cost-share of 5% from the applicant. The City of Auburn, if awarded, will be required to provide \$2,150.80, which will come out of the Fire Department's Operating Budget, to carry out the FP&S Grant Award; and

WHEREAS, the City of Auburn Fire Department budget does not contain sufficient funds to allow for the enhancement of current fire prevention and safety programs, or initiate additional programs to improve community safety, it is necessary to apply for funding assistance through the FEMA FP&S Grant Program to meet those goals.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF AUBURN, NEW YORK:

- 1. That the Auburn Fire Chief is authorized to execute any and all forms or applications necessary to complete the grant application;
- 2. That the Mayor, or authorized representative, upon notice of the funding award, is authorized to execute a FEMA FP&S contract and any reimbursement forms or other necessary documents to complete the project;
- 3. That the City Comptroller's Office is authorized and directed to create a city expense and revenue capital account to track project finances; and
- 4. This resolution takes effect immediately upon its approval and adoption.
