The City Clerk read a proclamation from the Office of Mayor Michael D. Quill. **WHEREAS** Solomon Northup was born a free person in the year 1807 in Schroon, New York, now Minerva, New York, and lived for many years in Saratoga Springs, New York; and

WHEREAS in 1841 Solomon Northup was recruited by two men to work as a musician in the circus and made a trip to Washington, D.C. to begin his work as a fiddler; and

WHEREAS upon his arrival in Washington, Solomon Northup was sold to slave trader James H. Birch by the name of Platt Hamilton, conveyed to Richmond, Virginia and then delivered by ship to New Orleans, Louisiana, where he was sold by trader Theophilus Freeman to William P. Ford; and

WHEREAS Solomon Northup would spend the next 12 years in slavery in the Bayou Boeuf plantation region of Central Louisiana's Red River valley; and

WHEREAS in 1840 then Governor of New York William H. Seward signed legislation that provided aid to help free New York citizens who had been kidnapped and sold into slavery; and

WHEREAS in 1852 then Governor of New York Washington Hunt utilizing Governor Seward's 1840 statute made Henry B. Northup an agent of the State of New York sending Henry to Louisiana with documentation supporting Solomon Northup's status as a free New Yorker; and

WHEREAS upon arrival in Louisiana on January 1, 1853 Henry Northup hired John P. Waddill Esquire in search of Solomon Northup; and

WHEREAS following months of search and legal battle, Solomon Northup's freedom was once again legally obtained in Marksville, Louisiana on January 4, 1853; and

WHEREAS Solomon Northup returned to the State of New York on January 22, 1853 where he was reunited with his family and together with local writer and lawyer David Wilson, he penned his memoir "Twelve Years a Slave"; and

WHEREAS "Twelve Years a Slave" was first published in 1853 by the Auburn, New York publishing company of Derby & Miller located at then 107 Genesee Street on July 15, 1853, and the book becoming a best-seller with more than 30,000 copies published in its first few years.

NOW THEREFORE, I, Michael D. Quill, Mayor of the City of Auburn, New York, on behalf of the City Council and Citizens of Auburn, on the 165th anniversary of the day that Solomon Northup re-obtained his freedom do hereby proclaim January 4, 2018 as,

Solomon Northup Freedom Day

in the City of Auburn, and encourage all Citizens to observe this day and year of the 165th anniversary by recognizing this unique story and its significant contribution to our status as History's Hometown.

In witness whereof I have hereunto set my hand and caused the seal of the City of Auburn to be affixed this Fourth day of January 2018.

AGREEMENT RESOLUTION #1 OF 2018

AUTHORIZING SUPPLEMENTAL AGREEMENT NUMBER THREE FOR THE GENESEE STREET PAVEMENT PRESERVATION PROJECT- PIN 375601

WHEREAS, a Project to design and repave Genesee Street in the City of Auburn, P.I.N. 375601 (the "Project") is eligible for funding under Title 23 US Code, as amended, and the Locally Administered Federal Aid Program (LAFAP) that calls for the apportionment of the costs of such program to be borne at the ratio of 80% Federal Funds and 20% non-federal funds; and,

WHEREAS, Resolution No. 128 of 2014 approved the Project and authorized execution of a master agreement with the New York State Department of Transportation regarding administration and funding of Design (Phases I-VI) for a total cost of \$225,000; and,

WHEREAS, Resolution No. 23 of 2017 authorized execution of a supplemental agreement with the New York State Department of Transportation regarding administration and funding of the construction phases (Phases VI and VII) for a total cost of \$3,666,000; and,

WHEREAS, the City of Auburn desires to advance the above Project by making a commitment of 100% of the first instance payments of the total project costs in the amount of \$310,000 for Design, and \$4,359,033 for the Construction and/or Construction Supervision and Inspection phases for the Project; and,

WHEREAS, the local share of the project is \$339,257 and City has already funded a portion of the local share in the amount of \$132,327.07.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Auburn does hereby approve the advancement of the Project and authorizes the City of Auburn to pay in the first instance 100% of the costs of Design, Construction and/ or Construction Supervision and Inspection work for the Project or portions thereof in the amount of \$4,669,033; and

BE IT FURTHER RESOLVED that the Mayor of the City of Auburn be and is hereby authorized to execute all necessary agreements, including supplemental agreements, certifications, and reimbursement requests for Federal Aid/ and/ or New York State Marchiselli Aid with the New York State Department of Transportation in connection with the advancement or approval of the Project and providing for the administration of the Project and the municipality's first-instance funding of Project costs and permanent funding of the local share of Federal-aid and State-aid-eligible Project costs and all Project costs within appropriations therefore that are not so eligible; and

BE IT FURTHER RESOLVED that the sum of \$206,929.93 is hereby made available for transfer from the General Fund Transfer to Capital if provided for in the City Budget or through the City's Annual Road Improvement Program to the Capital – Genesee Street Pavement account (HA99.2892.HN) to cover the local share cost of participation in the Design, Construction and/ or Construction Supervision and Inspection phase of the Project; and

BE IT FURTHER RESOLVED that the Construction and/ or Construction Supervision and Inspection phase work be charged to the W. Genesee Street Pavement capital account (#HA5110.440.HN); and

BE IT FURTHER RESOLVED that in the event the full Federal- and non-Federal share costs of the project exceed the amount appropriated above, the City of Auburn City Council shall convene as soon as possible to appropriate said excess amount immediately upon notification by the New York State Department of Transportation; and

BE IT FURTHER RESOLVED that a certified copy of this resolution be filed with the New York State Commissioner of Transportation by attaching it to any necessary agreement in connection with the Project; and

BE IT FURTHER RESOLVED that this Resolution shall take effect immediately.

WHEREAS, in order to move the project forward it is necessary to award the construction portion of the project at this time,

NOW, THEREFORE, BE IT RESOLVED that the Auburn City Council does hereby approve an award to F. Rizzo Construction Inc. for the construction portion of the Genesee Street Pavement Preservation Project for their low bid in the amount of \$4,148,679.00, said agreement is contingent upon the approval of the New York State Department of Transportation;

BE IT FURTHER RESOLVED, that:

- The Mayor is authorized to sign any and all documents necessary for the abovereferenced award on behalf of the City of Auburn; and
- The cost of the general construction in the amount of \$3,905,033.00 is to be charged to the Genesee Street Pavement Preservation Project capital account (#HA5110-440-HN); and
- The cost of the water betterments in the amount of \$194,081.50 is to be charged to the Genesee Street Water Betterments Project capital account (#HF8340-440-HN); and
- The cost of the sewer betterments in the amount of \$49,564.50 is to be charged to the Genesee Street Sewer Betterments Project capital account (#HG8120-440-HN); and
- The Genesee Street Water Betterments Project capital account (#HF8340-440-HN) and the Genesee Street Sewer Betterments Project capital account

(#HG8120-440-HN) shall be funded through a use of fund balance in the water and sewer funds, respectively.

WHEREAS, the City of Auburn does not currently have the funding to pay for 100% of the email management system costs and, therefore, it is necessary to obtain New York State Archives funding for the project.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF AUBURN, NEW YORK:

- 1. That the Mayor, or other duly appointed representative, is authorized to apply for a Local Government Records Management Improvement Fund Grant Application to the New York State Archives in an amount not to exceed \$75,000;
- 2. That the Mayor, or other duly appointed representative, is authorized to execute agreements specific to grant implementation and submit financial and reporting documentation related to the project and New York State assistance, if the grant is awarded; and
- 3. That the City Comptroller is authorized to recognize the grant revenue and to appropriate the funds into the correct departmental budget or capital account, if the grant is awarded; and
- 4. That upon adoption, this resolution shall take effect immediately.
