• Approval of the June 4, 2020 City Council meeting minutes. Councilor McCormick (aye), Councilor Giannettino (aye), Councilor Cuddy (Yes), Councilor Locastro. (Yes), Mayor Quill (aye). Carried.

Mayor Quill

Thank you. June 11. will be next week's Agenda Council. Mr Dygert, city manager's report please.

City Manager Dygert

Thank you Mayor a few updates. The City of Auburn is currently accepting bids for the biosolids processing and drying design, construction administration and construction Inspection Services. Bids are due back on June 26. More details can be found on the city webpage under the tab "Bids and RFPs". Last week, right after our city council meeting, we received notice that an executed grant agreement from the New York State Department of State for the Downtown revitalization Revitalization Initiative funding for the proposed public Safety building in the amount of \$1.2 million. So, combined with the \$1 million grant agreement from New York State DEC, we have \$3.2 million committed from New York State towards that project. Along those same lines, we've been in communication this week with New York State related to the New York State Shared Services program. We have two projects submitted for that program, being the Public Safety Building and the Falcon Park renovation project. Those are both moving forward through the process and are in the final stages of hopefully approval to offset the cost of those projects. So hopefully we'll hear soon on those. A lot of discussion around about the opening of recreational facilities. We expect our city owned playgrounds to officially open on June 26. Our DPW is currently completing the required reopening plan signage, and cleaning disinfecting practices that are required by New York State to allow us to properly open under the current situation. The DPW has also been working with the County Health Department and the YMCA. To wrap up a compliant reopening plan for Casey Park pool. The pool will likely open approximately a week later than it typically does. And that's to allow the YMCA a chance to ramp up and get ready for that. There will be restrictions we'll advertise and communicate those when we know exactly what those restrictions will be, again to remain compliant with the state regulations. We've continued to work diligently for dispersing the CDBG COVID funding that was allocated to the City of Auburn through HUD. Just as a little bit of a recap for that, the Economic Recovery Support Program, we had a total of \$304,000 available that was

going to be divided up in the following manner; \$224,000 to for profit businesses, and \$80,000 for not for profit arts and cultural organizations. We received a total of 72 applications. 52 were for for profit businesses. We had some other for other businesses that were in the process of just getting started that were set back a little bit from the COVID situation. We had a couple of candidates that were looking to start new businesses and eight not for profit organizations. Because of the overwhelming demand for the program, staff is working to allocate an additional \$100,000 to supplement the program out of the 2020 CDBG Small Business Assistance Program. So in saying that, I'm just trying to make sure we've got Council's blessing for us to go ahead and do that we can do it without a whole lot of extra work in the Planning Department putting all the pieces together as far as what we need to do for the notification to HUD and public hearings and things like that. But if councils okay with that, well, we'll continue that moving along with that process.

Mayor Quill

See a couple heads nodding.

Councilor Giannettino

I'm fine with that.

Councilor McCormick

That's great.

City Manager Dygert

Thank you.

Mayor Quill

Councillor Councilor Cuddy is good with so

Councilor Cuddy

I'm fine with that as well. Okay.

Mayor Quill

No, I didn't know Councilor Giannettino had a question for you.

Councilor Giannettino

I'm good. Okay.

City Manager Dygert

So again, we received a pretty overwhelming response, a number of requests. To that we are doing our best to make sure we fund everybody we possibly can through that and if not for that extra \$100,000, the awards would tend to be relatively small. So we want to, we want to do the best we can for our all our

local businesses, and we don't want to leave anybody out there without some sort of an award. So we're going to continue to work through that. We're hoping that throughout next week, we'll get that stuff finalized. And we're aiming to actually disperse funds, if we can get things moving with HUD and an our process here, the first part of July. And the last thing I've got, I just happen to remember as we're going through that stuff is that you may or may not have noticed, when you drive down South Street work has resumed on the Schine Theater. So that was kind of interesting to see today. So moving along, that's all I got.

Mayor Quill

Which, just for the record, it is in private hands. It's not a city project. Correct. Correct. Don't want someone to get the wrong message that we started back up. So thank you. Questions for Mr..... Councilor, please.

Councilor Locastro

Any new updates on the DoubleDays?

City Manager Dygert

No. Opening day for us at Falcon Park was supposed to be Father's Day, this coming Sunday. We are still in a holding pattern with both Minor League Baseball and their relationship with Major League Baseball. And neither Minor League Baseball, Northern New York Penn League have made any concrete decisions related to this current season. There's, you know, some hope and speculation that maybe they can get started but it would be a later season. That proved really problematic for us. And I think all the New York Penn League teams because as it stands right now, there has not been a lot of commission meant of supporting funds in the way of advertising and other things from the private sector at this point. Businesses are hurting. And you know, with the big question mark over the season, there hasn't been a lot of activity as far as bringing in those revenues. And that's a lot of what keeps that season going. So we'll see what happens. But nothing, nothing solid from the league or Minor League Baseball yet. Thank you.

Mayor Quill

Anyone else? Thank you. Reports from members of council, councilors. Oh, jump in there. We had a visitor yesterday. Lieutenant Governor, Kathy Hochul made another trip to Auburn. She's always a pleasure to speak with and she's always so upbeat. And the reason for her visit I takeaway is that she's encouraging people, it's going to take time to open up but we will be be up and running and be better than ever and it was nice to see her and have a short chat with her. So, Councilor McCormick was thereand Councilor Giannettino and Councilor Locastro. I don't believe we'd seen you there, nor Councilor Cuddy, so anyone else? Very well. WHEREAS, a transfer station was built to process and ready city garbage for disposal at another facility and, as a result, the City of Auburn must contract with another facility for disposal services; and

WHEREAS, City staff prepared bid documents and issued a formal bid for the Project; and

WHEREAS, bids were advertised for the Project and on May 14, 2020, the following bids were opened and received;

WHEREAS, it is necessary that the Auburn City Council award the initial three year bid for Landfill Disposal Services to the lowest qualified bidder, Seneca Meadows, in the amount of Year 1-\$362,500, Year 2-\$400,000 and Year 3-\$437,500.

NOW, THEREFORE, BE IT RESOLVED that the Auburn City Council does hereby award the contract for the initial three year Landfill Disposal Services to **Seneca Meadows** for their low base bid of **Year 1- \$362,500, Year 2- \$400,000 and Year 3- \$437,500,** and the cost of the Resolution is to be charged to the account entitled Transfer Station Services (#EM 8171.440); and

BE IT FURTHER RESOLVED that the Mayor is authorized to sign any and all documents in reference to the award of this bid.

Mayor Quill

Counselor, please.

Councilor Giannettino

I have a couple questions. Mr. Talbot, if he could entertain them for me. The first question is, I see that the per ton amount goes up every year. Can we just get an explanation of the reason for that? I'm sorry, the cost per ton per year goes up or a year. What is the justification for that?

Mike Talbot

Well, they cut their cost of doing business, just like ours, you know, and, you know, the analysis we did with the controller's office, we took into all those factors, even weight times and all that. And it's still considerably less to contract with Seneca Meadows simply because they're close proximity.

Councilor Giannettino

The reason I ask that question is, I know that often times people are critical of the fact that we charge for refuse collection. This shows that it's an expensive business, and that really for the \$10 a month that has been charged for the last several years that it really is a bargain for the service that people are getting.

The second question I have is, it's forecasted for five years. But we're only contracting for three. Why is that?

Mike Talbot

The initial bid, what the Comptroller's office, what we did, is we thought we would get our best value by offering an initial three year bid with two one year options on top of that, okay. And I think really, it came to fruition because you see, it's actually, they're charging less than what we charge ourselves. So, you know, and I think everyone has to remember also as part of our refuse collection service, what the people are also paying for that's not reflected in these numbers, is the Monday yard waste collection that everybody enjoys. I mean, this past Monday, we pulled, I believe, 35 tons of containerized and bagged yard waste. So, that's not reflected in here, but that is part of the service people are paying for.

Councilor Giannettino

And entering into this contract, will that allow us to still collect refuse at the current rate that we're charging homeowners?

Mike Talbot

Yes, you know, and in all honesty we will probably have to look at those numbers pretty closely over the next year. Because as you see here, I mean, our cost of doing business goes up also. So, it's still considerably less than private companies and the value of the service we provide is worth a lot more than what we charge. Not that we were out to make money, but it's what the service we provide our residents is really, there's no comparison between what private sector offers and what we do.

Councilor Giannettino

Yeah, and I mean, the thing is, this is going up \$3 a year per ton. But we hadn't raised the refuse collection fee in five years.

Mike Talbot

No, you know, what, that's also a tribute to the people who work in our collection department, you know, they're always cost conscious and, you know, resourceful. So, you know, it all goes hand in hand. But, you know, at some point I think we're all living in reality, at some point we will have to increase that cost. And I know people, including myself, you always hate the pay more for something you're getting right now, but it's just everything goes up, you know, loaf of bread goes up.

Councilor Giannettino

Thank you.

Mayor Quill

Councilor Locastro.

Councilor Locastro

How did you determine the tonnage?

Mike Talbot

Well, you mean the amount? Yeah, because that's what we're permitted for at the transfer station. 12,500 tons. So, to compare apples to apples, that's the tonnage we used.

Councilor Locastro

Can that 360 to 500 go up or down. If we happen to have more trash? Say you want to take more than 12,500 what happens that number will that will that go up?

Mike Talbot

No actually in what we did is for the bid, put 15,000 tons, I'm sorry, I kind of misspoke. We're allowed 12,500 tons for our transfer station, but as an option for us to possibly raise some additional revenue, that option is always there for us to collect our garbage in the garbage trucks, weigh it at the landfill and immediately turn around and drive it over to Seneca Meadows. So that would not go against our 12,500 tons. So that also can accommodate for some, if we're raising any structures here in town, because, you know, the Codes Department or Planning does have funds for sometimes to take vacant buildings down. That would also account for that tonnage.

Councilor Locastro

Is there a penalty if we don't reach that amount of 12,500?

Mike Talbot

No, we worked with the corporation Counsel's Office, we sent them a contract and they said it looks fine. We put in there that there's no minimum tonnage. Thank you,

Mayor Quill

Mike. I don't know if Councilor Cuddy has anything. All set Councilor?

Councilor Cuddy

Councilor Locastro asked the questions I was going to ask.

Mayor Quill

Thank you. Thank you. Mike, I think I had this right. He said there was 37 tons of yard waste picked up this past week. Did I get that? Will that be transferred to this to Seneca Meadows? Or do we have a separate area for that?

Mike Talbot

No, we have a separate registered compost facility. Okay, and what we do, that's where and you know, we have to get a little better, I'll be the first to admit, we have to get a little better for us to advertise for our residents that there's topsoil that's generated down there from the decaying, and that's why we, if you remember, a couple years ago, no more plastic bags, right? So they're all biodegradable paper bags, and you know, once a year, we grind our street trees and we grind some of the brush and it's really a decent kind of mulch, but if you let it sit and we, you know, the requires we have to turn it we have to take temperature of it, and it turns into some fairly decent topsoil and we've actually used it in the parks. But you know, I think I need to get better about getting a better program to make it, or make sure that residents are aware of it. It's not that they have to use it, but just that they're aware of it. I'll make sure we do a better job about that.

Councilor Cuddy

Mr. Talbot? Yes. So I mean, you know, Pete Kramer and Erin Humphrey. I mean, they've mentioned interest in and I guess promoting that option. I think that they would be interested in helping you do that as far as the compost pile for the people of Auburn have access to it. They will surely come up with suggestions on the best facilitate that too.

Mike Talbot

Yeah sure. Actually, they're our best customer for the Permaculture Park. You know, we bring several loads several times a year down there. So yeah, that's a good idea and I will definitely be in touch with Pete. Thank you.

Mayor Quill

Thanks Mike. Thank you. With no further discussion, Clerk, call the roll for Resolution Number 69. Please.

Mr. Dygert, City Manager's report, please.

City Manager Dygert

Mayor Quill

Okay, thank you. Any questions?

Councilor Giannettino

Mr. Dygert, this 11 County coalition? Is there any representation from private business that you know of?

I believe so. I believe that that's a significant part of what goes on and, and I guess I couldn't tell you off the top of my head.

AUTHORIZING A PROFESSIONAL SERVICES CONTRACT FOR ELECTRICAL SAFETY SERVICES

WHEREAS, over the past few years, the City has been working to come into full compliance with development and implementation of an electrical safety and electrical maintenance program; and

WHEREAS, the Department of Municipal Utilities maintains and operates a multitude of high risk electrical equipment to provide its Water/Wastewater Treatment and Hydro Electric Power services; and

WHEREAS, the Department of Municipal Utilities issued a Request for Proposals seeking to solicit professional firms that would provide electrical safety services such as ARC Flash analysis, low voltage breaker inspection, transformer oil testing, and infrared thermograph studies for the City of Auburn on an annual basis; and

WHEREAS, on May 29, 2020 the City of Auburn received proposals from four (4) qualified professional electrical service firms; and

WHEREAS, the City of Auburn Department of Municipal Utilities and the City Safety Office reviewed and scored the proposals against the criteria outlined in the RFP; and

WHEREAS, the scoring criteria used to rank each firm included a total possible score of 100 and was as follows:

1) Cost (70 points)
2) Responsiveness of Firm (10 points)
3) Qualifications of Firm (20 points),

; and

WHEREAS, the following average scores for the firms who responded to the request for proposals were as follows:

Integrated Energy Concepts Engineering PC
 HMT
 Score: 72.25
 Matco Electric Corporation
 O'Connell Electric Company
 Score: 69.25

; and

WHEREAS, it is necessary to enter into an agreement with the highest ranking firm, Integrated Energy Concepts Engineering PC for the aforementioned scope of work including future annual electrical maintenance and testing of necessary equipment.

NOW, THEREFORE, BE IT RESOLVED that the Auburn City Council does hereby approve the City to enter into an agreement with Integrated Energy Concepts Engineering PC for professional electrical services; and

What Tim would probably tell you, is that this is a requirement we have from our insurance carrier. It's also recommended best practice for any of our facilities that utilize high energy. It's even recommended here at City Hall. So we have some, some pretty powerful stuff coming into City Hall and some three phase stuff. But the water and wastewater facilities utilize a lot of energy. Some of you may be familiar with an incident we had at the wastewater facility several, quite a few years ago, that injured an employee, so, you know, these are things, this Electrical Safety Program is highly recommended by our insurance carrier and the Department of Labor just to make sure our employees are safe.

It was this an annual inspection did I hear that correctly?

City Manager Dygert

What they'll do is they come in, they do, I don't remember the specifics of it, they'll come in, they'll do an overall evaluation and they do annual updates to that.

WHEREAS, the City of Auburn maintains a revolving loan program, which allows property owners to finance the cost of sidewalk and/or curb installation and the cost of water and sewer line repair or replacement over a five year period; and

WHEREAS, Attachment A contains a list of all property owners who have requested to participate in the revolving loan programs; and

WHEREAS, approval is required in order to process the property owners' requests to participate in the program(s) for 2020 year and the cost of the programs are detailed in Attachment A.

NOW, THEREFORE, BE IT RESOLVED that the Auburn City Council does hereby approve the expenditure of \$116,637.78 to be charged to HA5497.440.001 to fund the sidewalk and curbing revolving loan program, \$46,710.00 to be charged to HF8340.440.002 to fund the water repair and replacement revolving loan program, and \$158,343.50 to be charged to HG8120.440.003 to fund the sewer repair and replacement revolving loan program.

WHEREAS, on March 18, 2020, the City's Casey Park facility and pool were closed due to the COVID-19 pandemic; and

WHEREAS, on June 11, 2020, Governor Cuomo announced that local governments are now authorized, at their discretion, to open public pools, provided that they comply with the guidance issued by the New York State Department of Health for operations during the COVID-19 Public Health Emergency; and

WHEREAS, the City would like to open and have the Y operate the Casey Park pool for the 2020 season pursuant to the proposed Agreement, which is attached hereto and incorporated herein; and

WHEREAS, Y has provided services and staff for programming at the Casey Park pool since 2009, which provides a source of summer fun for City residents; and

WHEREAS, under the Agreement, the YMCA will provide services and staff for programs at the Casey Park pool, while complying with the New York State Department of Health Interim Guidance for Pools during the COVID-19 Public Health Emergency; and

WHEREAS, the City will pay the Y the sum of \$48,000 in full satisfaction of all personnel and expenses incurred by the Y and the City will continue to supply pool chemicals and maintain the pool and premises; and

WHEREAS, the proposed pool opening is Monday, July 6, 2020, and it's closing would be on August 30, 2020.

Thank you, Mayor. I have a couple of things. I'm wondering if there's been any further communication from our congressional delegation regarding a possible fourth stimulus. Have we heard anything?

City Manager Dygert

We've heard nothing in my office. I'm not sure about the City Clerk's office. Okay.

Chuck Mason

Nothing directly. Just what we hear in the media that they plan to take things up again after the Fourth of July recess.

Councilor Giannettino

It's my understanding that as an organization, we're keeping track of the financial impact of this on us.

City Manager Dygert

Yeah, as a matter of fact, I just signed paperwork to go back to FEMA today for a reimbursement request for some of the things you know, in the first couple months of the situation. So, we'll see how that application goes.

Councilor Giannettino

Recently, the Planning Board approved the project at 70 South Street, which was subsequently denied at the Historical Resources Review Board. My understanding is that's going to come before us now. Do we know when that's going to happen?

City Manager Dygert

I don't know when it will actually be before you for your discussion and a decision. We will likely get you information as we get it. The property owner has not, to my knowledge as of yesterday, had not applied to take that next step, which would be to put the matter before the council.

Councilor Giannettino

So it's up to the property owner to request that. Is there a time limit on that?

City Manager Dygert

I don't know that off hand.

Stacy DeForrest

There is. It's 30 days from the decision they have to take action. Next week, the plan, hopefully will be for Assistant Corporation Counsel Nate Garland to discuss with council some of the aspects of the process of all of that.

Councilor Giannettino

And I have just a general question in terms of Planning and Zoning. I don't need an answer right now. But if staff could get an answer to it. When somebody goes before Planning or Zoning with a project like this, and say they own other property in the City of Auburn. Is their track record, as a property owner, whether there's any outstanding code violations, things of that nature, is that ever taken into consideration? Or, can it be taken to consideration for approval for additional projects in the city?

City Manager Dygert

I'm gonna withhold a comment on that until I find out exactly. Okay. And that's fine. That works or certainly there are things that we do in the city that if someone say has delinquent taxes, or they have outstanding violations that we will hold things up until they get their affairs in order. Whether or not, I don't know if Stacy can address that. Not sure whether or not we have the ability to do that in all cases.

Councilor Giannettino

I don't need an answer tonight and that's kind of an off the wall question. I get that. It's just a question that was posed to me. And it's actually a question that I've asked myself like, I've seen other projects happen, and I've kind of questioned, you know, Planning and Zoning exist for a reason and Council stays out of that for a reason. That's just a question that I have.

Stacy DeForrest

We can certainly look into that and get you a more definite answer. But what I can explain tonight is that the ZBA, and the Planning boards have very different functions. So the Planning board looks at applications and their job is to make sure that that application falls within the realm of the city code The ZBA, on the other hand, what they do is they have much more discretion because their decisions allow for variations outside of what the code provides. So, someone usually comes to the ZBA and says, "I need an exception to the code for these reasons". So they, the two boards have very different functions. So, depending on the type of application, those code violations that you're referring to, may be a factor in the decision, but it may really come down to the actual kind of application that's being considered. So I know that's kind of a messy answer, but we can try to give you a more definitive one.

Councilor Giannettino

Thank you.

Mayor Quill

Very well. Do we have a request for Executive Session? Entertain a motion real quick for Adjournment. So, Councilor McCormick, seconded by everyone else. Clerk, if you would call the roll?
