Reports of City Officials

A. City Manager's Report

- Earlier today, our Codes Department coordinated the installation of temporary fencing at the church at the corner of Wall and Washington St. Our planning, Codes, and Corporation Counsel's Offices have been working with the building owner for several years to address ongoing issues related to the upkeep and structural stability of the building. The stability of the building has deteriorated to the point that staff felt it necessary to install the fencing to keep pedestrians out of harm's way as debris from the building continues to fall from the building unto the adjacent ground. Staff is continuing to work with the property owner to address the issues.
- Our Civil Service Test for Police Officer received 127 applicants, a significant decrease from the last test with approximately 175 applicants, but still a good sized group that we hope scores well.
- The Civil Service Test for Firefighters is scheduled for Oct. 10 and those interested must sign up by Sept. 25. A community outreach event is scheduled for Sept. 17 at the Booker T. Washington Center at 6pm. Information about the job and the process will be available at the event. More information is available on the city webpage for both the event and the registration for the test.
- We urge all residents to complete their 2020 Census by Sept. 30. The Census can be completed electronically through the webpage 2020census.gov, or following the link on the City of Auburn webpage, or call 1-844-330-2020. Census data is used to determine eligibility and funding for a variety of community programs and projects for the next ten years, and is secure and confidential.

Public Safety Building Update:

- Construction trailers are onsite and hazard materials abatement is expected to begin on Monday September 14th. PEAK Construction is anticipating to begin demolition and construction work on Monday September 28th. The City and NYSEG are working to remove the existing overhead electric transformers and to relocate the electrical utilities underground. The relocation of electrical utilities supports the Willard Chapel's master plan and future DRI projects.
- MWBE utilization plans for this project were submitted to NYS DEC and DOS this week. The current proposed MWBE project participation is at \$1,460,114. The City will continue to encourage MWBE participation throughout the project.
