- Our most recent water quality tests showed no detectable microcystin in the raw or finished water. The Powder Activated Carbon PAC system has been shut down for the season with the approval the Cayuga County Health Department.
- The City of Auburn is currently accepting bids for Bradford St. Park Improvements. Bids are due back Nov. 5, 2020 and further information is available on the city webpage under the tab "Bids/RFPs".
- The City of Auburn is currently accepting bids for Backflow Management Software. Bids are due back Nov. 30, 2020 and further information is available on the city webpage under the tab "Bids/RFPs".
- The City of Auburn is currently accepting bids for the South St Corridor Enhancement Project. Bids are due back Dec. 1, 2020 and further information is available on the city webpage under the tab "Bids/RFPs".
- The State St. Bridge Reconstruction Project is progressing well and is on-schedule. The concrete deck surface has been poured and new approaches are being installed this week and next. The bridge should reopen to traffic by the end of December.
- The Parking Garage Repair Project, the result of a fire in May of 2019, is progressing well. The damaged section has been removed, new steel and tension cables have been installed, and concrete was poured last Friday Oct. 30.
- Work on the new Public Safety Building site is progressing well and the move in date for the summer of 2021 is currently achievable.

AGREEMENT RESOLUTION #105 OF 2020

AUTHORIZING AN AGREEMENT WITH BLACK DOT INC. ON BEHALF OF AT&T CONCERNING THE OSBORNE STREET RADIO TOWER

WHEREAS, the City of Auburn owns and maintains a radio tower located at 86 Osborne Street (the "Osborne Tower") upon which telecommunications equipment is located to facilitate the transmission of signals required by both public and private entities; and

WHEREAS, on June 6, 2000, the City and Cellular One entered into a lease agreement, which permitted telecommunication equipment to be located on the Osborne Tower; and

WHEREAS, on November 1, 2007, after AT&T acquired Cellular One's interests, the original lease agreement was renegotiated and amended with AT&T standing in the place of Cellular One and allowing for automatic renewals for up to 25 years; and

WHEREAS, AT&T has since exercised its contractual right to terminate the existing lease agreement and has requested a new, renegotiated agreement; and

WHEREAS, AT&T hired Black Dot, Inc. to act as its agent in this renegotiation; and

WHEREAS, Black Dot, Inc. and City staff have reached a mutually-agreeable resolution as outlined in the attached proposed Stipulation of Settlement; and

WHEREAS, City staff now recommends adoption of the proposed lease agreement, which is attached hereto and incorporated herein, since it provides contractual certainty and the assurance that an important service will continue without interruption

NOW, THEREFORE, BE IT RESOLVED that the Auburn City Council does hereby approve an agreement between the City of Auburn and Black Dot, Inc., on behalf of AT&T, pursuant to the terms of the agreement between the parties, which is attached hereto and incorporated herein; and

BE IT FURTHER RESOLVED that the Mayor is hereby authorized to sign the agreement on behalf of the City, together with any and all documents necessary to carry out this resolution.

FINANCIAL RESOLUTION #106 OF 2020

AMENDING THE 2020-2021 CITY OF AUBURN CONSOLIDATED FEE SCHEDULE, LANDFILL FEES

WHEREAS, the Auburn City Council annually adopts a Consolidated Fee Schedule in June of each year; and

WHEREAS, the City Manager and Department Heads have reviewed the Consolidated Fee Schedule and have determined that amendments are needed; and

WHEREAS, the City of Auburn is in the process of final closure for the landfill and all waste will now be processed at the transfer station; and

WHEREAS, the section of the Consolidated Fee Schedule named Landfill Fees needs to be renamed Transfer Station Fees; and

WHEREAS, Property Owner Decals and Non-Resident Day passes need to be deleted and Non-Resident Decals need to be changed from \$60/twelve months to \$120/twelve months and the gate rate tipping fee for using the transfer station for Non-Residents needs to be changed from \$72/ton and \$3.60 minimum to \$100/ton and a \$5.00 minimum; and

WHEREAS, the amended Transfer Station Consolidated Fee Schedule attached hereto and incorporated herein is proposed for adoption for the 2020-2021 fiscal year.

NOW, THEREFORE, BE IT RESOLVED that the Auburn City Council does hereby adopt the amended Consolidated Fee Schedule attached hereto for the fiscal year 2020-2021.

WHEREAS, on October 16, 2020 the City of Auburn received proposals from two qualified professional engineering service firms; and

WHEREAS, the City of Auburn's Department of Public Works and Department of Municipal Utilities reviewed and scored the proposals against the criteria outlined in the RFP and the following average scores were as follows

Barton & Loguidice
 D&B Engineers and Architects
 Score: 97.5
 Score: 88.67

; and

WHEREAS, City staff now recommends that the professional service contract necessary for the closure of the Auburn City landfill be awarded to the highest ranking firm, Barton & Loguidice.

NOW, THEREFORE, BE IT RESOLVED that the Auburn City Council does hereby authorize an agreement with Barton & Loguidice for professional engineering services needed for the closure of the City of Auburn landfill; and

BE IT FURTHER RESOLVED that this resolution shall be charged to account AL8167.551, Landfill Closure Accrual; and

BE IT FURTHER RESOLVED that the Mayor, or his authorized designee, be authorized to sign any and all documents associated with this agreement.
