# A. City Manager's Report

• The City of Auburn is seeking bids for the following projects:

• CDBG Sidewalk Program; bids are due May 19, 2021. More information on this projects is available on the City of Auburn webpage under the tab "Bids/RFPs"

• This week we were notified that the City of Auburn has been selected as one of approximately 40 communities to participate in a joint NYS DEC and DOH initiative to protect drinking water sources. The Drinking Water Source Protection Program (DWSP2) will work collaboratively with local drinking water suppliers to conduct a variety of studies, develop programs, identify funding sources, and implement and monitor plans to protect the drinking water for years to come.

• Last Friday staff was notified that the church at the corner of Wall St and Washington St was noticeably deteriorating during the wind storm. Representatives from our Codes, Fire, and Engineering Departments responded to assess the situation and determine a course of action. While we have had concerns about the stability and safety of the building for several years and we were making our way through the legal process to address the issues, the developments on Friday caused us to re-evaluate those prior plans and ultimately declare the structure an imminent hazard. A secure perimeter around the structure was expanded to protect the public from falling debris and a process to stabilize the building through controlled demolition was started. A number of regional contractors were contacted to determine their interest, capability, availability, and cost. It is likely the actual demolition of the building will begin as soon as next week.

WHEREAS, Officer Warter, also, filed his own separate claim against Allstate Insurance Company; and

WHEREAS, on March 9, 2020, Allstate acknowledged the claims and provided notice of the insurance policy coverage, which included coverage of up to a maximum of \$50,000; and

**WHEREAS**, after extensive settlement discussions, it is recommended that the \$50,000 award to be paid by Allstate be split equally between the claimants; and

WHEREAS, the attached mutual Release of All Claims memorializes this settlement and is attached hereto and incorporated herein.

**NOW, THEREFORE, BE IT RESOLVED** that the Auburn City Council does hereby approve the following:
