#### **CEREMONIAL PRESENTATIONS –**

**Public to be heard:** Mayor Quill asked the Clerk read the public to be heard rules. The following individual spoke:

My name is Zach Ciapello, I live at 65 South Street. Mayor and esteemed members of the council, the historic Mill Street Dam was sprayed with herbicide and bush hog recently. It's destroyed habitat for native species killed native plants and insects and encourage degradation of the soil at the area. Today when I had gone down to fish, I noticed a paucity of aquatic life and a strange odor they were spraying again. I approached the vehicle and the kind workers provided me with information about the engineering department who had instructed them to do the work. The workers did not have safety sheets on hand. Upon calling the engineering department a supervisor kindly and patiently answered all my questions. The employee who authorized the work later returned my call with information about the herbicides. Today, the city authorized Roundup pro-concentrate, Oust XP, Alligare MSM 60, Alligare Dicambe +2, 4-D DMA, the last of which is related to the active ingredient in Agent Orange, and is appealing as an effective broadleaf defoliant but a class 2b carcinogenic compound. These chemicals are also toxic to our aquatic ecosystem. Children play by the river and in our lake, which is just a short walk downstream. Please see the provided material safety data sheets for toxicity specifics. I encourage the city council to evaluate why we are using these dangerous, toxic chemicals where we play, fish and source our valuable drinking water. This is not a sustainable practice and I urge the city to complete a thorough, thoughtful scientific and public review of the chemicals used to kill plants in the city and evaluate their ecological impact. I asked that the MSDS sheets for the chemicals used today be entered into the record and I thank the council.

My name is David Scott. I At 63 South Street, Auburn 13021. Talking today in terms of the pro forma for the Koala center of Auburn. Presentation today 13 of May 2021 is about the lines of businesses for this perspective nonprofit operating within the municipal limits of the city of Auburn New York. Lines of business are the call of business call a society call center for culture and global engagement. And unnamed as of yet a wholly owned subsidiary, a capital company. The funding for this nonprofit is tentatively scheduled to be a \$10 to \$12 million bond issuance from the city of Auburn that is exactly the amount spent on the new public safety building. Interest Rate projected at .25% term 30 years useful life so the capital 20 years average per project. Operating grants also from the CDBG Fund and the CBDG allocation to the city of Auburn. Also, new funding source identified New York State Office of Cannabis Management. Also, potential funding from the Minority Business Development Agency. Today I am pleased to announce the trademark issue. The model we will be using is known as the Auburn Minority Economic Accelerator. It will be a model of targeted local minority economic development within the Municipal Corporation limits of Auburn. The three references are city of Cincinnati Minority Business Accelerator, the Brookings Institute of Washington DC and the United States Department of Commerce and Minority Business Development Agency. Moving quickly to the end, five tenets of this center are visibility, agility and most definitely accountability. Laser like focus on minority, disadvantaged and Small Disadvantaged Business Enterprises in the city of Auburn. People who are looking to start expand just locate here de novo. Regular title six equal opportunity audits, regular title seven Equal Employment Opportunity audits and we will most assuredly champion social

and economic stability within a framework of economic justice, not social justice. Concluding, we are not a community development nonprofit. We are not an economic development nonprofit. We are a minority economic development nonprofit.

That's historic, I think. Yes. Thank you. It's great. It's a wonderful thing. I think they've kind of, because of COVID, or whatever, we haven't really gotten a chance to, to realize that and when she told me that, I know, we have, we haven't had the usual swearing ins when they're two weeks. Okay, all right. I just wanted to acknowledge Senator Mannion, and comment on the wonderful advancements. If we say we don't have a diverse

police force or fire department, we have that too now, with women being represented. So, I think we've come a long way.
