BUDGET RESOLUTION #66 OF 2021 ADOPTING THE CITY OF AUBURN BUDGET FOR THE FISCAL YEAR 2021-2022

WHEREAS, the City Manager has presented to the City Council a final proposed budget for 2021-2022 fiscal year, which encompasses the various funds of the City; and

WHEREAS, a public hearing on this final budget was duly held on May 20, 2021; and

WHEREAS, the City Council wishes to adopt said recommended budget.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Auburn, New York hereby:

- 1. Adopts the 2021-2022 General fund budget in the amount of \$38,170,312, with the amount of \$13,146,346 to be raised by property taxes based upon the 2021-2022 taxable assessed valuation of \$1,047,203,722 which will produce a tax rate of \$12.553762 per \$1,000 of taxable assessed valuation; and
- 2. Adopts the 2021-2022 BID levy in the amount of \$145,030 to be raised by special district taxes based upon the 2021-22 taxable assessed valuation of \$57,763,699, which will produce a tax rate of \$2.510752 per \$1,000 of taxable assessed valuation within the Business Improvement District (BID); and
- 3. Adopts the 2021-2022 Power Utility fund budget in the amount of \$1,087,847; and
- 4. Adopts the 2021-2022 Refuse Collection fund budget in the amount of \$1,700,204; and
- 5. Adopts the 2021-2022 Transfer Station fund budget in the amount of \$1,035,990; and
- 6. Adopts the 2021-2022 Solid Waste fund budget in the amount of \$212,933; and

7. Adopts the 2021-2022 Water fund budget in the amount of \$5,960,509; and

AGREEMENT RESOLUTION #67 OF 2021

AUTHORIZING AN AGREEMENT WITH THE DOWNTOWN BUSINESS IMPROVEMENT DISTRICT FOR ANNUAL OPERATION OF THE NYS EQUAL RIGHTS HERITAGE CENTER

WHEREAS, on November 13, 2018, the New York State Equal Rights Heritage Center (the "NYS ERHC") opened at 25 South Street, Auburn, New York, as a part of Central New York's Upstate Revitalization Initiative; and

WHEREAS, the NYS ERHC includes the following attractions and offices: I Love NY Equal Rights Heritage Tourism Promotion Center; Taste NY Market; Local visitor information center for Auburn, Cayuga County and the region; Offices of the Cayuga County Office of Tourism, the Auburn Downtown Business Improvement District (BID) and the City of Auburn Historic & Cultural Sites Commission; and

WHEREAS, the BID's operations of the NYS ERHC has been successful since the Center's opening and the City would like to continue this established partnership; and

WHEREAS, the proposed Agreement, attached hereto and incorporated herein, outlines an operations plan for the NYS ERHC that will commence on July 1, 2021, and last through June 30, 2022, with an ERHC operations budget of \$110,000, and a Historic and Cultural Sites Commission budget of \$30,000 which are both allocated in the City budget's Equal Rights Heritage Center Account (A-10-1621-21-440); and

WHEREAS, the attached agreement will become effective upon approval of the BID Board of Directors and will expire on June 30, 2022; and

WHEREAS, due to impacts of the Coronavirus pandemic during the fiscal year 2020-21 the BID has notified the City that there will be operational funds remaining from the 2020-21 operations contract and that they recommend the funds carry over to the next fiscal year of 2021-22 to be used towards operations.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Auburn hereby approves an Agreement with the Auburn Downtown BID for services related to operating the New York State Equal Rights Heritage Center and the City's Historic and Cultural Sites Commission for a term commencing on July 1, 2021, and ending on June 30, 2022, together with all of the terms and conditions set forth in the Agreement, which is attached hereto and incorporated herein; and

BE IT FURTHER RESOLVED that the City Council of the City of Auburn hereby authorizes the City Comptroller to make payment to the Downtown BID as outlined in the Agreement; and

BE IT FURTHER RESOLVED the City Council approves of any remaining funds from the BID/ERHC operations agreement of the 2020-21 fiscal year be carried over and used for operations of the ERHC in fiscal year 2021-22; and

BE IT FURTHER RESOLVED that City Council of the City of Auburn hereby authorizes the Mayor to sign the Agreement with the Downtown BID, and any and all documents necessary to carry out this Resolution.

AUTHORIZING A GENERAL AGREEMENT WITH THE NATIONAL PARK SERVICE FOR INTERPRETATION AND EDUCATION SERVICES WITH THE EQUAL RIGHTS HERITAGE CENTER

WHEREAS, dating back to the 1990's the City of Auburn has been part of a community effort to obtain National Park Service (NPS) status for sites associated with Harriet Tubman in Auburn, New York; and

WHEREAS, following years of effort and significant historical analysis by the NPS, the Harriet Tubman National Historical Park was signed in to law in January of 2017, making the sites associated with Harriet Tubman in Auburn the 414th unit of the NPS; and

WHEREAS, it is the purpose and intent of the NPS to preserve, protect, interpret, and manage the natural and cultural resources in the National Park System for the benefit, education, and enjoyment of the people of the United States now and in future generations, consistent with the vision of the National Park Service Organic Act of August 25, 1916; and

WHEREAS, the City of Auburn has worked in partnership with NPS over the years as they establish their presence in Auburn; and in recent years the Equal Rights Heritage Center (ERHC) and the City of Auburn Historic & Cultural Sites Commission have worked on coordinating events, interpretive and educational programing, and marketing and promotion campaigns where there is common interest with the Harriet Tubman National Historical Park; and

WHEREAS, NPS acknowledges the importance of community partners to the success of its programs and seeks to embrace and better enable partners to support NPS in its critical education mission; and

WHEREAS, the proposed General Agreement, attached hereto and incorporated herein, establishes a foundational framework to guide and enhance the NPS's partnership with the Equal Rights Heritage Center and the City's Historic and Cultural Sites Commission.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Auburn hereby approves the attached General Agreement with the National Park Service For Interpretation and Educational Services with the Equal Rights Heritage Center for a term commencing immediately and lasting for 10 years; and

BE IT FURTHER RESOLVED that City Council hereby authorizes the Mayor to sign the Agreement with the National Park Service and any and all documents necessary to carry out this Resolution.

AUTHORIZING AN AGREEMENT WITH THE DOWNTOWN BUSINESS IMPROVEMENT DISTRICT

WHEREAS, on June 21, 2018, the City of Auburn and the Downtown Business Improvement District (the "BID") entered into a three-year agreement whereby the City agreed to contribute the sum of \$45,000 to the BID in exchange for services rendered in maintaining the business district; and

WHEREAS, this agreement expires on June 30, 2021, and the parties would like to propose a new three-year agreement, which is attached hereto and incorporated herein; and

WHEREAS, the proposed agreement sets forth a payment of \$45,000 to the BID in the first year and a payment of \$50,000 in the second and third years, with the condition that the increases in funding be allocated specifically to the planting and maintenance of BID flowers; and

WHEREAS, the proposed agreement will be effective July 1, 2021, and expire June 30, 2024.

NOW THEREFORE BE IT RESOLVED that the Auburn City Council does hereby approve an agreement with the Downtown Business Improvement District to provide funds in the amount of \$45,000 in the City Fiscal Year 2021-22, and the amount of \$50,000 in both FY 2022-23 and FY 2023-24, in exchange for services maintaining the Downtown Business Improvement District; and

BE IT FURTHER RESOLVED that the Mayor is hereby authorized to sign the agreement with the Downtown Business Improvement District, and any and all documents necessary to carry out this Resolution.

Sidewalk Replacement Program contract to the lowest qualified bidder which is Concrete Slipform Inc. in the amount of \$121,440.00, contingent upon the City receiving an executed fiscal year 2021 contract from the US Department of Housing and Urban Development.
