COUNCIL RESOLUTION #101 OF 2021

AUTHORIZING CHANGE ORDER #1 FOR THE UV REPLACEMENT AND WWTP IMPROVEMENT PROJECT

WHEREAS, on March 15, 2018, the Auburn City Council authorized Bond Resolution #2 of 2018 to fund the replacement of the UV Disinfection System at the Auburn WWTP and on May 16, 2019 the Auburn City Council passed Bond Ordinance #4 of 2019 establishing additional funds to support the replacement of settled sewage pumps and various components of the WWTP as part of the UV Disinfection System replacement project; and

WHEREAS, on July 18, 2019 the Auburn City Council authorized Award Resolution #83 of 2019 in the amount of \$1,895,000.00 for the construction contract for the UV Replacement and WWTP Improvement project to M.A. Bongiovanni, Inc.; and

WHEREAS, Change Order #1 in the amount of \$50,000 is now requested in order to perform emergency repairs to the grit removal systems as a result of recent flooding and high flows; and

WHEREAS, it is necessary that the City Council award this Change Order #1, in the amount of \$50,000 to M.A. Bongiovanni, Inc. so that the city can perform emergency repairs to the grit removal systems and,

NOW, THEREFORE, BE IT RESOLVED that the Auburn City Council does hereby award Change Order #1, in the amount of \$50,000 to M.A. Bongiovanni, Inc. for the UV Replacement and WWTP Improvements Project; and,

BE IT FURTHER RESOLVED that the sum of up to \$50,000 be transferred from the Sewer fund balance to the WWTP UV Disinfection Project account and the cost of the Resolution in the amount of \$50,000 is to be charged to the capital account titled WWTP UV Disinfection Project #HG8130-440-JI; and

BE IT FURTHER RESOLVED that the Mayor is authorized to sign any and all documents in reference to the award of this Change Order.

Second Public to be Heard

April Miles, Chief Operating Officer, East Hill Medical Center, 144 Genesee Street and 13 North Fulton Street. I just wanted to make a comment I didn't plan to speak tonight. But I wanted to let everybody know that East Hill is a federally qualified health center. We're also a federal vaccine site. We've

adopted a three prong approach to fight COVID infections coming up here. The first prong is providing rapid testing for our staff, their families, we've also elected to provide that for our patients and for our partner organizations. We did this earlier on in the pandemic and that included working with the city to provide rapid testing for their staffing, I just want to let everybody here know that commitment still stands, we are utilizing grant dollars to support the cost of the rapid tests. So, these tests are completed within 15 minutes. And we have two different ones that we're using. We utilize the grant funds so that we can offer those tests here to the community on a reduced fee, sometimes even free of charge, depending on the patient's involved. The second prong to the approaches of utilizing our position as a federally qualified health center to infuse additional volumes of the three vaccines here into the community. We currently have not been utilizing that greatly because we don't have the resources to provide those vaccines. So, one of the questions that the counselors mentioned earlier today was whether or not it would be helpful to go to the state to request additional EMT vaccinators and to get that back on the docket. And that is something that we would need here to support our federal program locally. If we would, if we could have that, we would be more efficient at being able to get these vaccines out. As of September, we would be able to get all three vaccines that includes the Johnson and Johnson, which is currently very difficult to find. So, just want to put that out there as a point of reference for everybody as well. The third piece of the prong, I guess, is actually looking at treatments. So, that's an area that we have not looked at in the past. As a federal site again, we have hersa backing us and so currently, they're putting a survey out to ask if we would be willing to offer antibody treatments here locally. With the support of Dr. Duckett, that is something that we are looking at. And so if you would like I'm sure that as we get further into those discussions, we can have him come in and provide additional information on what type of antibody treatment we could provide on an outpatient basis to keep people out of the hospital and to reduce deaths here locally. Thank you.

Executive Session. Councilor Giannettino made a motion to enter Executive Session, seconded by Councilor McCormick. Council voted to enter an executive session regarding the following matters: One matter made confidential by Federal or State law. (Section 4503 of the Civil Practice Law and Rules which establishes that a confidential communication between attorney and client shall be privileged. Pursuant to this section, Council will be receiving legal advice from its attorney which fulfills the requirement provided in Section 108(3) of the Public Officers Law allowing this exemption.).

The motion to enter executive session carried 4-0. The Council entered Executive Session at 7:20 p.m. Executive session adjourned at 8:09 p.m.

ADJOURNMENT: By unanimous vote the Council adjourned the meeting. The meeting was adjourned at 8:10 p.m..














