## A. City Manager's Report

- Today the Cayuga County Chamber of Commerce graduated their 30th annual Leadership Cayuga class. City of Auburn employees Shelly Lowe, Rhonda Miller, Mark Pineau, and Brian Scanlan completed this year's nine month program.
- The relocation of the Centro bus shelters to Dill St. was completed today. The actual change in service will happen on Monday June 4th as the designated Centro pick up and drop off point will become the new Dill St. stop.
- Lincoln St. in the area of the parking garage and the Equal Rights Heritage Center will be reduced to one lane of one way traffic on Monday June 4. The parking garage will remain open and will need to be accessed from South St. onto Lincoln St. Those exiting the parking garage will be required to turn right (or West) onto Lincoln towards William St. This is a temporary change to enable reconstruction of the roadway, underground utilities, and the grounds of the new Equal Rights Heritage Center.
- The City of Auburn has been asked to participate in a proposed program with NASA. NASA is developing a satellite based water quality monitoring tool that would track changes in bodies of water to anticipate outbreaks of things like blue green algae and help to collect large amounts of data from around the world for comparison and further research. Owasco Lake and Oneida Lake have been identified as potentially good candidates to utilize as test sites. NASA has requested letters of support from organizations involved with the management of these lakes.

**WHEREAS**, the City of Auburn has demonstrated leadership and commitment to revitalizing downtown Auburn which is a critical component of the community's high quality of life and economic opportunity; and

**WHEREAS,** the Governor of New York State announced a third round of the Downtown Revitalization Program in the FY 2019 State Executive Budget, which authorizes the investment of \$100 million in 10 downtowns throughout the Regional Economic Development Councils; and

**WHEREAS,** these funds assist New York State communities with revitalization efforts focused upon transforming downtown districts into vibrant places, where the workforce will want to live, work and raise families; and

WHEREAS, the DRI strategic investment plan can build upon the 2010 City of Auburn Comprehensive Plan, the 2016 Auburn SPARKS Brownfield Opportunity Area and the Parks Master Plan documents, which provide a pipeline of new projects that transform streetscapes, gateways, downtown and brownfield community properties; and

**WHEREAS,** the Downtown Revitalization Initiative funding would bolster downtown activities that could serve as real catalysts for increased economic development, environmental stewardship and enhanced job opportunities for Auburn's diverse residents, while recognizing Auburn as a place that matters.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Auburn, New York as follows

- 1. The Mayor, or appointed designee, is authorized to submit a Downtown Revitalization Initiative application in the amount of \$10,000,000 to the Central New York Regional Economic Development Council by June 1, 2018; and

**WHEREAS,** funding for the additional general construction work will be provided by New York Empire State Development through the Upstate Revitalization Initiative Program.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Auburn does hereby approve Change Order No. 1 to Fahs Construction Group Inc. of Binghamton NY, authorizing the additional general construction work of the Equal Rights Heritage Center in the amount of \$133,163.00, to be charged to the project capital account HA 1620.440.IM; and,
