# SUPPORTING THE OWASCO LAKE WATERSHED MANAGEMENT COUNCIL'S LETTER URGING THE DEPARTMENT OF ENVIRONMENTAL CONSERVATION TO RE-OPEN THE ENVIRONMENTAL CONSERVATION LAW CAFO PERMIT

WHEREAS, Owasco Lake is of paramount importance to the City of Auburn, surrounding townships, and Cayuga County, serving as a drinking water source for approximately 50,000 area-wide residents, providing diverse recreation opportunities such as fishing, swimming, and boating, and is one of the regions key economic development and tourism drivers; and

**WHEREAS,** in recent years, Owasco Lake has experienced seasonal Harmful Algal Blooms (HAB's) that continue to increase in intensity and contain toxins in high concentrations, threatening human health and compromising the intricate aquatic ecology of the lake itself; and

WHEREAS, nonpoint source pollution, including agricultural runoff, may cause or contribute to Harmful Algal Blooms; and

**WHEREAS**, The Department of Environmental Conservation (DEC) defines a Concentrated Animal Feeding Operations (CAFO) as any animal feeding operation that, for 45 days or more within any 12-month period, stables or confines in an area that does not produce vegetation, over 200 mature dairy cows; and

WHEREAS, The DEC regulates CAFOs through a permitting process; and

**WHEREAS**, CAFOs may apply for a permit pursuant to the Clean Water Act (CWA) or Environmental Conservation Law (ECL); and

WHEREAS, a recent court decision invalidated certain provisions of the CWA CAFO permit; and

**WHEREAS**, the DEC has promulgated a draft CWA CAFO permit which will allow for public comment and agency oversight of a CAFO's proposed Nutrient Management Plan; and

WHEREAS, the recent court does not touch on the ECL CAFO permit; and

**WHEREAS**, each and every CAFO within the Owasco Lake watershed is governed by the ECL CAFO permit and thus not affected by this move towards public transparency and agency oversight; and

**WHEREAS**, The Owasco Lake Watershed Management Council is an invaluable resource in protecting and preserving the lake and its watershed; and

**WHEREAS**, The Owasco Lake Watershed Management Council has written the Commissioner of the DEC urging that the ECL CAFO permit be reopened to include the sound and practical changes made to the CWA CAFO; and

**NOW, THEREFORE, BE IT RESOLVED,** that the Auburn City Council supports Owasco Lake Watershed Management Council in its efforts to protect and preserve Owasco Lake by urging the Commissioner of the DEC to close this regulatory loophole; and,

**BE IT FURTHER RESOLVED**, that the Auburn City Council does hereby request that the State Legislators representing the City of Auburn and County of Cayuga including, Senator John De Francisco, Senator James Seward, Senator Pamela Helming, Assemblyman Gary Finch and Assemblyman Bob Oaks work with their colleagues and the Commissioner of the DEC to effect such important regulatory parity; and,

**BE IT FURTHER RESOLVED** that the City Clerk forward certified copies of this resolution to the State representatives named above.

Councilor Giannettino provided the following statement for the record regarding resolution 139 of 2018:

Two weeks ago we discussed last year's lawsuit and the subsequent judicial ruling handed down in April of this year regarding CAFO permits in the State of New York. I was encouraged by this ruling and by the fact that the law was upheld, and that the permitting process was going to be reopened, to allow for public participation, which I view to be an important component of this process.

We asked staff to look into this further and upon doing so staff discovered the following:

- there are two types of CAFO permits CWA and ECL

-the only permits that are open at this time are the CWA permits

-only 21 out of nearly 500 CAFO permits state wide are covered under CWA

-none of these 21 are in Cayuga County

This was discouraging, to say the least.

As a result we have this resolution before us tonight, to endorse the letter prepared, by the OLWMC requesting the NYSDEC reopen the ECL CAFO permit to incorporate those changes proposed in the draft CWA CAFO permits.

-I want to thank the management council for taking this stand

-I fully intend to support their effort and vote for this resolution

However, personally, I do not feel simply voting to request this action goes far enough and I intend to push for more. I have several questions that I require answers to

1) Why are there two separate types of CAFO permits in NYS?

2) Have there always been two? If not, when did this happen?

3) Has this lopsided percentage of ECL CAFO permits to CWA CAFO permits always existed?

4) If it hasn't, and there has been a trend from CWA permits to ECL permits, I would like to know

when this occurred.

5) Which classification of permit do any future CAFOs fall under?

6) How can state law (ECL permits), supersede federal law (CWA permits)

I believe these all of these are valid questions.

According to the NYS HAB action plan for the Owasco lake watershed – on page 63 – it states the following:

"nonpoint sources dominate TP loading to Owasco Lake . Of these non-point sources, 83% is estimated to originate from agricultural land use within the Owasco Lake watershed and therefore should be the focus of nutrient reduction strategies."

While CAFOs are only one component of agriculture, I think it is safe to say that they are a significant percentage of agriculture (600,000 cows, 120 pound of waste per day, per cow = 720,000,000 pounds of waste, per day). How are we supposed to effectively implement any real nutrient reduction strategies if we don't have access to the information?

This HAB issue is not specific to Owasco Lake – it is a very real threat that has affected nearly 100 water bodies state-wide this year. Make no mistake - this crisis that we face is man-made, and it is going to require real solutions if we are going to make a concerted commitment to address it. I am not yet cynical enough to believe we cannot do it.

As a nation we have faced serious man-made environmental issues in the past :

-the Dust Bowl of the 1930s

-the drinking water crisis of the 1960s and 1970s

Both were man-made – and both were successfully addressed by serious minded public servants who recognized it was their duty to do the right thing. For whatever reason that is not currently happening, and until it does, we will continue to witness not only the continued degradation of our waterbodies, but a very serious threat to public health.

## **15. STAFF/VENDOR PRESENTATIONS**

# Presentation Regarding the Project at Falcon Park, Including a Review of the Proposed Agreement between Cayuga Community College and the City - Jeff Dygert, Stacy DeForrest. Cayuga Community College President Brian Durrant also addressed the Council.

On July 19, 2018, City Council of the City of Auburn passed Bond Ordinance #7 of 2018, authorizing the issuance of \$3,000,000 in serial bonds to finance of cost of the renovation and reconstruction of Falcon Park. This Project intends to renovate Falcon Park so that it will be usable as a multi-purpose athletic complex. The renovation includes the construction and/or renovation of athletic fields, installation of a synthetic turf field, modification of facilities to support year round usage and intercollegiate athletics, refurbishment of mechanical, electrical and plumbing systems, grading or improvement of the site and acquisition of original

furnishings, equipment, machinery and apparatus.

Over the course of the summer and into September, 2018, the City met with representatives of Cayuga County Community College ("CCC") to discuss and negotiate the terms of an Agreement, which would cover the cost of the foregoing Project. The proposed Agreement sets forth a twenty-year rental term, during which CCC and the City will be able to use Falcon Park during the year when the Auburn Doubleday's are not in-season. In exchange for its use of the Park, the City will receive rent from CCC in escalated amounts in order to cover the costs of the financing as well as operational expenses.

The Board of Trustees of Cayuga County Community College met on Wednesday, October 3, 2018, to review and voted to approve the proposed agreement, subject to approval by City Council.
