8. Reports of City Officials

A. City Manager's Report

- The Court St parking lot expansion is wrapping up. Approximately half of the lot has received the first coat of asphalt and by next week the parking surface should be mostly complete.
- The North St water main improvement project is also moving along. This week the new 12" main was activated and is now supplying water from Carpenter St to the City line. The next phase of the project is the connection from North St. down York St. to approximately the Chase St. Extension.
- The North Division St Bridge project is progressing. The center pier and northern abutment have been formed and poured. Work is underway to excavate for the relocated southern abutment. As with all of our construction projects weather has been a significant factor on the ability for certain work to progress.
- On November 15 we will have a presentation from our auditors and our comptroller to go over both the recent audit and provide an update on the final budget numbers for last fiscal year.
- Our most recent sales tax numbers for the first quarter of this fiscal year are showing a 10% or roughly \$200k increase from the same period last year. We are cautiously optimistic that this is a trend that will continue.

- Councilor McCormick discussed the first Downtown Revitalization Initiative Public Workshop that was held on October 23, 2018 at the Auburn Holiday Inn. She also praised the completed boardwalk area that was constructed on the Loop Road as part of the Owasco River Greenway Trail project.
- Councilor Giannettino discussed the groundbreaking event held on Monday, October 22, 2018 at Falcon Park for the new turf installation project.

AGREEMENT RESOLUTION #147 OF 2018

AUTHORIZING A LEASE AGREEMENT WITH THE CORNELL COOPERATIVE EXTENSION OF TOMPKINS COUNTY FOR USE OF SPACE AT THE NEW YORK STATE EQUAL RIGHTS HERITAGE CENTER TO OPERATE A TASTE NY MARKET

WHEREAS, the New York State Equal Rights Heritage Center (the "ERHC") is currently under construction at 25 South Street in downtown Auburn and will be owned and operated by the City of Auburn after opening in the fall of 2018; and

WHEREAS, the City of Auburn and the Cornell Cooperative Extension of Tompkins County (aka "TCCE") have negotiated the terms and conditions of a proposed lease agreement, which is attached hereto, whereby TCCE will lease space at the ERHC for the purpose of operating a Taste NY market; and

WHEREAS, pursuant to the proposed lease agreement, the TCCE will lease space at the ERHC for a term of three (3) years and 5 months, commencing on November 1, 2018, and ending on March 31, 2022, with the option to renew for an additional three year term thereafter; and

WHEREAS, pursuant to the proposed lease agreement, the City shall receive rent in the amount of \$5,500 for the first 17 months, and \$5,500 annually for the last two years of the initial term of the lease; and

NOW, THEREFORE, BE IT RESOLVED that the Auburn City Council does hereby approve a Lease Agreement with the Cornell Cooperative Extension of Tompkins County, whereby the City will lease space at the New York State Equal Rights Heritage Center to the TCCE for a term of three (3) years and five (5) months in exchange for rent in the amount of \$5,500 for the first seventeen (17) months of the term, and \$5,500 annually for the last two (2) years of the term, together with all of the terms and conditions set forth in the Lease Agreement, which is attached hereto and incorporated herein; and

BE IT FURTHER RESOLVED that the Mayor is hereby authorized to sign the Lease Agreement with the Cornell Cooperative Extension of Tompkins County, and any and all documents necessary to carry out this Resolution.
