# 8. Reports of City Officials

# A. City Manager's Report

• The Court St parking lot expansion is wrapping up. Approximately half of the lot has received the first coat of asphalt and by next week the parking surface should be mostly complete.

• The North St water main improvement project is also moving along. This week the new 12" main was activated and is now supplying water from Carpenter St to the City line. The next phase of the project is the connection from North St. down York St. to approximately the Chase St. Extension.

• The North Division St Bridge project is progressing. The center pier and northern abutment have been formed and poured. Work is underway to excavate for the relocated southern abutment. As with all of our construction projects weather has been a significant factor on the ability for certain work to progress.

• Later in November we will have a presentation from our auditors and our comptroller to go over both the recent audit and provide an update on the final budget numbers for last fiscal year.

• Our most recent sales tax numbers for the first quarter of this fiscal year are showing a 10% or roughly \$200k increase from the same period last year. We are cautiously optimistic that this is a trend that will continue.

# AUTHORIZING THE CITY OF AUBURN TO APPLY FOR FUNDING UNDER THE CORPORATION FOR NATIONAL AND COMMUNITY SERVICE RSVP GRANT

WHEREAS, the Corporation for National and Community Service (CNCS) administers various service and volunteering programs as well as the Senior Corps RSVP Grant Program which supports volunteers 55 years and older serving in a diverse range of activities that meet specific local and community needs in response to National Performance Measures; and

**WHEREAS,** the City of Auburn RSVP program was established in 1973 and has grown to 420 volunteers that service the City of Auburn and Cayuga County through 3 main Focus Areas including Healthy Futures, Economic Opportunity and Other Community Priorities; and

**WHEREAS,** the City of Auburn RSVP Program is submitting an application to the CNCS Senior Corps RVSP Grant Program in an effort to secure a 3-year continuation grant for FY 2019-2022 in the amount of \$40,000 annually for a total aggregate amount of \$120,000; and

**WHEREAS,** the City of Auburn does not currently have the funding to pay for 100% of the RSVP Program costs and it is necessary to obtain federal funding for this important community service program.

# NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF AUBURN, NEW YORK:

- 1. That the Mayor, or approved representative, is authorized to submit a City of Auburn RSVP Program Grant application to the CNCS in the amount of \$40,000 annually for FY 2019- 2022 by the submittal date of November 7, 2018; and
- 2. Upon award notification, that the Mayor, or approved representative, is authorized to execute the grant assistance contract, submit project documentation, and otherwise act on all matters related to the project and federal assistance; and
- 3. That the City Comptroller is authorized to recognize grant revenue, if awarded, and to appropriate the funds into the correct departmental budget.
