# **APPOINTMENT RESOLUTION #153 OF 2018**

### FOR THE APPOINTMENT OF COMMISSIONERS OF DEEDS

### December 20, 2018

**WHEREAS,** the Auburn City Council appoints individuals as Commissioners of Deeds in order to authorize them to take affidavits, depositions and acknowledgments for use in the City, which gives them powers similar to that of a Notary Public; and

**WHEREAS**, the law for appointment of Commissioners of Deeds is set forth in New York State Executive Law, Section 139, and the Auburn City Code, Section 62-1, which provide that the City Council shall appoint Commissioner of Deeds for a designated term; and

**WHEREAS**, the law requires that term of each Commissioners of Deeds expire on December 31 of the even-numbered year following appointment; that the appointed person reside or work in the City of Auburn; that the appointed person only administer the Commission within the City; and that the appointed person file an Oath of Office with the City Clerk and with the County Clerk; and

**WHEREAS,** the proposed list for Commissioners of Deeds is set forth on the list attached hereto and incorporated herein, and includes 35 persons. It is estimated that a total of 50 appointments may be necessary within the next two years.

**NOW, THEREFORE, BE IT RESOLVED,** that the Auburn City Council does hereby appoint the list of persons attached to this Resolution as Commissioners of Deeds pursuant to the authority provided by New York State Executive Law, Section 139, and that said appointments shall be effective from January 1, 2019, and shall continue until December 31, 2020; and

**BE IT FURTHER RESOLVED**, that the Auburn City Council does hereby determine that the number of Commissioners of Deeds for the City of Auburn shall be a maximum of 50, which is the number of Commissioners of Deeds appointed by the list attached to this Resolution plus additional numbers to be reserved for future necessary appointments.

### FINANCIAL RESOLUTION #154 OF 2018

### AUTHORIZING THE PURCHASE OF A NEW ICE RESURFACER FOR CASEY PARK

WHEREAS, the City of Auburn owns and operates an ice rink at the Casey Park recreational facility; and

**WHEREAS**, the ice resurfacer that is used to maintain the ice has deteriorated and become so unreliable that it should be removed from service immediately; and,

**WHEREAS,** the City will need to rent an ice resurfacer, which is approximately \$6,500/month, however, the Zamboni Company has agreed to provide a short-term rental unit at \$100/month during production of the City's new Zamboni equipment; and

WHEREAS, the new Zamboni equipment has a projected useful life of 15 years; and,

**WHEREAS,** an ice resurfacer was originally included in the City's 2019-2020 Capital Improvement Plan, but was removed when a  $3^{rd}$  party took over rink management, and, therefore, general fund balance in the amount of \$139,598.85 must be used to purchase a new Zamboni ice resurfacer.

**NOW, THEREFORE, BE IT RESOLVED,** that the City Council of the City Auburn hereby authorizes the use of general fund balance for the purchase of a new ice resurfacer from the Zamboni Company in the amount of \$139,598.85, by a budget increase to account No. A7143.250 – Casey Park Equipment; and

**BE IT FURTHER RESOLVED,** that this resolution shall take effect immediately upon its adoption.

### AGREEMENT RESOLUTION #155 OF 2018

### AUTHORIZING A LEASE AGREEMENT WITH WEGMAN'S FOOD MARKET'S INC FOR PARKING SPACES

**WHEREAS**, the City of Auburn has historically leased underutilized parking spaces located on the south side of Genesee Street between Loop Road and South Street to Wegman's Food Markets, Inc. ("Wegman's") for exclusive employee use; and

**WHEREAS**, the existing lease agreement terminated on February 28, 2018, and the parties would like to enter into a new agreement; and

**WHEREAS**, under the proposed agreement, Wegman's will pay the City the sum of \$1,500 for eight (8) designated parking spaces for the next four (4) months commencing on December 1, 2018, and ending on March 31, 2019; and

WHEREAS, Wegman's has already approved the proposed Lease Agreement.

**NOW, THEREFORE, BE IT RESOLVED** that the Auburn City Council does hereby approve a Lease Agreement between the City of Auburn and Wegman's Food Markets, Inc., under which Wegman's will leases eight (8) designated parking spaces on the south side of Genesee Street between South Street and Loop Road beginning December 1, 2018, and ending on March 31, 2019, for the payment of \$1,500; and

**BE IT FURTHER RESOLVED** that the Mayor is authorized to sign any and all documents in order to finalize the agreement.
