8. Reports of City Officials

A. City Manager's Report

- Staff met this week to discuss the upcoming grant opportunity through NYS know as Local Initiatives Suport Corporation (LISC). This is the same grant program that has helped fund a portion of our enhanced Code Enforcement Staffing and Assistant Corporation Counsel for the last two years. The new grant will allow us to continue these programs as well as potentially fund new code enforcement software that will improve efficiency and communication. The new grant is also for two years and the applications are due March 8.
- The Auburn Housing Authority has had an open board member spot and we had an open call for applications for the last few weeks. This is a City Manager appointment. I have appointed Thomas Falicchio to that position. Tom brings years of experience that include work with Planning Boards, Cayuga County Homesite, is currently on the Board of the Boyle Center and Bluefield Manor, and was very involved in the redevelopment of Westlake Ave., Orchard St., and Bluefield Manor.
- The City of Auburn is accepting bid proposals for the replacement of water service lines containing lead as part of a grant funded initiative. Bids are due on March 7, 2019 and details can be obtained through our webpage under the tab "Bids/RFPs."
- The City of Auburn is Requesting Proposals for the replacement of an aging Zebra Mussel Control system on our drinking water intake. RFPs are due February 15, 2019 and details can be obtained through our webpage under the tab "Bids/RFPs".
- The City of Auburn is Requesting Proposals for the Renovation for Water Filtration Plant Facility. RFPs are due February 15, 2019 and details can be obtained through our webpage under the tab "Bids/RFPs".
- The City of Auburn is Requesting Proposals for Sludge Hauling Services from our wastewater treatment facility. RFPs are due February 14, 2019 and details can be obtained through our webpage under the tab "Bids/RFPs".
- Last week I met with staff from DPW, Municipal Utilities, Planning, and Engineering as well as the Cayuga County Soil and Water Conservation District, Peter Kramer from our permaculture park, and Walt Aikman our local tree expert. The purpose was to collaborate on ways to achieve common goals of providing healthy, attractive, and easy to maintain green space. It was a productive meeting that has us focusing on the arterial median from State St. west to the city line and the area of the Owasco River Trail from North St. to Pulsifer Dr. At our next meeting we will discuss Tech Park and some specific city parks. I'm hopeful that we will be able to implement some changes this summer season. We will have a presentation for Council within the next few months to share some ideas and gather further input.
- Over the next few days our Corporation Counsel's Office will be sending tax foreclosure notices out related to approximately 113 properties.

Gavett, Esq., appeared and intervened in these proceedings on behalf of the Auburn Enlarged City School District; and

WHEREAS, after extensive settlement negotiations, the Parties and their attorneys have agreed that a settlement as outlined in the attached proposed Stipulation of Settlement and Judicial Order would be in the best interests of all parties and would avoid further litigation expense; and

WHEREAS, the Auburn City School District Board of Education has already approved, the proposed settlement as outlined in the attached; and

WHEREAS, the Cayuga County legislature has already approved the settlement as proposed.

WHEREAS, the parties propose to amend the terms of Articles VIII and XXIII of the Agreement, which is attached hereto and incorporated herein; and

WHEREAS, the Union held a meeting of its members on January 30, 2019, and voted in favor of the amendment of the Agreement.

NOW, THEREFORE, BE IT RESOLVED that the Auburn City Council does hereby approve the amendment to the Collective Negotiations Agreement between the City and the New York Finger Lakes Region Police Officers Local #195 and further authorizes the Mayor, City Manager, Corporation Counsel, and Comptroller to sign any documents necessary to carry out the intent of this resolution.
