15. STAFF/VENDOR PRESENTATIONS

Downtown Revitalization Initiative Final Plan by Christina Selvek, Director of Capital Improvement Program and Grants On Friday July 27, 2018 Governor Andrew Cuomo visited the community to announce the City of Auburn as the \$10 million Central New York Region Winner of the 3rd Round of the Downtown Revitalization Initiative grant program. Since the award announcement, City officials and staff have worked collaboratively with NYS Department of State regarding the selection of the Local Planning Committee (LPC) Members and project consulting team lead by Bergmann Associates out of Rochester, NY. Over the course of nearly 6 months the 14 member LPC met six (6) times to review projects that were submitted as part of the City's initial application as well as through one round of Call for Projects and one round of Call for Concepts. The Auburn DRI also consisted of four (4) public workshops which were geared towards public engagement, feedback and education about the DRI process. All LPC and public meetings for the Auburn DRI were well attended.

The City of Auburn initially included 5 projects in the May 2018 DRI application which were:

- State Street Event Plaza- total project cost of \$1,700,000
- · Greening East Hill- total project cost of \$560,000

- Shared Services Public Safety Facility- total project cost of \$10,000,000
- NPS Hart Corridor Enhancements (streetscape)- total project cost of \$300,000
- Downtown Wayfinding Signage Program- total project cost of \$70,000
- Market Auburn Initiative- total project cost of \$200,000

Following the announcements of the 2018 Consolidated Funding Applications (CFA) and the completion of the DRI LPC project evaluations, the City of Auburn will be moving forward with the following projects:

- Shared Services Public Safety Facility- total project cost of \$11,000,000
- State Street Event Plaza- total project cost of \$1,600,000
- · Market Auburn Initiative (CFA 2018 award)- total project cost of \$200,000

A total of 18 projects with an aggregate DRI request amount of \$13.5 million will be presented in the City's DRI Strategic Investment Plan. Since this is more than the \$9.7 million NYS will be allocating to projects, the City is still competing for NYS funding for the Public Safety and State Street Plaza projects. Therefore, City staff will be requesting a resolution supporting the submission of these projects and reaffirming the City's need and request for NYS aid to complete these projects.

Councilor Giannettino asked the City Manager to look into paving on Fitch Avenue. The street was just repaved last fall and is already in disrepair in some areas on the east end of the street near the entrance of the Fort Hill Cemetary.
