WHEREAS, the City of Auburn and the Civil Service Employees Association, Inc., Local 1000, AFSCME, AFL-CIO, Professional and Administrative Unit No. 6251-02 (the "Union") have previously entered into a collective bargaining Agreement which expires on June 30, 2019; and

WHEREAS, the City and the Union have been engaged in extensive negotiations in order to allow the parties to enter into a new collective bargaining Agreement, which would take effect on July 1, 2019; and

WHEREAS, it is necessary that the Auburn City Council ratify the terms of the new Agreement; and

WHEREAS, the new Agreement remains materially unchanged with the exception of the revised terms, which are set forth in a Tentative Agreement, by and between the City and the Union, and which is attached hereto and incorporated herein; and

WHEREAS, on March 29, 2019, the Union members voted to ratify the Tentative Agreement.

NOW, THEREFORE, BE IT RESOLVED that the Auburn City Council does hereby ratify the terms set forth in the negotiated Tentative Agreement and does further authorize the Mayor, City Manager, Corporation Counsel, Comptroller, and Director of Planning and Economic Development to execute the Agreement with the Civil Service Employees Association, Inc., Local 1000, AFSCME, AFL-CIO, Professional and Administrative Unit No. 6251-02.

AUTHORIZING AN AGREEMENT WITH WEGMAN'S FOOD MARKET'S INC FOR PARKING SPACES

WHEREAS, the City of Auburn has historically leased underutilized parking spaces located on the south side of Genesee Street between Loop Road and South Street to Wegman's Food Markets, Inc. ("Wegman's") for exclusive employee use; and

WHEREAS, the existing lease agreement terminated on March 31, 2019, and the parties would like to enter into a new agreement; and

WHEREAS, under the proposed agreement, which is attached hereto and incorporated herein, Wegman's will pay the City the sum of \$2,250 for eight (8) designated parking spaces for the next six (6) months commencing on April 1, 2019, and ending on September 30, 2019; and

WHEREAS, Wegman's has already approved the proposed Agreement.

WHEREAS, bids were advertised for the project and on March 7th, 2019 and the following bids were opened and received; and
