8. Reports of City Officials

A. City Manager's Report

- As part of the construction of the Equal Rights Heritage Center the intersection of William St and Lincoln St. has been operating as a three way stop since the beginning of the month. Earlier today the contractor was able to paint the street markings on the intersection which include a pedestrian crosswalk area across William St. We urge drivers to use caution in the area as everyone gets accustomed to the new traffic flow. Construction announcements pertaining to the project are posted on the city of Auburn webpage (www.AuburnNY.gov/welcomecenter).
- In the shadow of yesterday's tragedy in south Florida, the Auburn Police Department's Emergency Response Team, in collaboration with the Auburn Fire Department and the Auburn School District, will be conducting a joint training exercise testing our response to an active shooter scenario at the Auburn High School. APD obviously hopes we never have to employ this training in a real life situation, however, they are cognizant of the everyday threats in our society and will be ready to respond to any/all situations presented to the department. This training is scheduled for next week during the school district's February break.
- Also, the Auburn Police Department has released its 2017 Annual Activity Report that highlights the years accomplishments and goals for 2018. The report, as well as the Syracuse University employee and community survey reports, are now available both on the department website and Facebook pages.
- Yesterday, Governor Andrew Cuomo announced the dates and locations of four summits supporting NYS's comprehensive effort to protect vulnerable lakes and waterbodies in Upstate New York from Harmful algal blooms. The four regional summits are part of the \$65 million four-point initiative unveiled in the Governor's State of the State to aggressively combat harmful algal blooms in Upstate New York. The City of Auburn will be represented at a summit. There has been a Steering Committee recommended by the DEC, then picked and confirmed by the Governor's Office. Seth Jensen, Director of Municipal Utilities, has been asked to serve on the steering committee for the Central NY Region, representing Owasco Lake.
- Leak Detection Yesterday, Municipal Utilities staff met with the people who developed the technology the City uses for leak detection, which is called Sensus Analytics. They discussed a potential new piece of the program that allows customers to set up an account for an online portal and view their water meters and usage. Landlords and businesses, especially high volume water users, could benefit. There would be an up front cost of approximately \$20,000, and an additional \$6,000 fee for the first 1,200 customers. Staff has talked to a few potential customers, and there has been interest, even with the idea of the customers covering the \$6,000 fee. This program would also provide efficiencies for Municipal Utilities staff, who spend an enormous amount of time on leak detection. Would Council like a presentation?
- This morning, City Manager Jeff Dygert and DPW Superintendent Mike Talbot attended a meeting of the Town and County Highway Supervisors to talk about opportunities for shared equipment and services.

- Casey Park Playground Since the January 25th City Council Presentation on Casey Park Playground, the Office of Planning and Economic Development, Department of Public Works and Park Committee members have been actively reaching out to the community for the community build project. The community's response for volunteers has been tremendous. To date we have about 200 volunteers from the community including

The City is providing CDBG funds to continue its relationship with Play by Design to implement the design of Casey Park Playground and coordinate/organize volunteers during build week in May. An organizational meeting with Play by Design to discuss build week will be held on February 27th.

• 1-7 State Street – In response to public input on the design for 1-7 State Street, which includes a band shell and restroom, City staff have engaged Bergmann Associates for additional work scope to complete the design and construction documents. We anticipate having the final design by the end of April.

- **NOW, THEREFORE, BE IT ORDAINED** that the Auburn City Council does hereby repeal Chapter 305 in its entirety, passed on December 30, 1992, which adopted Chapter 305 of the City Code; and
- **BE IT FURTHER ORDAINED,** that the Auburn City Council does hereby adopt Ordinance #1 of 2018 as Chapter 305 of the Auburn City Code entitled "Zoning"; and
- **BE IT FURTHER ORDAINED,** that the Auburn City Council hereby directs codification of Chapter 305 of the Auburn City Code entitled "Zoning"; and
- **BE IT FURTHER ORDAINED** that the foregoing repeal and adoption of this shall take effect immediately.

AUTHORIZING EXECUTION OF AN AGREEMENT SUPPORTING THE OWASCO LAKE WATERSHED MANAGEMENT COUNCIL, INC. AND ITS ASSUMPTION OF FULL ADMINISTRATIVE RESPONSIBILITIES OF THE OWASCO LAKE WATERSHED INSPECTION PROGRAM

WHEREAS, the City of Auburn, the Town of Owasco and the County of Cayuga, are responsible for providing clean public water from Owasco Lake to approximately forty-five thousand water users within Cayuga County; and

WHEREAS, the City of Auburn and the Town of Owasco are responsible, under the New York State Public Health Law Section 1100, and 10 NYCRR, Section 104.1, for inspecting and reporting compliance with the Owasco Lake Watershed Rules & Regulations; and

WHEREAS, the County of Cayuga is responsible, under the Public Health Law, Section 225, and 10 NYCRR, Section 5-1.10, for testing, monitoring and reporting on the quality of the drinking water provided by the City of Auburn and the Town of Owasco; and

WHEREAS, on January 1, 2011, in furtherance of the Owasco Lake Watershed Rules and Regulations, the City of Auburn, the Town of Owasco, the County of Cayuga, and the Cayuga County Soil and Water Conservation District, entered into an agreement for the purpose of supporting the Owasco Lake Watershed Inspection Program (the "Program"), until such time

as the Owasco Lake Watershed Management Council, Inc. (the "Management Council") was able to assume full and ongoing administration of the Program; and

WHEREAS, on August 15, 2017, the Management Council, by its Board of Directors, approved a Board Resolution, confirming the Board's determination that the Management Council is ready, willing and able to assume full administration of the Program, and that doing so will be in the best interest of the Program; and

WHEREAS, the primary purpose of the Management Council is to monitor and inspect Owasco Lake and its Watershed and any activities and circumstances that may impact the quality and general health of the waters of Owasco Lake or the water resources of the Owasco Lake Watershed; and

WHEREAS, the Management Council has established a standing Watershed Inspection Committee (the "Committee") to oversee and manage the operation and implementation of the Program, which is comprised of representatives from the City of Auburn, Town of Owasco and Cayuga County; and

WHEREAS, the City of Auburn wishes to support the proposed transition of the Program to the Management Council.

NOW, THEREFORE, BE IT RESOLVED that the Auburn City Council hereby expresses its appreciation and thanks to the Cayuga County Soil & Water Conservation District Board of Directors, Executive Director, and staff for the administrative support provided to the Program during its formative years, during which time the Management Council built its organizational and operational capacity to assume the full administrative responsibility and oversight for the Program; and

BE IT FURTHER RESOLVED that the Auburn City Council hereby requests termination of the existing Agreement, dated January 1, 2011; and

BE IT FURTHER RESOLVED that the Auburn City Council hereby conditionally approves an Agreement, attached and made a part of this Resolution, by and between the City of Auburn, the Town of Owasco, the County of Cayuga and the Owasco Lake Watershed Management Council, Inc., conditional upon the amendment of the Bylaws of the Management Council to reflect the appointment of an additional City representative, who shall act as a voting member of the Owasco Lake Watershed Management Council standing Watershed Inspection Committee, and who shall be a high-level City employee; and

BE IT FURTHER RESOLVED that the Auburn City Council hereby authorizes and directs the Mayor, or his named designee, upon the satisfaction of the condition stated herein, to execute the proposed Agreement, together with any and all documents necessary to carry out the intent of this Resolution; and

BE IT FURTHER RESOLVED that this Resolution shall take effect immediately upon adoption.

WHEREAS, a Project to reconstruct the North Division Street Bridge in the City of Auburn, P.I.N. 374458 (the "Project") is currently funded under Title 23 US Code, as amended and the Locally Administered Federal Aid Program (LAFAP); and,

WHEREAS, Resolution #24 of 2017 authorized the City of Auburn to enter into an agreement with NYS Department of Transportation to proceed with the bidding, construction and inspection phases for the North Division Street Bridge Replacement Project; and

WHEREAS, the NYS Department of Transportation Schedule A for this Project has since been amended to reflect the engineer's estimate for all project phases including design, ROW incidentals and acquisition, construction, construction administration and inspection as well as improvements to the Finger Lakes Railway crossing for a total Project cost of \$6,338,000; and

WHEREAS, the NYS Department of Transportation is requesting the City of Auburn to advance the above Project by making a commitment of 100% of the first instance payments of

the total project costs in the amount up to \$6,500,000 for all Phases as well as possible field change orders related to bridges and railroad crossings.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Auburn hereby authorizes payment in the first instance of 100% of the federal and non-federal share of the costs for all Project phases including design, ROW incidentals and acquisition, construction, construction administration and inspection as well as improvements to the Finger Lakes Railway crossing or portions thereof; and,

BE IT FURTHER RESOLVED that the City's required local match of \$30,190 be made available from the North Division Street Bridge Capital Account (#HA 5110 440 HM) to cover the cost of participation in the above Phases of the Project; and,

BE IT FURTHER RESOLVED that in the event the full Federal- and non-Federal share costs of the project exceeds the amount appropriated above, the City of Auburn City Council shall convene as soon as possible to appropriate said excess amount immediately upon notification by the New York State Department of Transportation; and

BE IT FURTHER RESOLVED that a certified copy of this resolution be filed with the New York State Commissioner of Transportation by attaching it to any necessary agreement in connection with the Project; and,

AUTHORIZING THE CONSTRUCTION INSPECTION SERVICES CONTRACT FOR THE NORTH DIVISION STREET BRIDGE PROJECT - PIN 375548

WHEREAS, the Auburn City Council did, by Agreement Resolution #24 of 2017, authorize the Mayor to enter into an agreement with New York State Department of Transportation to proceed with the North Division Street Bridge Replacement Project (PIN 3755.48) phases for Right-Of-Way, Construction and Construction Inspection Services; and,

WHEREAS, on February 15, 2018 the Auburn City Council authorized payment in the first instance of 100% of the federal and non-federal share of the Project for a total cost up to \$6,500,000; and

WHEREAS, it is necessary in furtherance of this Project that a professional engineering firm be awarded a contract for the Construction Inspection services portion of the Project to Popli Design Group in an amount not to exceed \$725,000; and

WHEREAS, Popli Design Group is qualified to perform the Construction Inspection services with the contractual agreement being contingent upon the approval of the New York State Department of Transportation; and

WEREAS, it is necessary that Popli Design Group be awarded the contract for the Construction Inspection services portion of the North Division Street Bridge Project in an amount not to exceed \$725,000.

NOW, THEREFORE, BE IT RESOLVED, that the City Council of the City of Auburn does hereby approve an award to Popli Design Group for construction inspection services for the North Division Street Bridge Replacement Project in an amount not to exceed \$725,000 and said agreement is contingent upon the approval of the New York State Department of Transportation; and

BE IT FURTHER RESOVLED, that the cost of the construction inspection services contract is to be charged to the North Division Street Bridge capital account #HA5110.440 HM.; and.

BE IT FURTHER RESOLVED, that the Mayor of the City of Auburn be and is authorized to execute all necessary agreements, certifications, and reimbursement requests for Federal Aid/ and/ or New York State Marchiselli Aid/ and/ or NYS Bridge NY Aid with the New York State Department of Transportation in connection with the advancement or approval of the Project and providing for the administration of the Project and the municipality's first-instance funding of Project costs and permanent funding of the local share of Federal-aid and State-aid-

COUNCIL RESOLUTION #36 OF 2018

AUTHORIZING THE CITY TO APPLY FOR THE 2018 GRANT ENTITLED "IMPROVING CRIMINAL JUSTICE RESPONSES TO SEXUAL ASSAULT, DOMESTIC VIOLENCE, DATING VIOLENCE AND STALKING GRANT PROGRAM"

WHEREAS, the City of Auburn New York Police Department desires to be an antidomestic violence/pro-arrest police agency by reducing the likelihood of escalation of domestic violence, as well as combating Sexual Assault; and

WHEREAS, U.S. Department of Justice Office (US DOJ) through the Office of Violence Against Women has released funding in the form of a competitive grant which is due for submission by February 27, 2018, entitled "Improving Criminal Justice Responses to Sexual Assault, Domestic Violence, Dating Violence, and Stalking Grant Program"; and

WHEREAS, the Auburn Police Department, in collaboration with the Cayuga Seneca Community Action Agency (CSCAA), and the Cayuga County Sheriff's Office (CCSO), it has been recommended that the City pursue funding through this grant opportunity to be used towards funding of Auburn Police overtime while delivering the domestic violence follow-up program; and

WHEREAS, the City of Auburn Police Department has a large amount of domestic violence investigations, and would like to invest additional time and resources in the prevention, arrest and conviction of those who perpetrate domestic violence as well as sexual assault; and

WHEREAS, the City of Auburn will act as the lead applicant and will submit the grant application and request the maximum award of \$450,000.00, of which the City would receive \$30,000/year for three years totaling approximately \$90,000.00 in funding to be used towards the added efforts of supervision through the domestic violence follow-up initiative as well as the remaining funding to be granted to our partner agencies in order to strengthen programming, training and advocacy;

WHEREAS, the City of Auburn and its partners intend to submit a grant application to the US DOJ OVW for funding a domestic violence follow-up initiative program in the amount up to \$450,000 and authorization is needed to submit the application request.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Auburn, New York:

- 1. - 2. That, upon award notification, that the Mayor, or other appointed designee, is authorized to execute the Grant agreement and submit any and all documentation necessary for the Grant; and
- 3. That the City Comptroller is authorized to receive and appropriate grant funding into the appropriate departmental accounts; and
 - 4. That this resolution shall take effect immediately upon its adoption.
