- Work on the rail road tracks near the North Division St. Bridge will continue through this weekend. ## AWARD RESOLUTION #119 OF 2019 AWARDING A CONTRACT FOR A BIOSOLIDS DRYER EVALUATION STUDY

**WHEREAS**, the City of Auburn is experiencing substantial increases to its operating budget for removal of existing unstable sludge from the City of Auburn Wastewater Treatment Facility; and

WHEREAS, the City of Auburn has contracted with professional engineering firms to perform an evaluation of alternatives associated with additional sludge treatment options and found that the most cost effective alternative recommended is to conduct further feasibility analysis associated with sludge drying; and

**WHEREAS**, the treatment of sludge by means of drying will provide a Class A sludge which is much more cost effective to remove; and

WHEREAS, the City released a Request for Proposals (RFP) for the purpose of hiring a design firm who specializes in the implementation and study of sludge drying equipment; and

**WHEREAS,** on July 30, 2019 proposals were opened for bio-solids dryer evaluation study services, with submissions received from the following firms:

## COUNCIL RESOLUTION #120 OF 2019 ADOPTING AN AMENDED REVOLVING LOAN PROGRAM

**WHEREAS**, in 1997 the City of Auburn implemented a Sewer and Water Line Repair Program to provide a way for city residents to pay for the cost of repairs to their sewer lateral and/or water service; and

**WHEREAS**, under this Program, the cost of the work is placed onto the real property tax bill and paid over a five-year period at 6% interest; and

WHEREAS, City staff is recommending that the Program be modified to include City customers who are required to install appropriate backflow preventers; and

WHEREAS, under the State and Local laws, commercial businesses and certain residential properties are required to install, maintain, and test appropriate backflow prevention equipment, and the cost to do so can be substantial; and

**WHEREAS**, amending the Sewer and Water Line Repair Program will provide a way for property owners to finance the necessary work for backflow prevention so that they can be in compliance with the State and Local laws.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council does hereby authorize the Amended Revolving Loan Fund Sewer and Water Line Repair/Replacement Program, which is attached hereto and incorporated herein; and

**BE IT FURTHER RESOLVED** that this resolution shall take effect immediately.

**WHEREAS**, the existing agreement between the City and the County was last signed in 2016, and both parties would like to enter into the proposed Mutual Aid Assistance Agreement, attached hereto and incorporated herein; and

**WHEREAS**, The Cayuga County Legislature will review for approval, the attached Mutual Aid Agreement at a future Legislature meeting.

**NOW, THEREFORE, BE IT RESOLVED** that the Auburn City Council does hereby approve the Mutual Aid Assistance Agreement between the City of Auburn and the County of Cayuga, which is attached hereto and incorporated herein; and

**BE IT FURTHER RESOLVED** that the Mayor, City Manager and Chief of Police are authorized to sign any and all documents in order to finalize the agreement.

### **AGREEMENT RESOLUTION #122 OF 2019**

## AUTHORIZING A SETTLEMENT AGREEMENT AND MUTUAL RELEASE WITH SIEMENS INDUSTRY, INC

WHEREAS, on May 14, 2013, the City of Auburn entered into a Performance Contracting Agreement (the "PCA") with Siemens Industry, Inc. for the purpose of designing and installing equipment at the Mill Street Generation Facility (the "Mill Street Dam") that would allow for the generation and sale of hydroelectric power; and

WHEREAS, over the last seven years, the City has worked with Siemens to resolve various issues involved in automating and optimizing the equipment so that the parties could reach a point of substantial completion for the project; and

WHEREAS, as a part of the project completion, the parties have agreed to execute a Settlement Agreement and Mutual Release, which is attached hereto and incorporated herein; and

WHEREAS, this Settlement Agreement resolves all outstanding disputes between the parties and includes (a) a reimbursement to the City in the amount of \$10,564.65 for costs associated with SCADA and electrical work at the Mill Street Dam; (b) a payment to the City in the amount of \$70,000 for issues concerning meter service classification; and (c) a price adjustment to be credited to the City in the amount of \$12,000 for Year One of the performance assurance program; and

**WHEREAS**, the proposed Settlement Agreement would be in the best interests of all parties and would avoid further costs and litigation expense.

**NOW, THEREFORE, BE IT RESOLVED** that the Auburn City Council does hereby approve the following:

- 1) a Settlement Agreement and Mutual Release with Siemens Industry, Inc., which is attached hereto and incorporation herein; and
- 2) authorizing the City Comptroller to recognize the settlement agreement reimbursement and revenue into the City Budget Accounts entitled Power Utility Refunds (E99.2701) in the amount of \$10,564.65 and Power Utility Revenue (E99.2770) in the amount of \$70,000; and

**BE IT FURTHER RESOLVED** that the Mayor is authorized to sign any and all documents in order to carry out the foregoing settlement and this Resolution.
