AGREEMENT RESOLUTION #132 OF 2019

AUTHORIZING A RELEASE OF LEASE AGREEMENT WITH MAURICE I. SCHWARTZ TOWERS, INC

WHEREAS, on or about September 1, 1970, the City of Auburn entered into an Agreement (the "Agreement") with Maurice I. Schwartz Towers, Inc. ("Schwartz Towers") for the purpose of leasing approximately 4600 square feet of space at 90 North Street, Auburn New York (the "Leased Premises"); and,

WHEREAS, the Agreement included a payment of monthly rent by the City in the amount of \$668.66 over a fifty (50) year term ending on March 31, 2022, and is attached hereto for reference; and,

WHEREAS, the City and Schwartz Towers now wish to execute a Release of Lease Agreement, which is attached hereto and incorporated herein; and,

WHEREAS, the Release of Lease Agreement allows the parties to terminate the Agreement prior to the end of the term subject to the following:

- 1. The City agrees to vacate the rental premises on or before December 31, 2019;
- 2. The City agrees to pay rent in the amount of \$668.66 until June 30, 2020, unless Schwartz Towers finds another tenant prior to then; and
- 3. The City agrees to pay utilities for the premises in the amount of \$3,000 for the 2019 calendar year and \$500 for the 2020 calendar year;

and,

WHEREAS, the proposed Release of Lease Agreement would be in the best interests of all parties and would avoid further costs and expenses.

NOW, THEREFORE, BE IT RESOLVED that the Auburn City Council does hereby approve a Release of Lease Agreement with Maurice I. Schwartz Towers, Inc., which is attached hereto and incorporation herein; and

BE IT FURTHER RESOLVED that the Mayor, or his named designee, is authorized to sign any and all documents in order to carry out the foregoing settlement and this Resolution.
