FINANCIAL RESOLUTION #6 OF 2020

ADOPTING THE 2020 CAYUGA COUNTY TAX RATE AND CITY OF AUBURN SHARE OF THE CAYUGA COMMUNITY COLLEGE CHARGES

WHEREAS, the City of Auburn has been notified by the Cayuga County Legislature that, in accordance with Resolution #435-19, adopted by the County Legislature on December 12, 2019, the City of Auburn's participation in the 2020 County Tax will be in the amount of \$8,727,457.61 compared to last year's amount of \$8,804,788.20, a decrease of \$77,330.59. The full amount to be raised by property taxes in the entire County is \$41,525,905, that produces the City's share of the County tax levy is 21.02%; and

WHEREAS, the Cayuga County Legislature included within its Resolution #435-19 of 2019 charges to the City taxpayers for the collection of costs related to the preparation and mailing of County tax bills within the City in the amount of \$4,980.66; and

WHEREAS, the City of Auburn has been notified by the Cayuga County Legislature that, in accordance with Resolution #381-19, adopted by the County Legislature on November 26, 2019, the City of Auburn's proportionate share for the Cayuga Community College charges in the amount of \$170,529.31 is to be added to the 2020 County Tax to be raised from the City.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Auburn, New York hereby adopts the 2020 County Tax Rate in the City of Auburn in the amount of \$8.339814 per \$1,000 of assessed valuation for the City's share of the County tax, and \$0.162862 per \$1,000 of assessed valuation for the City's share of the Cayuga Community College charges for a total County tax rate of \$8.502676 per \$1,000, with an increase of \$0.000289 per \$1,000 over the 2019 rate; and

BE IT FURTHER RESOLVED that the Auburn City Council hereby adopts the 2020 County tax rate and authorizes the preparation of the necessary tax bills.
