Reports of City Officials

A. City Manager's Report

- The South Street reconstruction project is going well. The base coat of asphalt has been placed in the main travel lanes. The project is currently on schedule and within budget.
- The State Street Plaza project is progressing along. There have been some minor material delays but we expect work installing the hardscape to begin over the next week or two and the delivery and installation of precast fence panels to occur mid-October.
- The Public Safety Building Project is also moving along and a little bit of time was made up this week as contractors prioritized this project ahead of some others. This week epoxy coating was applied to the apparatus bays, concrete curbs were installed and much of the flat concrete work on the site outside of the building was installed.
- This week, staff met with surrounding towns and the Cayuga County Water and Sewer Authority in compliance with the requirements of our contracts. The meeting reviewed the completed wholesale metering project both operationally and financially. There was very little discussion and the project seems to be functioning as designed and was installed approximately 1/3 less expensive than originally anticipated due to some work being done in-house rather than contracted out.
- We have scheduled a presentation from the Cayuga County Water and Sewer Authority for the November 9 Council Meeting.
