WHEREAS, Dr. Phillip C. Gioia began his career as a practicing pediatrician in Auburn over 40 years ago; and

WHEREAS, in the early 1970s he began his education at Dartmouth College, Hanover, New Hampshire, Cum Laude with a distinction in mathematics; in June 1975 MD, Health Science Center, State University of New York, Syracuse, New York; in September 1976 Diplomat of the National Board of Medical Examiners; in April 1978 Licensed to practice medicine in the State of New York; in September 1980 Certified by the American Board of Pediatrics; in June 1981 Master of Public Health, Columbia University, School of Public Health, New York, New York; in February 1982 Certified by the American Board of Preventive Medicine in the area of Public Health; and, in December 2013 Certified in Clinical Informatics; and

WHEREAS, he opened his first pediatric practice at the old Mercy Hospital on May 7, 1981 and over the years relocated the practice to a house on Fulton Street, then an office on William Street, followed by building his Grant Avenue office in 1991 and finally in 2001 purchased and moved to the Health Central Building on W. Garden Street; and

WHEREAS, he has served in several notable capacities over the years including as a medical consultant to the Cayuga County Health Department, a fellow of the American Academy of Pediatricians, a fellow

of the American College of Preventative Medicine, as a Board Director of the Cayuga Community Health Network since its inception, as a delegate to the Medical Society of the State of New York, and has served multiple times as Chief of Pediatrics at Auburn Hospital, just to name a few; and

WHEREAS, he has been a pediatric on-call provider for Auburn hospital since 1981, taking calls, seeing newborns for their initial assessments, and evaluating emergent pediatric cases for the hospital for 40 years; and

WHEREAS, Dr. Phill Gioia has worked tirelessly for over four decades preventing disease, treating illness, and educating our community on healthy lifestyles and safe practices. He has put his heart and soul into practicing medicine and caring for children, from his kind, selfless, nonjudgmental, patient demeanor, to his astounding knowledge, expertise, and experience, the Auburn community has been so fortunate to have him take care of us and our children.
