City Manager Jeff Dygert: just a couple of quick updates. We've informed Council in the past three collective bargaining agreements that we continue to work on and just wanted to update you that all those discussions are going well. We continue to work on budget development. So, in the month of March and April, department heads will be before council to present their individual department budgets for your consideration. Next Monday, our staff will be having a riveting meeting related to all things trash. Pick-up, codes related to trash, the cost related to trash disposal and all of those things, so, that we can prepare a presentation for your consideration in the near future. Yesterday, staff had a meeting related to summertime city sponsored events and other events going on. Again, that's something that typically happens practically year round and we take a little bit of a break in the fall and the winter. But really, planning for a lot of those events takes all year round. This year there's some partnerships being had for a significant amount of programming around the Juneteenth weekend. So, that was a big thing that we worked on over the last couple of weeks in partnership with Auburn BID and the Chamber and a variety of other community organizations to get that up and going. It sounds like that's going well.

Councilor Cuddy discussed that he has been working with Superintendent of Public Works Mike Talbot on a new summer program for tennis for the youth of the city. More details will be forthcoming closer to summer.
