# **Reports of City Officials**

# City Manager's Report -

- Coronavirus State and Local Recovery Funds (CSLFRF) applications for expenditure category: negative economic impact, assistance to small business will go live on the City of Auburn webpage tomorrow, Friday, March 18 at 1pm. Eligible expense categories include grants to mitigate financial hardship, rehabilitation of commercial properties or other improvements, business incubators, and start up or expansion assistance, and enhanced support to microbusinesses. There is a maximum of \$40,000 per applicant and applications are due April 30. The application process is on-line only. If potential applicants have questions or need assistance, they should contact Daniel Szabo at the Cayuga Economic Development Agency (CEDA)>
- This week the city's Nuisance Abatement Committee recommended that the smoke shop located at 67 Franklin St. move onto to a hearing at the April meeting, based upon the amount of undesirable illegal activity occurring at that location. Related to this action, the Auburn Police Department obtained the following arrest warrants based on their recent raid of the business: For the owner of the business and separately for the business manager: an E Felony charge of Evading Cigarette Tax Law (over \$10k).
- Our latest NYS Sales Tax report came in this week showing a 24.58% increase over February of 2021. We are averaging about 20% over 2021.
- Notices for participation in the Auburn Community Solar Project and the associated 10% monthly electric discount should be going out to residents next week. Residents can also visit AuburnCommunitySolar.com to apply.
- On Monday 7 new recruit firefighters started training in-house at our fire department. Five of these positions are funded through the federal Staffing for Adequate Fire and Emergency Response (SAFER) grant. The cost of these positions is covered by the grant for three years with no city match. Due to lack of capacity at the NYS Fire Academy and a need to fill the positions in a timely manner, the Auburn Fire Department will be training the recruits in-house. In addition to our own recruits, our staff will be training 6 recruits from Oswego, 2 from Cortland and 1 from Manlius FD.
- The annual State of the City Update will take place virtually on Thursday, March 24 at 10am.

**WHEREAS,** on March 16, 2021, the City of Auburn issued a Request for Proposals (RFP) seeking a marketing firm capable of leading and executing marketing services for the Historic & Cultural Sites Commission and the NYS Equal Rights Heritage Center; and,

WHEREAS, a total of five responses were received from the RFP and a review committee of seven individuals made up of City staff, staff from the Auburn BID and members of the City's Historic and Cultural Sites Commission conducted a competitive review of all responses received; and,

WHEREAS, following the review, the review committee recommended to the City Council to retain the services of TGW Studio of 210 South Avenue, Suite 130, Rochester, NY; and,

WHEREAS, in December 2021, the City received notice that it had been awarded a \$300,000 grant from the New York State Empire State Development's Market NY Grant Program to provide

events and marketing services totaling \$400,000 for the Historic and Cultural Sites Commission and NYS Equal Rights Heritage Center; and,

WHEREAS, following a successful execution of the previous Market NY funded program, the Historic and Cultural Sites Commission would like to continue with the selected firm and retain the services of TGW Studio at an amount not to exceed \$365,000.00.

# NOW, THEREFORE, BE IT RESOLVED that:

- 1. The City Council does hereby authorize an agreement for marketing services for the Historic & Cultural Sites Commission and the NYS Equal Rights Heritage Center with TGW Studio of 210 South Avenue, Suite 130, Rochester, New York, for a period of time commencing immediately and ending no later than December 31, 2023, in an amount not to exceed \$365,000, to be charged to the designated account entitled ARPA Projects (Market NY) (#HA8760-440HSC); and
- 2. The Mayor is authorized to sign all documents required to execute services for this project.
