#### **CEREMONIAL PRESENTATIONS**

WHEREAS, historic preservation is an effective tool for managing growth and sustainable development, revitalizing neighborhoods, fostering local pride and maintaining community character while enhancing livability; and

WHEREAS, historic preservation is relevant for communities across the nation, both urban and rural, and for Americans of all ages, walks of life and ethnic backgrounds; and

WHEREAS, for the past thirty-one years the Community Preservation Committee has been made up of the people saving historically significant places in our community and we thank them for their dedicated service to Auburn.

Proclamation for Historic Preservation Month presented to Kathy Walker representing the Community Preservation Committee. Followed by a presentation from the Harriet Tubman National Historical Park, Ahna Wilson, Superintendent. Superintendent Wilson provided an update on the National Park Service project to restore the AME Zion church and parsonage on Parker Street in Auburn. Construction will begin immediately with the goal of completion by the end of summer 2023.

WHEREAS, travel has a critical role on New York State and the nation's economic prosperity; and

WHEREAS, a robust travel industry has provided significant economic benefits for the nation, generating more than \$2.0 billion in economic output in 2021, with \$910 billion spent directly by travelers in the U.S.; and

## AUTHORIZING A SECOND AMENDMENT TO THE RENTAL AGREEMENT WITH CAYUGA COMMUNITY COLLEGE

**WHEREAS**, the City owns a multipurpose facility located at 130 N. Division Street, Auburn, New York used for athletic and other functions named "Falcon Park"; and

WHEREAS, on October 11, 2018, the Auburn City Council passed Agreement Resolution #140 of 2018, which authorized a Rental Agreement with Cayuga Community College ("CCC") for the use of Falcon Park; and

WHEREAS, the Rental Agreement allows CCC to use Falcon Park for its collegiate sports teams including, baseball, softball, soccer and lacrosse, and, in exchange, the City receives rents to help cover the costs it incurred in renovating Falcon Park to make it a usable year-round, multi-purpose athletic complex; and

WHEREAS, at the time the Agreement was executed it was expressly agreed that all of the project costs were based upon estimates and that the terms of rent would be subject to adjustment based upon actual numbers received; and

**WHEREAS**, in 2019 the parties entered into a first Amendment for the sole purpose of adjusting the frequency of rental payments from annually to monthly; and

WHEREAS, now the parties would like to enter into a second Amendment for the purpose of adjusting the monthly rents set forth in Paragraph 3 to reflect the actual share of costs owed by CCC to the City; and

**WHEREAS**, the Board of Directors of CCC have agreed to the terms proposed in Amendment No. 2, which is attached hereto and incorporated herein.

**NOW, THEREFORE, BE IT RESOLVED** that the Auburn City Council does hereby approve Amendment No. 2 to the Rental Agreement with Cayuga Community College, which is attached hereto and incorporated herein; and

**BE IT FURTHER RESOLVED** that the Mayor, or his named designee, is authorized to sign any and all documents in order to carry out the purposes of this resolution.

## AUTHORIZING THE IMPLEMENTATION AND FUNDING FOR THE LAKE AVENUE BRIDGE REHABILITATION PROJECT- PIN 375693

**WHEREAS,** a Project for the Lake Avenue Bridge Rehabilitation over the Owasco River, BIN 2207050, in the City of Auburn for the Bridge NY 2021 Program, P.I.N. 375693 (the "Project") is eligible for funding under Title 23 US Code, as amended, that calls for the apportionment of the costs of such program to be borne at the ratio of 95% Federal Funds and 5% non-federal funds; and

WHEREAS, on December 15, 2021 the City of Auburn received a notice of award from the New York BRIDGE NY Program in the amount of \$4,662,410 towards the Lake Avenue Bridge Project which has an estimated total Project cost of \$4,907,800; and

**WHEREAS**, the City of Auburn will complete all design and inspection phases as well as award bids for construction of the Project; and

WHEREAS, the City of Auburn desires to advance the above Project by making a commitment of 100% of the first instance payments of the total project costs in the amount of \$4,907,800 for all Design Phases (I-VI), ROW Incidentals and Acquisition (if necessary), Construction, and Construction Supervision and Inspection phases for the Project.

**NOW, THEREFORE, BE IT RESOLVED,** that the City Council of the City of Auburn does hereby

**RESOLVE,** to approve the Project and authorizes the Mayor, or appointed designee, of the City of Auburn to pay 100% of the cost of all Design, ROW and Construction Phase work for the Project or portions thereof, with the understanding that qualified costs may be eligible for federal-aid, state-aid, or reimbursement from the Bridge NY funds; and it is further

**RESOLVED,** that the sum of \$4,907,800 is hereby made available from the City's General Fund to the Lake Avenue Bridge Capital Account (#HA 5110 440 KW) to cover the cost of participation in the above Phases of the Project, and it is further

**RESOLVED,** that the City of Auburn City Council hereby agrees that the City of Auburn shall be responsible for all costs of the project which exceed the amount of federal-aid, state-aid, or the NY Bridge Program funding awarded to the City of Auburn; and it is further

**RESOLVED**, that in the event the Project costs are not covered by federal-aid, state-aid, or NY Bridge funding of the project exceeds the amount appropriated above, the City of Auburn City Council shall convene as soon as possible to appropriate said excess amount immediately upon notification by the New York State Department of Transportation, and it is further

**RESOLVED,** that the City of Auburn hereby agrees that construction of the Project shall begin no later than twenty-four (24) months after award and that the construction phase of the project shall be completed within 30 months; and it is further

**RESOLVED,** that the Mayor, or appointed designee, of the City of Auburn be and is hereby authorized to execute all necessary agreements, certifications and reimbursement requests for federal-did and/ or state-aid with the New York State Department of Transportation in connection with the advancement or approval of the Project and providing for the administration of the Project and the City of Auburn's funding of Project costs and permanent funding of the local share of federal-aid and state-aid-eligible Project costs and all Project costs within appropriations therefore that are not so eligible; and it is further

**RESOLVED,** that a certified copy of this resolution be filed with the New York State Commissioner of Transportation by attaching it to any necessary agreement in connection with the Project, and it is further

**RESOLVED**, that this Resolution shall take effect immediately.

### AGREEMENT RESOLUTION #47 OF 2022 AUTHORIZING ENGINEERING SERVICES FOR DESIGN PHASES I –VI TO FOR THE LAKE AVENUE OVER OWASCO OUTLET BRIDGE REHABILITATION PROJECT

**WHEREAS**, on December 15, 2021 the City of Auburn was notified by the New York Department of Transportation that it had been awarded a Bridge NY 2021 grant in the amount \$4,662,410 for the rehabilitation of the Lake Avenue Bridge (the "Project"); and

WHEREAS, the Bridge NY 2021 grant provides 95% of the total estimated cost of the Project, which is \$4,907,800; and

WHEREAS, on May 5, 2022 the Auburn City Council passed an Agreement Resolution authorizing the Master Agreement and funding for the Lake Avenue over Owasco Outlet Bridge Rehabilitation Project (PIN 375693, D040626)); and

WHEREAS, this project is eligible for funding under Title 23 US Code, as amended, and the New York State Dept. of Transportation Bridge NY 2021 Program that calls for the apportionment of the costs of such program estimated at \$4,907,800 to be borne at the ratio of 95% Federal Funds and 5% non-federal funds; and

WHEREAS, the City Council authorized to approve the project and authorize the City of Auburn to pay in the first instance 100% of the all Project costs; and

WHEREAS, it is now necessary to obtain consulting services for the Design Phases (I-VI) for the Project; and

WHEREAS, after conducting the Consultant Selection Process, C&S Engineers was chosen as our Consultant to provide design, engineering, and construction inspection services for this project; and

WHEREAS, C&S Engineers has agreed to provide engineering services for Design Phases (I-VI) in the amount of \$550,000; and

WHEREAS, this amount is eligible for 95% Federal reimbursement (\$522,500).

**NOW, THEREFORE, BE IT RESOLVED** that C&S Engineers be retained to provide engineering services for the Design Phases (I-VI) for the Lake Ave over Owasco Outlet Bridge Rehabilitation Project for a sum of \$550,000.; and it is further

**RESOLVED,** that the City of Auburn shall be responsible to pay in the first instance 100% of the Federal and non-Federal share of the costs of Design Phases I-VI in the amount of \$550,000; and it is further

**RESOLVED,** that all eligible Design Costs shall be submitted for 95% Federal reimbursement; and it is further

**RESOLVED,** that the Mayor of the City of Auburn is hereby authorized to execute all necessary agreements, certifications, and reimbursement requests for Federal Aid and/or State Aid of behalf of the City of Auburn with the New York State Dept. of Transportation.

## AUTHORIZING A CHANGE ORDER TO CRANE-HOGAN STRUCTURAL SYSTEMS INC. FOR THE STATE STREET PUBLIC PLAZA

**WHEREAS,** on March 18, 2021, the City Council passed Award Resolution #37 of 2021, awarding Construction of the State Street Public Plaza to Crane-Hogan Structural Systems Inc. in the amount of \$1,133,113.50; and

**WHEREAS**, the City of Auburn was awarded funding for the buildout of the State Street Public Plaza in the amount of \$1 million through the Downtown Revitalization Initiative (DRI) Program on March 18, 2021 and \$178,114 from the Emerson Foundation were accepted by City Council on July 1, 2021; and

**WHEREAS**, Auburn City Council also authorized Bond Ordinance #3 of 2021, in the amount of \$400,000.00, to finance costs for the Project on March 18, 2021; and

WHEREAS, a Change Order in the amount of \$273,637.00 involving improvements to the State Street Corridor is now necessary to complete the project and extend the useful life of the State Street Corridor; and

WHEREAS, a project construction contingency budget of \$10,000 is necessary to cover field change requests during construction to be approved by construction administrator Bergmann Architects, Engineers, and Planners and the City of Auburn Staff; and

**WHEREAS**, City staff is recommending a total project change order of \$283,637.00 to complete the construction of the State Street Public Plaza Project; and

WHEREAS, the Change Order work will involve removal of pavers, replacement with exposed aggregate concrete in walkways and colored concrete in the roadway, landscaping improvements, and additional repairs and/or replacement of concrete sidewalks and brick pavers in the State Street Corridor; and

**WHEREAS**, the Department of Planning and Economic Development, Department of Municipal Utilities, and Bergmann have reviewed and support the cost and scope of Change Order; and

**NOW, THEREFORE, BE IT RESOLVED,** that the Auburn City Council does hereby award the Change Order in the amount of \$283,637.00 to Crane-Hogan Structural Systems Inc. for the State Street Public Plaza Project; and

BE IT FURTHER RESOLVED that the cost of the Resolution in the total

amount of \$283,637 is to be charged to the State Street Public Plaza capital account HA8672.440.SS; and

**BE IT FURTHER RESOLVED** that the Mayor is authorized to sign any and all documents necessary in reference to the award of this Change Order.

## AUTHORIZING A CHANGE ORDER TO POPLI DESIGN GROUP FOR THE STATE STREET PUBLIC PLAZA PROJECT

**WHEREAS**, on March 18, 2021, the Auburn City Council authorized Agreement Resolution #38 of 2021, which awarded Popli Design Group for professional services related to Construction Inspection Services for the State Street Public Plaza Project (the "Project") in the amount of \$45,000; and

WHEREAS, pursuant to Bond Ordinance #3 of 2021, the City Council of the City of Auburn authorized the expenditure of funds for the construction and inspection phases of the State Street Public Plaza Project; and;

WHEREAS, the Project scope of work was increased to include additional construction time associated with necessary repairs along the State Street Corridor and a change order to Popli Design Group is necessary to perform the required construction inspection services; and

**WHEREAS**, the Change Order to the Agreement with Popli Design Group in the amount of \$19,750.00 is now required to cover additional professional services costs for construction work extending through July 30, 2022 for the Project; and

**NOW, THEREFORE, BE IT RESOLVED** that the Auburn City Council does hereby award the Change Order, in the amount of \$19,750.00, to Popli Design Group for additional professional services related to the State Street Public Plaza Project; and
