- The Auburn Fire Department applied for the FY2021 Assistance to Firefighters Grant for the purchase of new emergency portable radios. The grant has been awarded \$219,122.72 in Federal funding for the project. This amount, along with the City's 10% match of \$21,912.25, brings the project total to \$241,035.00. This was the full amount the Fire Department requested.

GRANT RESOLUTION #93 OF 2022 AUTHORIZING THE APPLICATION TO THE U.S. DEPARTMENT OF TRANSPORTATION FOR THE 2022 BRIDGE INVESTMENT PROGRAM GRANT

WHEREAS, in June 2022 the U.S. Department of Transportation (DOT), Federal Highway Administration (FHWA) announced the availability of grant funding for three categories of Bridge Investment Program (BIP) funding opportunities; and

WHEREAS, through the U.S. Department of Transportation (DOT) requests for applications may be submitted for consideration by municipalities who are eligible to apply; and

WHEREAS, the City Manager's Office proposes to submit a funding application for the Replacement of Canoga Street Bridge over Owasco Outlet; and

WHEREAS the proposed project is estimated to cost \$6,000,000 with a local match requirement of 20% or \$1,200,000, consisting of a non-Federal cost-share; and

WHEREAS, since the City of Auburn does not currently have the funding to pay for 100% of the replacement of the Canoga Street Bridge it is necessary to obtain DOT grant funding assistance from the 2022 Bridge Investment Program (BIP).

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Auburn, New York:

- 1. That the Mayor, or appointed designee, is authorized to submit an application to the Bridge Investment Program for the Replacement of Canoga Street Bridge over the Owasco Outlet; and
- 2. That if awarded Bridge Investment Program funds, the Mayor or appointed designee is authorized to accept the grant funds and sign any and all agreements, documents and reimbursements in association with the grant project; and
- 3. That if awarded Bridge Investment Program (BIP) funds, the City Comptroller is authorized to issue a municipal serial bond and create a Revenue Account and Expenditure Account; and
- 4. That this resolution shall take effect immediately upon its adoption.
