CEREMONIAL PRESENTATIONS -

WHEREAS, twenty-one years ago this month, nearly three thousand innocent men, women, and children lost their lives in attacks meant to terrorize our Nation. America witnessed one of the darkest days it had seen in years; and

WHEREAS, today we pay tribute to loved ones, friends, family, fellow citizens, and all who died on September 11, 2001 out in the field in Southwestern Pennsylvania, in the steel of the twin towers of the World Trade Center, and the wreckage and flames of the United States Pentagon; and

Reports of City Officials

City Manager's Report –

- The city is accepting bids for Supervisory Control and Data Acquisition (SCADA) general services. Bids are due back September 23.
- The City is accepting bids for tree trimming, removal, and stump grinding services. Bids are due back Sept. 15.
- Testing of the raw water at the filtration plant has shown traces of microcystin. The Powder Activated Carbon System (PAC) is in operation and our finished water has been testing with no microcystin.
- A couple of weeks ago the water department responded to Standart Woods to investigate a high water consumption situation. During their investigation they discovered an unrelated but serious condition with a sanitary sewer main in the area. A significant portion of sewer main along the brook had been exposed by erosion and exists in an unstable position. Our crews are working to replace and relocate the main while coordinating with the County Soil and Water Authority to restore and fortify the washed away bank area.

• Councilor Cuddy reported that he had participated in review of applications from non profit organizations in the City for funding allocated as part of the City's American Rescue Plan Act (ARPA) funding. The City staff involved had the process very well organized.

COUNCIL RESOLUTION #95 OF 2022 SUPPORTING THE REDEVELOPMENT OF THE OLYMPIA TERRACE APARTMENT COMPLEX

WHEREAS, in 1948 the Auburn Housing Authority was created by the City of Auburn in order to promote adequate, affordable housing, economic opportunity and a suitable living environment free from discrimination; and

WHEREAS, the Auburn Housing Authority owns and manages the 50-unit Olympia Terrace public housing complex, which has served low and moderate income households in the City of Auburn since it was constructed in 1980; and

WHEREAS, Olympia Terrace is in need of substantial rehabilitation if it is going to continue to provide low and moderate income households in the City of Auburn with safe, adequate, and affordable housing; and

WHEREAS, Olympia Terrace plays a central role in meeting the demand for affordable housing in the City of Auburn and the community desires that Olympia Terrace be rehabilitated in lieu of developing affordable replacement housing; and

WHEREAS, rehabilitation will improve safety, enhance the neighborhood, and improve the overall quality of life for the residents of Olympia Terrace while ensuring a stable stock of affordable housing in the City of Auburn; and

WHEREAS, the City Council, by separate resolution, has authorized a 40-year PILOT Agreement to ensure that Olympia Terrace is economically viable and to promote affordable housing in the City of Auburn.

NOW THEREFORE, BE IT RESOLVED that the City Council supports the efforts of the Auburn Housing Authority and AHA Development Corporation to secure State assistance in furtherance of the Olympia Terrace redevelopment effort; and

BE IT FURTHER RESOLVED, that the redevelopment of Olympia Terrace is consistent with and fulfills objectives set forth in the City of Auburn's Community Development Block Grant Five Year Consolidated Plan, Community Development Block Grant Annual Action Plan, and the Comprehensive Plan.

COUNCIL RESOLUTION #96 OF 2022

AUTHORIZING THE EXECUTION OF A PAYMENT IN LIEU OF TAX ("PILOT")
AGREEMENT BY AND AMONG THE CITY OF AUBURN, OLYMPIA TERRACE HOUSING
DEVELOPMENT FUND COMPANY, INC. AND OLYMPIA TERRACE LIMITED
PARTNERSHIP AND AUTHORIZING THE CONVEYANCE OF THE PROPERTY (AS
DEFINED HEREIN) BY THE AUBURN HOUSING AUTHORITY

WHEREAS, the City of Auburn (the "City") desires to encourage a sufficient supply of adequate, safe and sanitary dwelling accommodations properly planned for persons of low-income; and

WHEREAS, Olympia Terrace Limited Partnership, a New York limited partnership (the "Partnership"), and Olympia Terrace Housing Development Fund Company, Inc., a New York not-for-profit corporation formed pursuant to Article XI New York State Private Housing Finance Law (the "HDFC"), have identified property located at 2 Olympia Avenue, City of Auburn, County of Cayuga, State of New York, as described in Exhibit "A" attached hereto (the "Property"), for the purpose of rehabilitating a current housing development known as Olympia Terrace (the "Project"), containing fifty (50) dwelling units, with the intent to preserve and maintain adequate and sanitary affordable housing for persons of low-income in the City; and

WHEREAS, the Partnership has been formed for the purpose of providing residential rental accommodations for persons of low-income; and WHEREAS, the HDFC will acquire fee title to the Property, as nominee for the Partnership, and will convey its equitable and beneficial interests in the Property to the Partnership in furtherance of the development and rehabilitation of the Project; and

WHEREAS, the HDFC's and the Partnership's plan for the use of the Property constitutes a "housing project" as such term is defined in the Private Housing Finance Law of the State of New York ("PHFL"); and

WHEREAS, the HDFC is a "housing development fund company" as the term is defined in Section 572 of the PHFL, and Section 577 of the PHFL authorizes the City Council to exempt the Project from real property taxes; and

WHEREAS, the HDFC is, or will be, on the commencement date of the PILOT Agreement contemplated herein, the general partner of the Partnership; and

WHEREAS, the Partnership and the HDFC will be willing to enter into a PILOT Agreement whereby they will make annual payments in lieu of taxes to the City as set forth in the PILOT Agreement presented to this City Council for approval; and

WHEREAS, in accordance with the terms and provisions of Section 58-b of the Public Housing Law of New York State, a sale or lease by a housing authority of all or a portion of a 2 project in order to obtain the benefits of any Federal program of assistance for low-income housing is subject to the approval of the local legislative body.

NOW THEREFORE, BE IT RESOLVED that the City Council hereby (i) exempts the Project from real property taxes to the extent authorized by Section 577 of the PHFL, (ii) approves the proposed PILOT Agreement by and among the City, the Partnership and the ``HDFC, in substantially the form presented at this meeting, providing for annual payments as set forth in such agreement and (iii) approves of the conveyance of the Property and the Project from Auburn Housing Authority to the HDFC; and

BE IT FURTHER RESOLVED, that the Mayor of the City is hereby authorized to execute and deliver the foregoing PILOT Agreement on behalf of the City; and

BE IT FURTHER RESOLVED, that this resolution shall take effect immediately.
