Reports of City Officials

City Manager's Report -

- The city is accepting bids for Supervisory Control and Data Acquisition (SCADA) general services. Bids are due back September 23.
- The city is also accepting proposals for the demolition of three buildings at 145 Grant Ave. These proposals are due back Sept. 23. More details on these Bids and RFPs is available on the City webpage under the tab "Bids/RFPs."
- Testing of the raw water at the filtration plant has shown high levels of microcystin over the past few days. The Powder Activated Carbon System (PAC) is in operation and our finished water has been testing with no microcystin. Seth Jensen, our Director of Municipal Utilities provided some more detail about our current status. Councilor Cuddy asked for copies of the drinking water sample testing reports.
- Wednesday, we conducted our monthly meeting of the City Nuisance Abatement Committee. The committee reviewed 25 properties that have received complaints from neighbors, including four new additions. The committee also agreed to remove about four properties that had addressed their issues and received no further complaints for about six months. The committee agreed to move two properties onto a hearing based upon continued complaints and/or the outcome of other legal proceedings. The smoke shop at 67 Franklin St. and a rental property at 64 Grant Ave will be the topic of these hearings.
- Paving of E. Genesee Street and John Street will begin in October. This is a project that includes storm sewer installations and replacements. This will require John Street to be closed to vehicular traffic for much of the month of October. Project information is available on the City website.

LAND SALE RESOLUTION #100 OF 2022 AUTHORIZING THE SALE OF REAL PROPERTY KNOWN AS 197 STATE STREET

WHEREAS, the Property is approximately .54 acres and consists of a commercial building and adjoining parking lot; and

WHEREAS, Housing Vision Consultants, Inc., has offered to purchase the Property by way of a Purchase Offer and Sale Contract, which is attached hereto and incorporated herein; and

WHEREAS, as consideration for this purchase, Housing Vision Consultants is proposing to invest \$5.6m into renovating the Property, which would create sixteen (16) one bedroom apartments together with community space; and

WHEREAS, the Property is a surplus parcel and not needed for City purposes.

NOW, THEREFORE, BE IT RESOLVED that the City of Auburn does hereby approve the Purchase Offer and Sale Contract from Housing Vision Consultants, Inc., which is incorporated herein, for the sale of 197 State Street, subject to the following additional terms and conditions:

- (1) That the City provides only a Quit Claim Deed to the buyers at closing;
- (2) That the buyers be responsible for payment of all title and closing costs;
- (3) That the Deed include a condition that the renovation of the Property be completed on or before December 31, 2026, or the title shall automatically revert back to the City; and,

BE IT FURTHER RESOLVED that the Mayor is authorized to sign any and all documents in order to finalize the closing of this real estate transaction.

WHEREAS, the City of Auburn desires to continue supporting projects identified in the 2019 Auburn DRI Strategic Investment Plan and the recent redevelopment and investment in the East Hill commercial area of the Auburn Downtown Business Improvement District; and

WHEREAS, the building and property at 22 E. Genesee Street was identified as a transformative project in the Auburn DRI Plan and is located in the East Hill commercial area with the potential to attract residents and new commercial enterprises to downtown; and

WHEREAS, Empire State Development (ESD) has released a Request for Proposals under Round 6 of the Restore NY Communities Initiative Grant Program for which municipalities are eligible to apply; and

WHEREAS, the proposed rehabilitation project at 22 E. Genesee Street also aligns with goals outlined in the City Comprehensive Plan, *Building a Sustainable Auburn*, such as 1) Boosting Downtown to support the rehabilitation of historic buildings, 2) Revitalizing Neighborhoods to encourage the reuse of existing historic buildings and 3) Shaping Business Growth Across Auburn to encourage sustainable development principles and practices; and

WHEREAS, the City of Auburn is requesting \$1,750,000 in funding assistance from the Restore NY Communities Initiatives program towards the rehabilitation of the mixed-use building at 22 E. Genesee Street that has a total anticipated project cost of \$2,575,000; and

WHEREAS, R&M Associates LLC, owner of the property at 22 E. Genesee Street, will make available the required application fee and matching funds commitment as well as any fees associated with the ESD Incentive Proposal or Grant Disbursement Agreement; and
