A. State Environmental Quality Review Act Resolutions (SEQR) -SEQRA RESOLUTION #4 OF 2022

DECLARING TYPE II ACTIONS UNDER SEQRA FOR HOOPES PARK IMPROVEMENT PROJECT

WHEREAS, the City intends to undertake maintenance, repair, and rehabilitation improvements at Hoopes Park including, but not limited to, dredging the pond, and repair to the pond wall and outlet control structure; and

WHEREAS, the City desires to comply with the New York State Environmental Quality Review Act (the "SEQR Act") and the regulations adopted pursuant thereto by the Department of Environmental Conservation of the State of New York, being 6 NYCRR Part 617, as amended (the "Regulations"), with respect to the project; and

WHEREAS, Section 617.5 of the Regulations establishes a list of Type II actions that have been determined not to have a significant impact on the environment and are not subject to further review; and

WHEREAS, § 617.5 (c) 1 states "maintenance or repair involving no substantial changes in an existing structure or facility"; and § 617.5 (c) 2 "replacement, rehabilitation or reconstruction of a structure or facility, in kind, on the same site, including upgrading buildings to meet building or fire codes, unless such action meets or exceeds any of the thresholds in Section 617.4".

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Auburn that:

- 1. The proposed action corresponds with the parameters identified in § 617.5 (c) 1 and § 617.5 (c) 2 of the Regulations; and
- 2. The Hoopes Park Improvements Project constitutes a "Type II Action" under 6 NYCRR § 617.5 and no further action under the SEQR Act and the Regulations is required; and
- 3. This resolution shall take effect immediately.

ORDINANCE #3 OF 2022

REPEALING AND REPLACING CHAPTER 254 ENTITLED "SOLID WASTE"

Motion by Councilor Locastro

WHEREAS, on March 28, 1991, the Auburn City Council enacted and established the Ordinance which adopted Chapter 72 of the Auburn City Code, which is now Chapter 254 of the City Code, entitled "Solid Waste"; and

October 20, 2022

WHEREAS, in light of the closure of the City of Auburn Landfill and the new operation of the City of Auburn Transfer Station, and a renewed focus on keeping the City clean for the health and benefit of residents, City staff recommends an update and revision to City Code Chapter 254; and

WHEREAS, City recommends repealing the existing City Code, Chapter 254, entitled "Solid Waste," and replacing with the updated Chapter 254, also entitled "Solid Waste, which is attached and incorporated herein.

NOW, THEREFORE, BE IT ORDAINED that the Auburn City Council does hereby repeal Chapter 254 in its entirety, passed on March 28, 1991, which was originally adopted as Chapter 72 of the City Code; and

BE IT FURTHER ORDAINED, that the Auburn City Council does hereby adopt Ordinance #3 of 2022 as Chapter 254 of the Auburn City Code entitled "Solid Waste"; and

BE IT FURTHER ORDAINED, that the Auburn City Council hereby directs codification of Chapter 254 of the Auburn City Code entitled "Solid Waste"; and

BE IT FURTHER ORDAINED that the foregoing repeal and adoption of this shall take effective immediately upon adoption.

LAND SALE RESOLUTION #112 OF 2022 AUTHORIZING THE SALE OF REAL PROPERTY KNOWN AS 67 BARBER STREET

WHEREAS, on October 30, 2017, the City of Auburn acquired title to real property commonly known as 67 Barber Street (the "Property") by tax foreclosure; and

WHEREAS, the Property is approximately .22 acres and consists of a vacant lot; and

WHEREAS, an adjacent property owner, Domingo Santiago, has proposed a Purchase Offer and Sale Contract, which is attached hereto and incorporated herein, for the purchase of the Property at a price of Six Hundred Dollars (\$600) together with payment of all title and closing costs; and

WHEREAS, pursuant to the City's Land Sale Policy, all adjacent property owners have been notified of this purchase offer and have not expressed any interest or concern; and

WHEREAS, the Property is a surplus parcel and not needed for City purposes.

NOW, THEREFORE, BE IT RESOLVED that the City of Auburn does hereby approve the Purchase Offer and Sale Contract from Mr. Domingo Santiago, which is incorporated herein, for the sale of 67 Barber Street, for the sum of \$600, on the conditions that the City provide only a Quit Claim Deed at closing, that the buyer pay all title and closing costs, and, subject to the remaining conditions and terms set forth therein; and

BE IT FURTHER RESOLVED that the Mayor is authorized to sign the Purchase Offer and Sale Contract together with any and all documents in order to finalize the closing of this sale.
