## **Reports of City Officials**

## City Manager's Report -

- Municipal Utilities (John West) MU staff spoke with Eileen O'Connor at the Health Department earlier this week, and we are done with the HAB sampling for the season unless we see something in water that concerns us. Our internal sampling is showing the HAB activity winding down. We will continue to treat the water with carbon for another week and possibly shut the system down at that time. We will keep you updated if anything changes.
- Tree Planting DPW For spring and fall plantings this year, there were 175 trees planted, with the spring planting focused on the west side of town, and the fall planting was a little more wide spread. Both plantings we did try to target the areas that we removed a lot of ash trees. CDBG The CDBG Tree Planting program, with the services of a contractor, is in the process of planting 100 trees in the Standart Avenue area. Engineering Volunteers planted 26 Trees on Road Program Streets. In addition 34 more will be planted as follows: South Street (6), West Garden St. (5), Perrine St. and Lansing St. (21), and, St Francis Playground (2). Also, 30 Trees to be planted by CSI as part of the Sidewalk programs and 15 trees to be planted by Vitale with Road Program. This makes a TOTAL of 380 TREES!
- Fall Clean Up Days at the City Transfer Station were a success again this year. (see attached summary sheets)
- AFD Station 1 functioned as a polling place on Tuesday. Members worked to ensure citizens had what was needed (water, chairs, etc.) as they waited in line to vote.
- AFD Two Platoons started NYSOFPC Confined Space Rescue Training this week. The members completed training on their two days shifts this week and will complete the training on their two day shifts next week. The Fire Department is not only the Confined Space Rescue Team for all City Departments, but also provides that service for several area industrial, manufacturing and utility businesses.

#### **LOCAL LAW #3 OF 2022**

# REPEALING AND REPLACING SECTIONS OF CHAPTER 178 OF THE AUBURN CITY CODE ENTITLED "HISTORIC PRESERVATION"

WHEREAS, on March 28, 1991, the Auburn City Council enacted and established Local Law No. 2-1991 as Chapter 178 of the Auburn City Code entitled "Historic Preservation," pursuant to New York State Municipal Home Rule Law Section 10(1)(ii)(a)(11); and

**WHEREAS**, on April 6, 2017, the Auburn City Council enacted and established Local Law No. 1-2017 repealing and replacing Chapter 178 of the Auburn City Code entitled "Historic Preservation"; and

WHEREAS, the Historic Preservation Chapter created the Historic Resources Review Board "HRRB" and empowers the same to review applications of property owners to determine the historical appropriateness of certain proposed changes to the exterior of a structure; and

WHEREAS, the HRRB, after a public hearing, shall administratively issue or deny a Certificate of Appropriateness to an applicant allowing or prohibiting the proposed changes; and

WHEREAS, certain sections of the Historic Preservation Chapter regarding the procedure by which an aggrieved applicant may appeal a decision of the HRRB are not in keeping with the procedure and custom all other City Boards and relief made available by the New York State Civil Practice Laws and Rules; and

WHEREAS, it is necessary for the purposes of efficiency and clarity to make uniform the sections of the City Code which allow for an applicant to exhaust his or her administrative remedies at the city board level; and

WHEREAS, it is possible to achieve such uniformity by amending the language in the relevant sections of Chapter 178 of the City Code to conform with the relevant sections of the City Code regarding the other various boards of the City of Auburn; and

**WHEREAS**, Local Law No. 3 of 2022, attached hereto and incorporated herein, proposes to update Chapter 178 of the City Code to achieve such uniformity; and

**WHEREAS**, the passage of Local Law No. 3 of 2022, is categorized as a Type II Action pursuant to the New York State Environmental Quality Review Act (SEQRA) and New York State Code, Rules, and Regulations Sections 617.5(c)(16), and, therefore, pursuant to NYCRR Section 617.3(f) a determination under SEQRA is not required; and

**WHEREAS**, subject to City Council approval, a public hearing will be held on November 1, 2022, concerning the repealing of sections of Local Law No. 1-2017 and the enactment of Local Law No. 3 of 2022.

**NOW, THEREFORE, BE IT ENACTED** that the Auburn City Council does hereby repeal the following sections of Local Law No. 2-1991, which was originally passed as Chapter 44 of the City Code entitled "Historic Preservation:"

- 1. Section 178-13
- 2. Section 178-18

and,

**BE IT FURTHER ENACTED** that the Auburn City Council does hereby adopt Local Law No. 3 of 2022 attached and incorporated herein, which replaces the following Sections of Chapter 178 of the Auburn City Code entitled "Historic Preservation":

- 1. Section 178-13
- 2. Section 178-18

and,

**BE IT FURTHER ENACTED** that the foregoing repeal and adoption shall take effect immediately upon the filing of a certified copy of the local law with the New York Secretary of State.

## **CHAPTER 178 HISTORIC PRESERVATION**

## § 178-13 Certificate of appropriateness public notice requirements and approval.

## D.

Denial or delay of certificate; appeal to City Council. If the Board determines that a certificate of appropriateness should not be issued, or that a delayed certificate or a certificate contingent upon specific structural performance should be issued, the Board shall notify the applicant in writing of such determination. Such notice shall advise the applicant of his or her right to appeal such determination to the City Council in accordance with the appellate provisions contained in § 178-18.

#### E.

Building permits not to be granted without certificate. Unless the action of the Board is reversed by the City Council or a court of competent jurisdiction, the Building Inspector shall refuse to grant a building permit, sign, demolition permit or other permit for any historic landmark or district where a certificate of appropriateness has been denied or has expired due to the applicant's failure to commence work as described in Subsection  $\underline{\mathbb{C}}$ .

## § 178-18 Appeals.

Any person aggrieved by a ruling or determination of the Board may appeal to the City Council, which may reverse or affirm the action of the Board or remand to the Board with instructions. In ruling upon an appeal, the Council must consider the same evidence and be guided by the same criteria as used by the Board in rendering its decision. A decision to reverse the Board's action will require the affirmative vote of a majority of the City Council members. The decision of the Historic Resources Review Board shall be immediately filed in the office of the City Clerk and be a public record. The Historic Resources Review Board's decision shall constitute the exhaustion of an aggrieved applicant's administrative remedies.
