AUTHORIZING ACCEPTANCE OF A GRANT THROUGH THE NYSERDA CLEAN ENERGY COMMUNITIES PROGRAM

WHEREAS, as a result of the application to NYSERDA, the City of Auburn has been awarded a grant in the sum of \$5,000, to be utilized toward the LED replacement project at the Slow Sand Filter Building; and
