## **AGREEMENT RESOLUTION #69 OF 2023**

# AUTHORIZING AN AGREEMENT WITH THE DOWNTOWN BUSINESS IMPROVEMENT DISTRICT FOR THE OPERATION OF THE NYS EQUAL RIGHTS HERITAGE CENTER

**WHEREAS**, the City has an established partnership with the Auburn Downtown Business Improvement District (BID) for the operation of the NYS Equal Rights Heritage Center ("ERHC"), which has been successful since the center's opening in 2018; and

**WHEREAS**, the existing agreement for operations of the NYS ERHC between the City and the BID expires on June 30, 2023; and

**WHEREAS**, the City and the BID now propose the attached Agreement for continued operations of the NYS ERHC, which is attached hereto and incorporated herein; and

**WHEREAS**, the term of the proposed Agreement is from July 1, 2023, through June 30, 2024, and provides for an ERHC operations budget of \$215,000, and a Historic and Cultural Sites Commission budget of \$30,000 which are both allocated in the City budget's Equal Rights Heritage Center Account (A1621-440); and

**WHEREAS**, the attached agreement will become effective upon approval of the BID Board of Directors.

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Auburn hereby approves an Agreement with the Auburn Downtown BID for services related to operating the New York State Equal Rights Heritage Center and providing administrative support for the City's Historic and Cultural Sites Commission for a term commencing on July 1, 2023, and ending on June 30, 2024, together with all of the terms and conditions set forth in the Agreement, which is attached hereto and incorporated herein; and

**BE IT FURTHER RESOLVED** that the City Council of the City of Auburn hereby authorizes the City Comptroller to make payment to the Downtown BID as outlined in the Agreement; and

**BE IT FURTHER RESOLVED** the City Council approves of any remaining funds from the BID/ERHC operations agreement of the 2022-23 fiscal year be carried over and used for operations of the ERHC in fiscal year 2023-24; and

**BE IT FURTHER RESOLVED** that the City Council of the City of Auburn hereby authorizes the Mayor or designated representative to sign the Agreement with the Downtown BID, and any and all documents necessary to carry out this Resolution.

# AGREEMENT RESOLUTION #70 OF 2023 FOR THE SALE OF A 2018 FORD F150 XL TRUCK TO THE AUBURN BUSINESS IMPROVEMENT DISTRICT (BID)

**WHEREAS**, The City of Auburn desires to enter into an agreement with the Auburn Business Improvement District (BID) for the sale of a 2018 Ford F150 XL truck, having 37,344 miles and a VIN of 1FTMF1E58JKF30393 currently owned by the City of Auburn; and

**WHEREAS** The City of Auburn has determined that this vehicle is no longer necessary for the operations of the City of Auburn; and

WHEREAS, The sale of this vehicle will assist the operations of the Auburn Business Improvement District (BID) and thereby in return benefit the citizens of Auburn, NY; and

WHEREAS, The City of Auburn and the Auburn Business Improvement District (BID) have reached a proposed agreement for the sale of the 2018 Ford F150 XL truck for a sale price of twenty thousand dollars (\$20,000.00) to be paid at the rate of five thousand dollars (\$5,000.00) per year for four (4) years with the first payment commencing on July 31, 2024 and continuing thereafter until the balance is paid; and

**WHEREAS**, the City of Auburn will also take possession of a 2007 Chevrolet C1500 truck, having 45,720 miles and a VIN of 1GCEC14X37Z614766 currently owned by the Auburn Business Improvement District (BID) as part of this agreement; and

**WHEREAS**, the foregoing is in keeping with the City of Auburn procurement and surplus property policies; and

**NOW, THEREFORE, BE IT RESOLVED** that the Auburn City Council adopts Resolution #70 of 2023 authorizing the sale of a 2018 Ford F150 XL truck VIN# 1FTMF1E58JKF30393 from the City of Auburn to the Auburn Business Improvement District.

**BE IT FURTHER RESOLVED** that the Mayor is authorized to sign any and all documents necessary in reference to this sale of surplus property.
