City Manager's Report -

- The city of Auburn Civil Service Office has announced the following exams:
 - Police Officer Entry Level Exam Sept. 9, must sign up by Aug. 10
 - Keyboard Specialist Exam Aug 26, must sign up by July 28
- Last week we were notified of another successful grant application. The city has been awarded \$900k from the NYSDOH under the Lead Service Line Replacement Program. Our application was ranked number 2 in NYS.
- This week we were notified of an additional \$2.565m in funding to replace the Aurelius Ave. Bridge. This brings our total funding to about \$8.1m of the estimated \$10-11m project.
- Staff is compiling an update on our use of NYS Touring Route funds to date, as well as allowable uses for funds moving forward. We are planning a work session with Council July 27 to discuss the use remaining funds. Staff will present some identified projects and answer Council questions related to potential application of the funds.

GRANT ACCEPTANCE RESOLUTION #74 OF 2023

AUTHORIZING THE ACCEPTANCE OF NYS DIVISION OF CRIMINAL JUSTICE SERVICES (DCJS) FUNDING UNDER THE 2023-24 GUN VIOLENCE ELIMINATION (GIVE) INITIATIVE PROGRAM

WHEREAS, the New York State Division of Criminal Justice Services (NYS DCJS) established a program entitled the "*Gun Involved Violence Elimination (GIVE) Initiative*" with the purpose of providing state funding to local law enforcement agencies for equipment, overtime, personnel, as well as focused training and technical assistance; and

WHEREAS, the Cayuga County GIVE Partnership, a task force consisting of the Auburn Police Department and various Cayuga County agencies, applied for and were awarded funding under the NYS DCJS 2023-24 GIVE Initiative; and

WHEREAS, the Auburn Police Department has been awarded \$121,277 to cover over-time and equipment costs associated with implementing the GIVE Initiative with no local match required over the 1-year grant period starting July 1, 2023; and

WHEREAS, the City of Auburn, NY needs to accept the grant funding and execute all necessary documents in connection therewith prior to commencing the GIVE Initiative.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Auburn, New York, hereby accepts grant funding from the NYS DCJS GIVE Initiative in the amount of \$121,277 to cover equipment and overtime expenses for the Auburn Police Department for a period of one year beginning July 1, 2023; and

BE IT FURTHER RESOLVED, that the City Comptroller is authorized to recognize grant revenue in the amount of \$121,277 into revenue account A99 359 GIVE and to appropriate the funds into the Police Department accounts A3120 150 GIVE and A3120 440 GIVE; and

BE IT FURTHER RESOLVED, that the Mayor of the City of Auburn, or designated representative, is authorized to execute the grant agreement and all other documents necessary for the acceptance of the funding and otherwise act on all matters related to the GIVE Initiative.
