LOCAL LAW #1 OF 2023

AMENDING SECTIONS OF THE "HOUSING STANDARDS" CHAPTER OF THE AUBURN CITY CODE

WHEREAS, On March 28, 1991, by Local Law No. 2 of 1991, the City Council of the City of Auburn adopted Ch. 27 of the 1991 Code of the City of Auburn entitled "Housing Standards"; and

WHEREAS, Section 182-75 of the Housing Standards chapter provides direction for judicial review of governmental acts made thereunder; and

WHEREAS, it is optimal for the purposes of efficiency, clarity and certainty that the Housing Standards Chapter and provide an avenue for grievances to be heard administratively; and

WHEREAS, the City of Auburn Nuisance Abatement Committee meets regularly, holds administrative hearings and maintains general subject matter jurisdiction over housing matters; and

WHEREAS, Local Law No. 1 of 2023, attached hereto and incorporated herein, proposes to update Chapter 182 of the City Code to achieve such goals by adding an administrative appellate process to the Housing Standards Chapter and placing the same within the purview of the Nuisance Abatement Committee; and

NOW, THEREFORE, BE IT ENACTED that the Auburn City Council does hereby repeal the following sections of Local Law No. 2 of 1991, "Housing Standards"

1. Section 182-75

and,

BE IT FURTHER ENACTED that the Auburn City Council does hereby adopt Local Law No. 1 of 2023 attached and incorporated herein, which replaces the following Sections of Chapter 182 of the Auburn City Code entitled "Housing Standards":

1. Section 182-75

and,

BE IT FURTHER ENACTED that the foregoing repeal and adoption shall take effect upon its filing with the New York Secretary of State.

§ 182-75 Administrative and Judicial review.

- a) Any person or persons jointly or severally aggrieved by any final order or administrative fee issued or imposed by the Housing Code Inspector may seek to have such order reviewed by the Supreme Court in the manner prescribed by Article 78 of the Civil Practice Law and Rules and as otherwise provided for in the laws of the State of New York seek an administrative review of the same before the Nuisance Abatement Committee.
- b) The aggrieved party shall initiate an administrative review by submitting a written request for administrative review to the Office of the City Manager along with a copy of the order or fee notice seeking to be appealed from within 14 days of receipt of the same.
- c) The Nuisance Abatement Committee shall meet on a quarterly basis to hear appeals, at which time the aggrieved party or their counsel shall be granted the opportunity to present arguments on his or her own behalf to the Nuisance Abatement Committee.
- d) Pursuant to the City Code of Auburn section §213-5 the Nuisance Abatement Committee shall possess the authority to make a determination as to reverse, modify, or affirm the final order or administratively imposed fee of the Housing Code Inspector.
- e) Any person or persons jointly or severally aggrieved by any final order of the Nuisance Abatement Committee shall be deemed as exhausting all available administrative remedies and may seek to have such order reviewed by the Supreme Court in the manner prescribed by Article 78 of the Civil Practice Law and Rules and as otherwise provided for in the laws of the State of New York.

GRANT ACCEPTANCE RESOLUTION #75 OF 2023

AUTHORIZING ACCEPTANCE OF A GRANT FOR A LEAD SERVICE LINE INVENTORY

WHEREAS, the City of Auburn's water system serves approximately 26,866 Auburn residents with around 8,800 service connections; and

WHEREAS, in August 2022 the City of Auburn applied for the 2022 Bipartisan Infrastructure Law Lead Service Line Replacement funding through the Drinking Water State Revolving Fund for funding for a Lead Service Line Inventory; and

WHEREAS, the project will identify and locate all the unknown lead service lines in the city and use this information to create a lead service line inventory; and

WHEREAS, as a result of the application to the New York State (NYS) Department of Health (DOH), the City of Auburn has been awarded a grant in the sum of \$917,988.00; and

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Auburn, hereby accepts grant funding from the NYS DOH in the amount of \$917,988 for the Lead Service Line Inventory; and

BE IT FURTHER RESOLVED that the City Comptroller is authorized to recognize grant revenue in the amount of \$917,988 to revenue account HF99.280.LSL and to appropriate the funds into the Lead Service Line Replacement Project, capital account No. HF8340.440.LSL; and

BE IT FURTHER RESOLVED that the Mayor of the City of Auburn, or a designated representative, is authorized to execute the grant contract and all other documents necessary for the acceptance of the grant, and otherwise act on all matters related to the grant.

GRANT RESOLUTION #76 OF 2023

AUTHORIZING A NON-AGRICULTURAL NONPOINT SOURCE PLANNING GRANT APPLICATION TO NEW YORK STATE DEPARTMENT OF ENVIRONMENTAL CONSERVATION

WHEREAS, in May 2023, the Office of the Governor of New York announced the availability of water quality grant funding for non-agricultural and nonpoint source planning projects; and

WHEREAS, through the New York Consolidated Funding Application (CFA) the Department of Environmental Conservation (NYS DEC) has released request for proposals for non-agricultural and nonpoint source planning projects, for which municipalities are eligible to apply; and

WHEREAS, the Department of Municipal Utilities proposes to submit a grant application for a Subwatershed Comprehensive Stream Corridor Assessment Project, a subset category of the non-agricultural and nonpoint source grant program; and

WHEREAS, if awarded, the grant will provide for a focused assessment of the Owasco Lake Subwatershed which contains Veness and Sucker Brooks to identify long-term stream monitoring points, identification of stream stabilization opportunities, riparian buffer acquisition, and cost estimating for implementation of said projects focusing on phosphorus reduction as outlined in the Owasco Lake 9 Element Plan, Drinking Water Source Protection Plan, and Harmful Algal Bloom Action Plan for Owasco Lake; and

WHEREAS, the proposed project is estimated to cost of \$85,000 with a proposed \$10,000 local minimum match, consisting of funds from the Water Fund; and

WHEREAS, since the City of Auburn does not currently have the funding to pay for 100% of the Owasco Lake Subwatershed Comprehensive Stream Corridor Assessment, it is necessary to obtain New York State grant funding assistance from the Non-Agricultural Nonpoint Planning Grant Program.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Auburn, New York:

- 1. That the Mayor, or Director of Municipal Utilities, is authorized to submit a Non-Agricultural Nonpoint Planning Grant application to NYS DEC in the amount not to exceed \$85,000 in total project costs; and
- 2. That if awarded Grant funds, the Mayor or appointed designee is authorized to accept the grant funds and sign any and all agreements, documents and reimbursements in association with the grant project; and
- 3. That if awarded Grant funds, the City Comptroller is authorized to create the capital project budget for the Owasco Lake Subwatershed Comprehensive Stream Corridor Assessment by the State

Grant amount of \$75,000 with the remaining \$10,000 local match amount being transferred from Water Fund Balance to the new capital account; and

4. That this resolution shall take effect immediately upon its adoption.

AWARD RESOLUTION #77 OF 2023 AWARDING A CONTRACT FOR A DEFERRED COMPENSATION PROVIDER FOR THE CITY OF AUBURN

WHEREAS, the City of Auburn Deferred Compensation Plan has been provided administrative services by International Capital Market Association (ICMA), with Mission Square Retirement serving as the financial organization and ICMA Trust company serving as a trustee; and these services expired July 6, 2023; and

WHEREAS, on February 14, 2023, the City of Auburn advertised a Request for Proposals (RFP) for a Deferred Compensation Plan and on March 17, 2023, the City received 8 (eight) responses to the RFP and on May 23, 2023 and May 24, 2023, the top five providers were interviewed; and

WHEREAS, the specialized nature of the financial services industry requires that several entities be engaged to fully provide an appropriate level of service for a deferred compensation plan; and

WHEREAS, the City of Auburn has gone through a competitive RFP process and chosen to select Genesee Capital Advisors as the independent financial professionals providing education to City of Auburn Deferred Compensation Plan participants, Empower Retirement, LLC for administrative services and plan provider, Great-West Life & Annuity Insurance Company of New York (Empower) as a financial organization, and Empower Trust Company serving as a trustee for a five (5) year period; and

WHEREAS, the City of Auburn wishes to enter into a contract with Genesee Capital Advisors and Empower Retirement, LLC as the plan administrator, Great-West Life & Annuity Insurance Company of New York as a financial organization, and Great West Trust Company, LLC as Trustee for the City of Auburn Deferred Compensation Plan; and

NOW, THEREFORE, BE IT RESOLVED that the Auburn City Council does hereby award a contract to Empower Retirement, LLC as the plan administrator, Great-West Life & Annuity Insurance Company of New York as a financial organization, and Great West Trust Company, LLC as Trustee for deferred compensation services for the City of Auburn employees to commence on or about October 1, 2023; and

BE IT FURTHER RESOLVED that the Comptroller or appointed designee, is authorized to sign the initial agreement and all related documents to carry out the purposes of this Resolution.

E. Staff or Vendor Presentations -

Community Development Block Grant (CDBG) Program Year 2023 Annual Action Plan Amendment – Tiffany Beebee, Senior Planner

The CDBG Five Year Consolidated Plan and subsequent Annual Action Plans provide the framework for funding priority projects. However, a change in funding for a project that constitutes twenty-percent (20%) or more requires a substantial amendment. To provide this funding to the community in a timely manner, the City will be amending the 2023 Annual Action Plan. This document is a substantial amendment that provides information on projects and activities that will be completed with PY 2023 funding previously allocated to Parks, Playgrounds, and Public Facilities. This Action Plan was adopted by City Council on February 16, 2023. The proposed project is supported by the goals within the 2020 Five- Year Consolidated Annual Action Plan. The amount of funding to be moved from the Home Access Program, Microenterprise Program, and the Parks budget line to Sewer Line Repair is up to \$93,000. The Microenterprise Program has been on pause as new initiatives are being introduced to the community such as the SBDC Fast Track to Business. The Home Access Program is delayed in expending the 2022 grant funds. It was agreed upon to issue an extension on the 2022 grant funds and to re-program the 2023 funds. The parks budget line had excess funds after receiving additional grants for Casey Park Skate Park. The funds dedicated to Casey Park Skate Park are not affected by this amendment: A thirty (30) day public comment period on the substantial amendment was initiated on

July 1, 2023. A public hearing will be held on July 20, 2023 at 5 pm at City Council. The public comment period will conclude on July 31, 2023 at 4 pm.
