Minutes

The meeting of the Auburn City Council was called to order at 5:00 p.m. from the City Council Chambers, 24 South St. Auburn, NY by Mayor Quill.

ROLL CALL – The City Clerk called the roll. Mayor Quill and Councilor Ginny Kent, Councilor Jimmy Giannettino, Councilor Terry Cuddy and Councilor Tim Locastro were present.

Motion to approve the August 17, 2023 minutes by Councilor Locastro, seconded by Councilor Cuddy. Motion to approve carried 4-0. Mayor Quill voted present.

Reports of City Officials

City Manager's Report -

- The City of Auburn has issued a Request for Proposals (RFP) for design construction documents and construction administration for the Wall St Park improvement project which is part of our CDBG plan. Responses are due August 29.
- The city is also accepting bids for pipe and materials, due September 6.
- Last week our Water Treatment staff began utilizing the Powder Activated Carbon (PAC) system in low doses as a precaution and based on prior years' experience. Both raw and finished water testing have resulted in non-detect classifications for microcystin. More information and timely updates are available on the city webpage.
- Earlier this week our director of Planning, Jenny Haines, and I attended the CNY Regional Economic Development (REDC) meeting in Syracuse. These meetings are useful in staying updated on regional projects and trends related to economic development overall, as well as progress on the Micron project.
- Earlier this week staff participated in the Cayuga County Housing Committee meeting led by Jenny Haines. These meetings are attended by both local and regional representatives from government and the private and non-profit sector related to housing and residential development. The group anticipates having input and participating in future regional discussions related to housing needs driven by the micron development. The work of this group continues to be helpful and informative regardless of the impact of Micron, as we work to address current housing issues and anticipate more needs as we experience other commercial development.
- Today staff issued a notice to proceed on the Casey Park Skate Park project. The construction kick off has been delayed due to some issues lining up appropriate insurances for the various contractors.
- The City Manager introduced Director of Municipal Utilities, Seth Jensen to provide Waste Water Treatment Plant Construction Update:

General work completed to date is as follows:

- 1) Demo of 1970's Trickling Filters (275' diameter, 4 total filters)
- 2) Stone from filters crushed and reused as compacted foundation and trench fill.
- 3) Site subgrade placement for new solids handling building, one digester, and dry product storge canopy
- 4) 90% of stormwater facilities installed including piping and manholes

- 5) 3 Electrical manholes and ~350' of duct bank placement
- 6) Over 100,000# of rebar tied and placed
- 7) Formwork for solids handling building foundation set

Upcoming next week:

- 1) 50 yards of electrical duct bank concrete encasement
- 2) 170 yards of foundation concrete placement
- 3) Asbestos Abatement and demo of interior of the recirculation building (new digester control building)
- 4) Painting of existing steel in Final Settling Tank (FST) 4 (1 of 4 to complete)
- 5) Continuation of demolition in the existing solids handling facility around operations.

The Project continues to progress within the confines of the construction schedule and budget. No major unanticipated costs/scope alterations so far.




