Ceremonial Presentations –

WHEREAS, fire is a serious public safety concern both locally and nationally, and homes are the locations where people are at greatest risk from fire; and

WHEREAS, home fires killed more than 2,800 people in the United States in 2021, according to the National Fire Protection Association® (NFPA®), and fire departments in the United States responded to 338,000 home fires; and

WHEREAS, cooking is the leading cause of home fires in the United States and fire departments responded to more than 166,400 annually between 2016 and 2020; and

WHEREAS, two of every five home fires start in the kitchen with 31% of these fires resulting from unattended cooking; and

WHEREAS, more than half of reported non-fatal home cooking fire injuries occurred when the victims tried to fight the fire themselves; and

WHEREAS, children under five face a higher risk of non-fire burns associated with cooking than being burned in a cooking fire; and

WHEREAS, Auburn, NY residents should turn pot handles toward the back of the stove; always keep a lid nearby when cooking; keep a three-foot kid-free zone around the stove, oven, and other things that could get hot; watch what they heat; and set a timer to remind them that they are cooking; and

WHEREAS, residents who have planned and practiced a home fire escape plan are more prepared and will therefore be more likely to survive a fire; and

WHEREAS, working smoke alarms cut the risk of dying in reported home fires almost in half; and

WHEREAS, Auburn NY first responders are dedicated to reducing the occurrence of home fires and home fire injuries through prevention and protection education; and

WHEREAS, Auburn NY residents are responsive to public education measures and are able to take personal steps to increase their safety from fire, especially in their homes; and

WHEREAS, the 2023 Fire Prevention WeekTM theme, "Cooking safety starts with YOU. Pay attention to fire preventionTM," effectively serves to remind us to stay alert and use caution when cooking to reduce the risk of kitchen fires.

NOW THEREFORE, I, Michael D. Quill, Mayor of the City of Auburn, NY, do hereby proclaim **October 8–14, 2023**, as

throughout this City, and I urge all the people of Auburn, to check their kitchens for fire hazards and use safe cooking practices during Fire Prevention Week 2023, and to support the many public safety activities and efforts of Auburn, NY fire and emergency services.

Mayor Quill presented the National Fire Week Proclamation to Fire Chief Fritz.

Public to be heard: The City Clerk read the rules for Public To Be Heard and the following individuals spoke: Tim Lattimore of 63 South Street spoke and stated that he attended the Chamber of Commerce dinner and at his table he heard that the City was not doing a sufficient job with providing advanced public notice on road construction, he said the City should provide public notice to businesses.

Reports of City Officials

City Manager's Report -

- There was a public meeting to gather input on a future project to refresh the Wall St. Playground. The meeting took place at the playground on Wednesday October 4. Approximately 35 neighborhood residents attended and were able to view several conceptual designs and features. They were able to score each design and feature and also contribute their suggestions. This neighborhood input will be used to develop next step designs.
- This week staff hosted a meeting with Cayuga County Social Services and our local homeless outreach coordinator to discuss various topics related to the homeless population and those squatting in vacant and condemned homes. County Social Services works directly with these individuals and families and is in close communication with our police and code enforcement departments. The primary focus of this particular meeting was the change in seasons and the onset of cold weather that impacts the actions Social Services can, and in some cases, must take with the drop in temperatures.
- Last week we gave a rather lengthy presentation on our housing situation including challenges and method we employ to maintain and improve our neighborhoods. We didn't spend much time discussing the police department's recent GIVE initiative. We frequently see a connection between nuisance complaints and suspected or known criminal activity at particular addresses. Chief Slayton is here to briefly explain the GIVE initiative.
- Today, several city staff participated in a meeting conducted by Camoin Associates. Camoin has been commissioned by Central NY Regional Economic Development to develop strategic visioning and plans for CNY to better respond to both commercial and residential development.

We were joined by CEDA staff and board members, our counterparts from Cayuga County Planning, staff from Cayuga County Tourism, and a few local business owners.

• This morning Christina Selvek, our Director of Capital Projects and Grants, and Jenny Haines, our Director of Planning and Economic Development had another productive meeting with Alstom representatives and their realtor. These meetings have been occurring every two weeks as all parties work through the first phases of returning the Bombardier property to productive use. As a general reminder, the property is still privately owned and controlled, with city staff and CEDA providing assistance within our scopes of authority.

A. State Environmental Quality Review Act Resolutions (SEQR) SEQRA RESOLUTION #4 OF 2023

DETERMINING TYPE II ACTIONS UNDER SEQRA FOR LEAD SERVICE LINE INVENTORY

WHEREAS, the City Council of the City of Auburn, New York (the "City") is the sponsor of a lead service line inventory project that intends to identify and locate all the unknown lead service lines in the City and use this information to create a lead service line inventory and purchase a new vehicle (the "Project"); and

WHEREAS, the City desires to comply with the New York State Environmental Quality Review Act (the "SEQR Act") and the regulations adopted pursuant thereto by the Department of Environmental Conservation of the State of New York, being 6 NYCRR Part 617, as amended (the "Regulations"), with respect to the Project; and

WHEREAS, Section 617.5 of the Regulations establishes a list of Type II actions that have been determined not to have a significant impact on the environment and are not subject to further review; and

WHEREAS, § 617.5 (c) 18 states "information collection including basic data collection and research, water quality and pollution studies, traffic counts, engineering studies, surveys, subsurface investigations and soils studies that do not commit the agency to undertake, fund of approve any Type I or Unlisted action"; and § 617.5 (c) 25 "Purchase or sale of furnishings, equipment or supplies, including surplus government property, other than the following: land, radioactive material, pesticides, herbicides, or other hazardous materials".

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Auburn that:

- 1. The proposed action corresponds with the parameters identified in § 617.5 (c) 18 and § 617.5 (c) 25 of the Regulations; and
- 2. The Lead Service Line Inventory constitutes a "Type II Action" under 6 NYCRR § 617.5 and no further action under the SEQR Act and the Regulations is required; and
- 3. This resolution shall take effect immediately.
