- Earlier this week I met with the Cayuga County Micron Development group to report out on the Housing Committee's recent meeting. That committee is headed up by Jenny Haines, our Director of Planning, who was unable to attend this week's county meeting. The county group will meet again in January.
- Yesterday I attended the CNY Regional Economic Development Council's (CNY REDC) meeting in Syracuse along with Steve Lynch from Cayuga County Planning Department and Maureen Riester from CEDA. We were updated on several projects related general business development as well as projects focused on the Micron project.
- Earlier this week I met with representatives from Auburn Community Hospital regarding their new Cancer Center which is nearing completion and parking around their facility. We continue to work with the hospital to explore potential solutions to the congested parking situation.
- Staff from several departments collaborated this week to develop enhanced procedures to address problem properties. We hope that some of these new approaches will expedite the necessary measures often needed to correct violations, as well as reduce the extensive staff time that is frequently required to administer our current approach.
- City staff continues to communicate regularly with Alstom and their realtor regarding the Bombardier property. The company has decided to extend their deadline for responses to the sale of the property to mid-February due to significant interest and the needs of potential bidders.

ADJOURNMENT: By unanimous vote the Council adjourned the meeting. The meeting was adjourned at 6:09 p.m..



Auburn Community Cats TNR, Inc. Annual Report July 1, 2022 to June 30, 2023



Community cats are homeless, but not always feral. Many in Auburn are friendly, having been fed by local residents their entire lives. Local rescues are full, and there are not enough potential adopters for the number of community cats living outside. Unfixed males fight and ruin property by marking territory. Unfixed females have litters at an exponential rate. The issue of feline overpopulation affects the entire city of Auburn. TNR, which stands for Trap, Neuter, and Return, addresses the issue of overpopulation by spaying and neutering cats before returning them to the colony and caretakers. The cats are also given vaccinations for distemper and rabies, an important step for public health.

History & Locations



Auburn Community Cats TNR, Inc. had its first meeting in August of 2021. It was incorporated in February of 2022. By June 30, 2022, ACC-TNR had trapped, neutered and returned 98 cats, all paid for through private fundraising.

Between July 1, 2022 and June 30, 2023, ACC-TNR neutered 155 cats, 99 of which were within city limits. Of the 56 cats taken from outside city limits, 19 were from <2 miles of city limits. All 98 cats from 2021-2022 were in the city limits.

Members of the public reach out to ACC-TNR via our Facebook page, phone calls, and word of mouth. They are added to a master list and addressed in order. As of June 30, 2023, we had trapped at the first 70 locations we were told about, which leaves 65 remaining on our list.

ACC-TNR has run chocolate bar sales, chicken barbeques, t-shirt sales, and other fundraisers, besides tabling at many community events to solicit private donations. Our group members donate items to sell at craft fairs and yard sales. We have GoFundMe and Venmo accounts that we share widely. We presented at a City Council meeting in April of 2022, asking for financial assistance, and were awarded \$5,000 in the 2022-2023 city budget.

Our biggest challenge has been a lack of available appointments. In 2021, we surveyed local veterinarians and found that average private appointments cost over \$250 per cat and were difficult to obtain and schedule.

Low cost spay and neuter clinics are held at the Finger Lakes SPCA of CNY three times per month, but we are limited to 2 cats per clinic. The SPCA will sometimes cover our costs with a grant for stray cats, but this is inconsistent.

Several times per year, we have been able to hold our own clinics with more expensive independent veterinarians. We fix between 12 and 16 cats at each of those clinics.

Auburn Community Cats TNR, Inc. spent \$16,889.18 by June 30, 2023. In that time, we fixed 253 cats. Therefore, our average cost per cat by June 30, 2023 was \$66.76.
