**WHEREAS**, it is necessary that the Auburn City Council award the Project to the lowest responsible bidder, namely, WCA Roofing & Sheet Metal Co., which has submitted a low bid of \$74,895.00;

**NOW, THEREFORE, BE IT RESOLVED** that the Auburn City Council does hereby award the contract for the Project to WCA Roofing & Sheet Metal Co., the lowest responsible bidder in the amount of \$74,895.00; and

- \$37,447.50 is to be charged to F8340 440 Transmission/Distribution Services;

## What is Hotel Occupancy Tax?

A hotel occupancy tax is a tax placed on each nights' stay at a hotel, motel, or, Air B&Bstyle rental.

Hotel Occupancy Tax at the **County Level** in New York State




#### **Occupancy Tax Report**

The following is a report relating to the occupancy tax in New York State, specifically tracking the impact that occupancy tax increases may have on Cayuga County and individual municipalities that would consider implementing additional occupancy tax.

#### Occupancy tax rate by county in New York State



The chart above reflects the current occupancy tax rate in 55 of the 63 counties in New York State. As the chart reflects, approximately 50% of these counties have an occupancy tax of 3% or 4%. Cayuga County's 5% occupancy tax is already a bit higher than 50% of the counties in the state. The highest occupancy tax rate is 8% in Richmond County which is in Staten Island. There's only one county in the state at that rate, and then a couple that are at 5.5%, 6% and 7%. These counties makeup about 20% of the highest occupancy taxs in the state. Another quarter is at 5%, which is where Cayuga County is currently at.

Above Data Provided by Cayuga County Office of Tourism

Cayuga County has had a hotel occupancy tax since the 1990's. This county tax has been 5% for several years and is collected by the County Treasurer. The tax revenue is used to fund the **Cayuga County Convention and** Visitors Bureau.

Hotel occupancy taxes are becoming more common as alternatives to property tax to allow generation of revenue for municipalities.

In 2023 Governor Hochul signed several home rule legislation request bills that allowed municipalities to implement their own hotel occupancy tax.

- Hotel annual estimated at \$452,000. + Airbnb estimated at \$48,000. = \$500,000. at 5%
- Every 1% of hotel occupancy tax = \$100,000 estimated in revenue

# How to Implement a City of Auburn Hotel Occupancy Tax?

- Requires NYS Legislature Home Rule Request Legislation.
- Process starts with a letter from the City asking our State Representatives to start the Home Rule Process
- State Senate and State Assembly will introduce Home Rule Request Bills
- Once State Bills are introduced, City Council Resolution of Support for those bills would be voted on by the City Council.
- By the end of the State Legislative session in June 2024, the State Senate and State Assembly would need to adopt the Home Rule Request Bills
- Summer/Fall 2024, Home Rule Request Bill would need to be signed into law by the Governor
- When all of the above is completed the City of Auburn City Council would need to adopt a Local Law to Establish a Hotel Occupancy Tax
- If all of the above can happen by November 2024, the City Hotel Occupancy Tax could take effect January 1, 2025.
- City Treasurer would register local hotels in December 2024 and collect payments quarterly.
- First quarter payments from hotels would be due in April 2025.
