THINGS TO KNOW:

1. One box of chalk will be provided with registration. Artist may bring their own chalk if preferred. (chalk/pastels in solid form only. No paint, markers, etc.)
 2. Participants are encouraged to bring the following: pillow, blanket, or cardboard for kneeling to stay comfy while you draw; sunscreen and hat; water and snacks; sketches or inspiration pieces to guide your chalk design. Please be advised participants are responsible for the security of their belongings throughout the afternoon.
 3. Participants must remain “within the lines” of their assigned space and not damage surrounding drawings.
 4. Pre-Registration is required for all participants. **Pre-registration deadline is Friday, June 12, 2020.** A Hold Harmless Agreement must also be completed by all participants. Parents of minors must sign and date registration form for them. Children under 16 years of age must be accompanied by parent/guardian or supervising adult.
 5. Assignment of space will be at the discretion of event organizers. Participant will receive a confirmation with assigned space# prior to June 17th. Spaces are approximately 5’ x 5’ and are located around the property of the NYS Equal Rights Heritage Center on South and Lincoln Streets.
 6. There will be one prize given for “Best in Show” for each of the three Age Categories. Age Categories for Participants/Prizes are as follows:
 - 12 years and under (child)
 - 13-17 years old (teen)
 - 18 years and older (adult)
- There will also be one *“Honorable Mention”* awarded a prize.
Prizes are generously donated by Auburn Downtown BID.
7. No more than four (4) artists working as a group in one space.
 8. No spaces will be granted to those wishing to express religious, moral, political or controversial opinions.
 9. Commercial advertising messages, business logos, and alcohol/tobacco/drug themes will not be allowed.
 10. Images with nudity, vulgar, or explicit language or expression are STRICTLY prohibited.
 11. Event organizers reserve the right to deem a drawing inappropriate for a family-themed event.
 12. Judging will take place between 6:00 - 6:45 p.m. with prizes being awarded at 7:00 p.m.
 13. By participating in **Let's Chalk About It Again** sidewalk chalk art competition, you allow the use of images of yourself and your artwork to be included, during and after the event, including but not limited to City of Auburn and Downtown BID websites, print media and social media outlets.
 14. In the unfortunate circumstance of rain on the day of the competition, the event will be cancelled or rescheduled. Cancellation notice will be posted on the “City of Auburn Parks and Recreation” Facebook page if necessary.

15. Updated Requirements in response to COVID-19:

- Participants will be spaced out pursuant to proper CDC social distancing guidelines
- All participants must have a mask or face covering on their person and it must be worn upon request by event staff
- No gathering or congregating allowed with anyone who is not part of your family or group
- Bathrooms will be available and will be kept sanitized throughout the day
- You are encouraged to incorporate messages of hope and positivity in your artwork
