The 2022 Auburn Recreation Program is scheduled to begin on May 2, 2022. Rosters are due by 3:00 PM on Friday, April 8, 2022.

1. All managers and players are responsible for becoming know ledgeable of the rules. Once a roster is completed and filed with the Recreation Department, that manager is agreeing that he/she has read the rules, is acceptant of the rules, and has informed his/her players of the content and application of those rules. In addition, compliance with any COVID-19 protocols in place at the time must be adhered to.
2. All entry forms accompanied with the proper fee are to be submitted to the Department of Public Works office by Friday, April 8, 2022. Each entry will be numbered upon being submitted. You will need separate checks for the forfeit fee. Both checks should be made payable to the City Treasurer. Both of these fees will be paid with the entry forms at the Department of Public Works \& Recreation.

4. Roster:
A. Typed or printed roster, nonresident fee and forfeit fees must be submitted on or before April 8, 2022. Checks for entry/nonresident fees must be made payable to the City Treasurer. All rosters will be closed with all player names included on or before April 8, 2022. Any changes to the roster after April $8^{\text {th }}$ must be review ed and approved by the Superintendent of Public Works and Sports Coordinator. Each roster must include at least twelve names. Players whose names appear on more than one roster will be committed to that team once his/her name is entered on the score sheet for the first game that he/she participates. Managers are solely responsible for the accurate completion and maintenance of their roster. Any violations may result in suspension and termination of players or teams.
B. A responsible team manager must be designated on the roster prior to submittal. It is required that cell phone number, home phone numbers, e-mail address (this will be used as an initial contact), and work number (if possible) and complete addresses of the managers be supplied. Be advised that no schedules, standings, rain out schedules etc. will be mailed via regular mail. ALL of that will be supplied on the City's website www.auburnny.gov and/or the City of Auburn Parks and Recreation Facebook page.
5. Player Eligibility:
A. Anyone residing within the City of Auburn city limits.
B. Residents of Cayuga County, not residing within the city limits of Auburn, will be assessed a $\$ 30$ fee per player. Non-county residents (only contiguous counties permitted at this time) will be assessed a $\$ 60$ fee per player. THESE FEES MUST ACCOMPANY TEAM ROSTER. This fee will not be refunded for any reason.
C. ALL players must be able to show proof of residence (drivers license, registration, school I.D., etc.) within 48 hours upon request of the Sports Supervisor or the Department of Public Works.
D. All players must be at least 18 years of age by July 1,2022 , to participate in any league.
E. Any player found violating any part of Rule \#6 will be suspended from further league play and all games said player participated in will be declared a forfeit. The team managers will be responsible for making sure their team members bring in proof of residency to the Department of Public Works upon request.

6. Switching Teams:
A. Players will not be permitted to laterally switch teams during the season unless approved by the Superintendent of Public Works and Sports Supervisor and only under extenuating circumstances.
B. Players are not permitted to play with more that one team in the $A$ and $B$ slow pitch classification.

Any player found to be in violation of rules five or six will be fined $\$ 50.00$ and suspension determined by league coordinator and review ed by Superintendent of Public Works. Further violations will result in possible termination.
7. The Sports Supervisor will decide on which teams are placed in the Men's or Women's "A", "B" or "C" leagues for the 2022 season. The City of Auburn Department of Public Works reserves the right to place teams in the various leagues depending on skill level of the players. Previous year records, roster evaluation and player representatives will be methods that will determine placement and classification of teams in the various leagues.

The City of Auburn Department of Public Works reserves the right to cancel leagues and refund registration fees if the leagues are unable to form in the appropriate classification of skill level. The City of Auburn also reserves the right to determine how many players from a refunded team may join another team to compete in a different league.
8. Teams may purchase softballs through the Parks and Recreation Department (office located in the basement of City Hall).
9. Schedules will be posted to the City's website: www.auburnny.gov sometime during the week of April 18, 2022. Please be advised that schedules will only be e-mailed to team managers. The team managers will be responsible for checking the website and/or email and providing copies to teammates.
10. The softball meetings, which usually take place prior to the start of the season, will NOT be held this year.
11. The home team is responsible for recording wins and losses on the master schedule. The master schedule is located on the Casey Park Office window or at the fields in the utility boxes behind the backstops. All teams are requested to check their individual wins and losses on a regular basis to ensure proper and accurate recording. Do not wait to the last game of the season to review your current standings, as it may become too late to be included in the playoffs.

* Teams will not be contacted by the softball coordinator to ascertain whether a game was won or lost. Those incomplete games will result in losses to both teams and team manager will accept the responsibility.

12. Managers and/or players of those final games being completed on any given night are requested to ensure that the lock is secured on the utility box after recording the win/loss and placing the bases in the box.
13. In Men's Slow Pitch Divisions, the mat has been expanded by 1 " on each side of the plat, plus 2 " off the end of the mat. Any pitched ball conforming to the 6 to 12 foot arc and falling between the highest shoulder and lowest knee on the player from the ground and hitting the mat, will be called a strike by the umpire. In the Women's Division, no mat will be utilized; how ever, normal strike zone will be enforced.

14. In an effort to reduce serious injuries to the pitcher from batted balls, a chalked line 6 feet from the back of the pitching rubber will be designated. The pitcher will be allowed to choose at the beginning of the game which pitching distance they wish to pitch from. Pitchers will not be allowed to switch the pitching lengths once the length has been determined. A new pitcher entering the game will be allowed to select his/her pitching distance. This rule can only be altered under the discretion of the umpire and only in the best interest of the game.
15. The base paths will remain at 70 feet for the Men's 2022 season as indicated in the 2022 USA of NY rule book. The base paths will remain at 65 feet for the Women's 2022 season.
16. Games must start when scheduled as long as any nine rostered players are present. No out shall be declared if a team begins a game with nine in the absence of a tenth player. In slow pitch, a tenth player whose name is already on the roster, may enter the game prior to the completion of the fourth inning.

Without the appropriate number of players, teams may wait ten minutes, after which, game is forfeited.
A. In slow pitch a team may play with an extra player (EP) who may enter the game as a defensive player. That player who leaves the defensive position then becomes the (EP). No alterations to the batting order will be permitted unless a player enters the game as a fresh substitute.

1. Once a team starts with the 11 player (EP) they may finish with 10 or 9 players. How ever, an out will be declared in that player's spot that leaves the game.
2. Once a team starts with 10 players and loses player(s) to an injury or ejection, that spot in the batting order will be declared an out.

No team will be allowed to play with less than 9 players.

## 17.HOME RUN RULE:

The Department of Public Works will continue the home run rule from last season.
A Division - Each team will be allotted three home runs per game. Once team A hits the $4^{\text {th }}$ home run, team $B$ must match their $4^{\text {th }}$ home run. If team $A$ hits the $5^{\text {th }}$ home run before team $B$ hits their $4^{\text {th }}$ home run, it will be declared an out. Teams will be allowed to match each other with unlimited home runs.

B Division - Each team will be allotted two home runs. Any further home runs after the $2^{\text {nd }}$ will result in outs.

Teams are notified that the game will continue with a back-up ball after each home run. At no time should a game be stopped to retrieve the ball. The umpire will be responsible to enforce this rule. If there is violation of this policy, the rule will be terminated and we will finish the season with the past home run policy.

## 18.FORFEIT POLICY:

All men's and women's leagues are required to pay a $\$ 72$ forfeit fee to the City of Auburn. This forfeit fee will be refunded at the completion the season barring any forfeits during the season. In the event of a forfeit, the umpire fee will be deducted from the offending team's forfeit fee. The non-offending team will NOT be responsible for payment of the umpire on that evening. A second forfeit will result in payment of the remaining forfeit fee and suspension from further league play.

19. A. Each player plays at his own risk. Any injuries sustained are paid for by each individual or group.
B. Blood Rule: Any player who is injured during the contest and is bleeding from said injury will be removed from the game until such time as the bleeding has stopped. That player must remove all clothing which has been bloodied by the injury, prior to re-entry into the game.
C. Failure to adhere to the Blood Rule will result in ejection of the player from the game.
20. PROTESTS:
A. Protest must be made to the umpire at the time of the discrepancy. Protests must be written and forwarded with a $\$ 25$ deposit to the Department of Public Works within 24 hours of the discrepancy. If protest is upheld, the fee will be returned.
B. Protest must quote section, paragraph, and number of rule violated, as it appears in the 2022 USA of NY Rule Book.
C. The Sports Supervisor and/or Arbitration Board will decide all protests.
21. Any conduct not considered sportsmanlike will not be tolerated. Such players will be ejected from the game, and possibly from the league if the Sports Supervisor deems it necessary. Ejection will mean automatic one-game suspension. Any/all players ejected from a game are required to pay a $\$ 50$ re-entry fee to the Recreation Office prior to the next scheduled game. Any player ejected a second time will be suspended from league play for the season OR will be suspended for an indefinite amount of time. The above applies to individuals as well as teams. Unsportsmanlike action includes any verbal or physical abuse directed at another player, fan or umpire (i.e., swearing, pushing, intimidation, etc.). This rule will be in effect before, during, and after games. Violations of this rule will be automatic forfeiture of games involved. Those ejected players must leave the facility immediately. If the player remains at the location the game will be declared a forfeit.
22. USA of NY Softball Rules will prevail, unless otherwise stipulated, with ground rules stipulated by umpires. Any rules violation will result in games being forfeited. Any changes regarding rules and regulations must come from the Sports Supervisor.
23. Slow Pitch teams will be dressed in conforming colored shirts once the season begins.
24. (A) Balls:
25. Due to the pandemic and the Recreation Department's inability to guarantee the shipment of the balls prior to the season, the same Trump ball as used in previous years will be utilized this season. The Recreation Department has identified, that for safety reasons, we must change the current COR 44 compression of the ball to a COR 52 compression. We are currently evaluating the feasibility and pricing of this ball for future use after the exhaustion of the current ball inventory.
26. Ball Rotation-All Men's Divisions: Two new balls shall be delivered to the umpire at the beginning of the game
The umpire will enforce the USA of NY ball rotation policy.
27. Women's Divisions - one new ball and good back up ball shall be delivered to the umpire at the beginning of the game. Quality of back up ball will be left to the discretion of the umpire. If the back up ball is deemed unacceptable, a new ball must be provided.
28. Scorekeepers - all teams will be responsible for purchasing a scorebook. The home team designated on the schedule will be required to maintain the official score.
29. (B) Bats:

The official bat governing the City of Auburn Softball League play will be modeled after the USA Softball Championship play and will meet the specifications and requirements of Rule 3 Section 1 of the USA Rule Book. The bat must bear the appropriate certification as shown below. The bat and model must be included
on a list published by USA Softball. Please ask the Recreation Department for a copy of that list.


Allowed in all games
25. In case of inclement weather, the Department of Public Works will be responsible for cancellation of games up until 3:30 p.m. of the day in question. The decision will NOT BE MADE UNTIL AFTER 3:00 P.M. Please do not call the Recreation Office prior to 3:00 P.M. If the game has not been cancelled by 3:30 p.m., teams must report to their scheduled field site at game time, at which time the umpire will determine if the game is to be played or not. THE UMPIRES DECISION WILL BE FINAL. At any field with multiple games per night, once a game is cancelled, the remainder of that night's games are cancelled. The softball hotline number is 315-255-4119. Cancellations can also be found on the City website: www.auburnny.gov, and City of Auburn Parks \& Recreation Facebook page.
26. All recreation softball games must be played as scheduled or declared a forfeit. Games will not be rescheduled for any reason, with the exception of rained-out games. Those teams who cancel games on their own by contacting the other team the game will be declared a forfeit.
27. A player must play in two games to be eligible for playoffs, unless otherwise stipulated by the Sports Supervisor.
28. PLAYOFFS:

In the past, schedules have been supplied by the Recreation Office. We have experienced many problems with inaccurate, unidentifiable and unintelligible standing recordings by the teams. In addition, many playoff berths were not settled until games are played on the last night of the season. This caused many problems as teams were not prepared to begin playoffs the following Monday.

To address and possibly resolve these problems, playoff schedules will be determined during the weekend (following the final night of the season) and supplied to the Department of Public Works early Monday morning. Team managers will be responsible for securing the schedule by contacting the Department of Public Works. There will be no calls made by the Department of Public Works to those team managers who failed to secure the schedule! The playoff schedule will begin the following week promptly giving all teams an opportunity to make arrangements with their individual players.
29. Playoffs will be limited to the pennant winners, runners-up or determined by the Sports Supervisor.
30. The ten run, five-inning rule, will prevail in all slow pitch games. In slow pitch, if either team leads by ten or more runs after five innings, the game will be awarded to the team with the most runs. The ten run rule will be in effect for the playoffs.
31. The consumption of alcoholic beverages or use of tobacco and/or marijuana products by any player or spectator on the grounds of the Casey Park facility is STRICTLY forbidden and in violation of City Ordinances. Any violators of this policy are subject to police arrest, suspension from the league and forfeiture of the game by the offending team. This policy is in effect prior to, during and subsequent to the game. This policy also includes the parking lots. Team managers or captains are responsible to see that this rule is enforced.
32. Schedules will NOT be altered! Early schedule distribution will allow you to avoid any/all schedule conflicts. Inability to conform to this master schedule is a concern of yours and will not be the concern of this

department. The early release of said schedule is a convenience for all teams so arrangements can be made in advance of scheduled games.
33. The enclosed rules and USA of NY rules will govern league play.
34. UMPIRE FEES:

The Umpires Fees for the upcoming season will be based on a sliding scale and will be determined by proficiency of the league.
A. Men's A and B Major: $\$ 44.00$ per game; $\$ 22.00$ per team

Men's B League : $\$ 40.00$ per game; $\$ 20.00$ per team
Women's Leagues: $\quad \$ 36.00$ per game; $\$ 18.00$ per team
B. This fee must be paid to the umpires prior to the start of the game.
C. In the case of a game starting and getting suspended due to rain or any other act of God, the umpire will keep the fee. That umpire will be scheduled to work the incomplete game or
prorate
umpire.
35. IN ALL SOFTBALL LEAGUES, metal cleats or football shoes will not be permitted. Anyone violating this rule will be subject to ejection from the game.
36. All existing preceding rules and regulations are subject to change, modification, and/or alterations by the Sports Supervisor ONLY! These changes, modifications and/or alterations are made in conjunction with the Board of Arbitration. The Board of Arbitration will consist of the following:

1. Softball Coordinator
2. Superintendent of Public Works
3. Executive Board (Umpire)
4. Player Representative
