The Detective Bureau was assigned 352 new cases and closed 301 previously assigned cases during 2020. Detectives made 43 arrests, to include 45 felony and 44 misdemeanor charges. 28 juveniles were petitioned to Cayuga County Family Court. Detectives applied for 29 warrants for a total of 61 charges. The Detective Bureau had 130 active cases as of the end of the year.

The Identification Bureau was assigned 1008 new cases and a total of 2711 items were received as evidence/property during 2020. Officers processed 1141 photo memory cards and 24 background checks. Officers oversaw the state mandated reporting of 149 sex offenders residing in the City of Auburn which included 964 sex offender contacts. Officers processed 50 items of evidence within the Identification Bureau, and sent 226 items out to the crime lab for further processing.

The School Resource Officer program handled 572 incidents in and around school buildings which required intervention by school officers while school was in session in 2020. The incidents included criminal cases, fighting, bullying, property checks, and other disruptive behavior. There were 7 arrests made for the year concerning school related incidents, which included 1 adult and 6 juveniles. The SRO's foster a relationship between the police and the students and staff of the Auburn School district. They create a safe environment on all school properties and respond to concerns of the staff or students. The SRO's provide mentorship to students with teaching and referral to appropriate programs.

The Traffic Division conducted several details to address aggressive driving during 2020. As part of the "Police Traffic Safety Program" sponsored by the Governor's Committee on Traffic Safety, officers issued 671 traffic tickets. Officers also coordinated additional DWI patrols on targeted dates during the year to curb drinking and driving. During those details, APD officers issued 36 uniform traffic tickets. The additional patrols are part of a program funded by the Cayuga County Stop DWI Committee.

The Training and Planning Division coordinated 16,677 total hours of training in various subjects throughout 2020, which include 3 police academies.

The Finger Lakes Drug Task Force initiated 117 new cases during 2020. Narcotics officers made 14 arrests and filed 63 charges. Officers seized 9,794 grams of marihuana, 182 grams of cocaine, 13 grams of heroin, 146 doses of controlled prescription medication and 18 grams of "Molly" during confidential drug investigations throughout 2020. Narcotics officers also executed 19 search warrants and seized 10 firearms and 8 vehicles.

During 2020, the Auburn Police Department hired ten officers, including one lateral transfer from the Oswego County Sheriff's Department. The department also lost five officers due to retirement. At the end of 2020, the department employed 62 sworn police personnel, including the Chief of Police and the Deputy Chief.
