

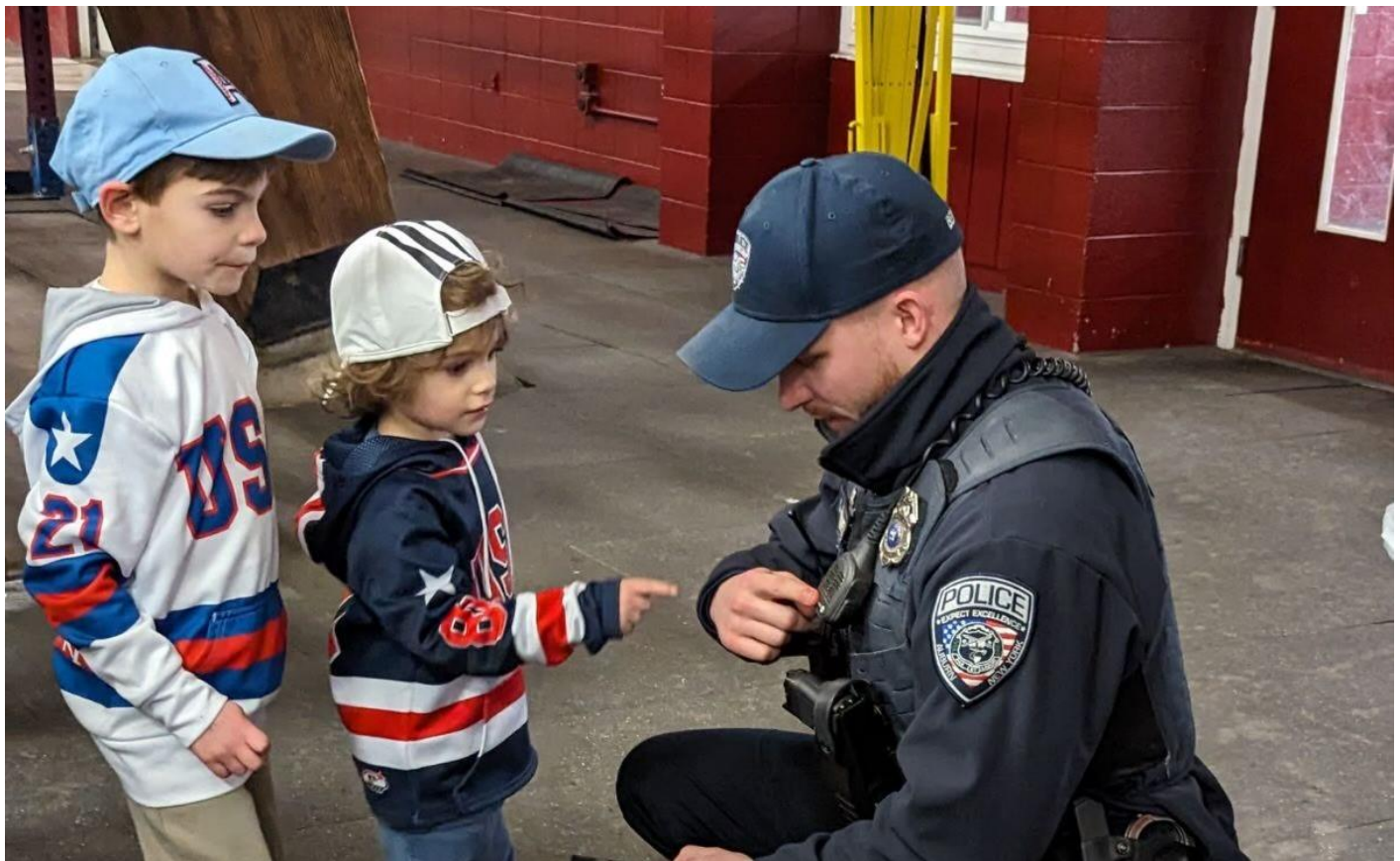

The Detective Bureau was assigned 28 new cases and closed 27 previously assigned cases. Detectives made 3 adult arrests, which included 5 felonies and 2 misdemeanors, and also executed 3 search warrants during the month. In addition, 2 warrant applications, consisting of 2 felonies and 7 misdemeanors, were filed. 3 juveniles were petitioned to Cayuga County Family Court. The bureau had 104 open cases at the end of February.

The Identification Bureau was assigned 65 new cases and a total of 193 items were received as evidence/property. Officers processed 88 photo memory cards during the month. Officers oversaw the state mandated reporting of 160 sex offenders residing in the City of Auburn which included 70 sex offender contacts. Officers sent 10 items out to the crime lab for further processing.

The School Resource Officer program took part in 76 incidents in February, which required intervention by school officers. The incidents included criminal cases, fighting, bullying, property checks, and other disruptive behavior. SROs also attended various after school activities and sports games.

The Training and Planning Division coordinated 639 hours of training in February, where officers participated in a variety of training courses, including Anti-Bias training, Emergency Response Team training, Sniper training, Supervisor Leadership, and field training for our newest recruits, Officer Jensen and Officer Major.

In February, we celebrated SRO Appreciation Day, honoring our School Resource Officers and Special Patrol Officers who play an invaluable role to our students, teachers and parents. SRO Officer Bennett gave a presentation to Auburn High School students regarding police recruitment, which entailed the process of applying, and meeting requirements, to become a police officer. Chief Slayton participated in a Law Enforcement Roundtable in Victor, NY, to discuss various public safety challenges including recruitment challenges, discovery mandates and bail reform.
