The Detective Bureau was assigned 16 new cases and closed 36 previously assigned cases. Detectives made 1 adult arrest, which included 2 felonies, and also executed 3 search warrants during the month. 1 juvenile was petitioned to Cayuga County Family Court. The bureau had 98 open cases at the end of January.

The Identification Bureau was assigned 53 new cases and a total of 196 items were received as evidence/property. Officers processed 89 photo memory cards during the month. Officers oversaw the state mandated reporting of 155 sex offenders residing in the City of Auburn which included 93 sex offender contacts. Officers sent 9 items out to the crime lab for further processing. The bureau collected 38.96 lbs of unused/unwanted prescription medications as part of our Medication Drop-Box Program.

The School Resource Officer program took part in 78 incidents in January, which required intervention by school officers. The incidents included criminal cases, fighting, bullying, property checks, and other disruptive behavior.

The Training and Planning Division coordinated 871 hours of training in January, where officers participated in a variety of training courses, including a Patrol Rifle course, RADAR/LIDAR, Interview Techniques and Therapeutic Crisis. Included in the training was field training for our newest recruits, Officer Jensen and Officer Major.

During the month, we congratulated Officer Fabiani at his pinning ceremony at City Council. Officer Fabiani was hired at the end of 2022 and completed his field training in 2023. During Law Enforcement Appreciation Day, officers were welcome to the CAP Community Action Programs Cayuga/Seneca where they spoke with students about their jobs and had the opportunity to read books to them. We always appreciate the invitation to interact with children in our community.
