The Detective Bureau was assigned 27 new cases and closed 21 previously assigned cases. Detectives made 1 adult arrest, which included 1 felony charge, and also executed 5 search warrants during the month. 6 juveniles were petitioned to Cayuga County Family Court. The bureau had 106 open cases at the end of March.

The Identification Bureau was assigned 63 new cases and a total of 239 items were received as evidence/property. Officers processed 75 photo memory cards during the month. Officers oversaw the state mandated reporting of 155 sex offenders residing in the City of Auburn which included 76 sex offender contacts. Officers sent 14 items out to the crime lab for further processing. The bureau collected 49.70 lbs of unused/unwanted prescription medications as part of our Medication Drop-Box Program.

The School Resource Officer program took part in 63 incidents in March, which required intervention by school officers. The incidents included criminal cases, fighting, bullying, property checks, and other disruptive behavior.

The Training and Planning Division coordinated 668 hours of training in March, where officers participated in a variety of training courses, including various armorer courses, Property Room Management, supervisor school, and Advanced Bloodstain Analysis. All members also received domestic violence training.

During the month, we continued our community outreach to the public. Sgt. Smith and Sgt. Hare spent time at Wells College recruiting future officers, while Officer Dranczak joined several community organizations at Play Space during Resource Night. Several members of our department attended a Domestic Violence seminary, hosted by the Community Action Programs Cayuga/Seneca (CAP), at Springside Inn. We also joined the community at the Easter egg hunt at Emerson Park.
