The Detective Bureau was assigned 308 new cases and closed 314 previously assigned cases during 2018. 23 juveniles were petitioned to Cayuga County Family Court. Detectives made 43 arrests and applied for 33 warrants for a total of 194 charges. There were 108 felonies, 82 misdemeanors and 4 violations for the year.

The Identification Bureau was assigned 1058 new cases and a total of 2768 items were received as evidence/property during 2018. Officers processed 966 photo memory cards, 41 background checks and issued new/renewed 29 taxi licenses. Officers oversaw the state mandated reporting of 135 sex offenders on average residing in the City of Auburn which included 1045 sex offender contacts for the year. Officers processed 35 items of evidence within the Identification Bureau and sent 208 other items out to the crime lab for further processing throughout 2018.

The School Resource Officer program handled 1296 incidents in and around school buildings which required intervention by school officers while school was in session during 2018. The incidents included criminal cases, fighting, bullying and other disruptive behavior. There were 21 arrests made for the year concerning school related incidents which included 6 adults and 15 juveniles.

The Community Oriented Policing program has one officer assigned to its operation. The officer is assigned to specific problem areas within the city when there is sufficient manpower. During the year of 2018 the COP officer dedicated 264 hours to community policing and visited 71 businesses throughout the city to advise the owners of our mission and to address any public safety concerns. The COP officer only worked during the months of July and August due to a lack of manpower.

The Traffic Division conducted several details to address aggressive driving during 2018. As part of the "Police Traffic Safety Program" sponsored by the Governor's Committee on Traffic Safety officers issued 721 traffic tickets. Officers also coordinated additional DWI patrols on weekends during the year to curb drinking and driving. During those details APD officers issued 93 traffic tickets and made 7 DWI arrests. The additional patrols are part of a program funded by the Cayuga County Stop DWI Committee.

The Finger Lakes Drug Task Force initiated 108 new cases during 2018. Narcotics officers made 23 arrests and filed 75 charges. Officers seized 1392 grams of marihuana, 159 grams of cocaine, 2 grams of heroin, 150 doses of controlled prescription medication and 2 grams of "Molly" during confidential drug investigations throughout 2018. Narcotics officers also executed 8 search warrants and seized 5 firearms.

The City Jail temporarily housed 29 persons awaiting arraignment in Auburn City Court on various charges throughout 2018.

During the year of 2018 the Auburn Police Department hired four new police officers. The department also lost three officers to retirement and three officers resigned. At the end of 2018 the department employed 64 sworn police personnel including the Chief of Police and the Deputy Chief.
