

AGREEMENT RESOLUTION #60 OF 2022

**AUTHORIZING AN AGREEMENT WITH THE
AUBURN YMCA-WEIU FOR THE OPERATION OF THE CASEY PARK POOL**

WHEREAS, since 2009 the City of Auburn (the “City”) and the Auburn YMCA-WEIU (the “YMCA”), have worked together to provide services at the Casey Park Pool during the summer seasons;

WHEREAS, this year the City of Auburn and the YMCA would like to enter in a new proposed agreement for the 2022 summer season, pursuant to the terms of the Agreement, which is attached and incorporated herein;

WHEREAS, under the Agreement, the YMCA will provide services, staffing and programming for the operation of the pool for the cost of \$53,500, and the City will continue to supply pool chemicals and maintain the pool and premises; and

WHEREAS, the term of the operation of the Casey Park Pool will run for eight (8) weeks beginning on Wednesday, July 6, 2022, and run through Sunday, August 28, 2021.

NOW, THEREFORE, BE IT RESOLVED that the Auburn City Council does hereby approve the attached Agreement between the City and the Auburn YMCA-WEIU and shall pay for the services provided the sum of \$53,500 for the term of this agreement; and

BE IT FURTHER RESOLVED that the Mayor is hereby authorized to sign any and all documents necessary to finalize the contract.

2022 Casey Park Summer Program Management Proposal

04/11/22

Proposal:

This proposal has been generated to continue the collaboration between the City of Auburn and the Auburn YMCA-WEIU. The purpose of the collaboration is to provide management, staffing, and community services for the Casey Park pool.

The strategy for providing services at the pool will be to carry forward the types and levels of programs used successfully for the previous summers, adhering to YMCA program standards and methods for guarding, swim instruction and coaching.

We believe that continuing to partner with the City to provide services at Casey Park will result in tangible benefits to the citizens of Auburn in the level and quality of recreational experiences available for the summer.

1. Pool management and staffing included in this proposal are:
 - Pool Managers – up to **900** hours in total
 - Lifeguards – up to 3500 hours
 - Lifeguard Apparel - Swimsuits to identify staff
2. Programs included in this proposal are:
 - Community Swim
 - Swim Lessons
 - Aquatic Fitness
 - Lifeguarding for
 - Group swim
 - Public swim
 - Adult & team swim
3. The pool schedule will change again this summer, hoping to return to pre-pandemic regulations. This will include morning swim instruction, late morning group swims, afternoon open swims and Aqua Fitness Classes. The pool will be used for Community Swim from the hours of 12-6pm Monday – Sunday. The swimmer capacity will be 200 and is subject to change based on the progression of the pandemic.
4. Swim lessons will consist of YMCA levels and techniques. Progress reports will be provided at the end of each session. Sessions will be 8 lessons in length, offered in two week or four week formats.
5. Group, public, and adult swims will be guarded according to YMCA Aquatics, and/or Health Department rules – whichever is the highest standard of care.

6. Outside of the community programming, the YMCA would like to include the use of the Casey Park pool for swim lessons, swim teams and fitness classes pending guidelines during the COVID-19 Pandemic. This would be outside of contracted hours and be staffed by YMCA lifeguards.
7. The proposal includes the non-monetary agreement that YMCA members may use the Casey Park pool at no charge, and that the YMCA-WEIU may host birthday parties and other special events at the pool.
8. Not included in this proposal is the maintenance and upkeep of the pool and park.
9. The City of Auburn and the YMCA-WEIU will name each other as "Additional Insured" on their respective liability insurance coverage.
10. Proposing that normal operation and opening of the park would be on Wednesday, July 6th and run through Sunday, August 28th which would be 8 weeks of the summer.

The proposed price for pool management, staffing and programming is \$53,500.

Proposal / Program Cost: \$ 53,500

The YMCA WEIU has a proud history of serving the Auburn community for 150+ years. The YMCA runs programs of all types, including Health and Wellness programs, camping, youth sports and swimming.

Partnering with the City of Auburn in the programming of Casey Park will allow the YMCA to extend its missions of youth development, healthy living, and social responsibility, and to instill YMCA community values of caring, honesty, respect, and responsibility.
