- **NOW, THEREFORE, BE IT RESOLVED** that the Auburn City Council does hereby award Change Order #1, in the amount of \$27,182.50 to Concrete Slipform Inc. for additional work to be done within the 2022 CDBG Sidewalk Program; and
- **BE IT FURTHER RESOLVED** that the cost of the Resolution in the amount of \$27,182.50 is to be charged to the Community Development Account # CD 8672-2210-2022; and
- **BE IT FURTHER RESOLVED** that this award is contingent upon the City of Auburn receiving an executed CDBG contract from the US Department of Housing and Urban Development; and
- **BE IT FURTHER RESOLVED** that the Mayor is authorized to sign any and all documents necessary in reference to the award of this bid.
