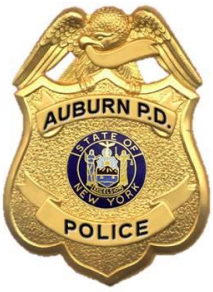

On April 21st, 2021 at about 2:55 pm, members of the Finger Lakes Drug Task Force with assistance from the City of Auburn Police Department executed a search warrant at 5 Cross Street in the City of Auburn at the conclusion of an investigation into the illegal sale of cocaine.

During the search warrant, investigators recovered over 1/8 oz of cocaine (criminal possession of controlled substance 3rd), inositol powder (criminally using drug paraphernalia 2nd), 2 digital scales (criminally using drug paraphernalia 2nd) and numerous assorted baggies, microbags, and packaging material (criminally using drug paraphernalia 2nd), as well as more than \$4,500 dollars in U.S. currency.

Arrested as part of the investigation and search warrant, was Harry W. Hurst III who was processed and held pending his arraignment at the Centralized Arraignment Part court.
